This is to inform you of a Tourism Sub-Committee that has been set up to deal with fishing legislation. The Wisconsin State Fishing Legislation Sub-Committee will be chaired by Representative Thompson, with Representative Boyle, Representative Volk, Representative Linton, Representative Zeuske, Representative Musser and Representative Gard serving as committee members. Their assignment is to look at the laws currently in the Wisconsin State Statutes and pending legislation that deal with fishing in order to examine licensure and determine equity and program relationship. I also expect widespread citizen input so that a consensus can be obtained prior to budgetary deliberations.

I will keep you up to date on the progress of this sub-committee.
