Public Policy Involved

Assembly Bill 850, constituting the 1988 Annual Budget Bill, contains in SEC. 78, a decrease of \$500,000 in the authorized borrowing level for DNR land acquisition, from \$36,403,600 to \$35,903,600. If that Bill is enacted and this Bill is also to be enacted, it may be appropriate to reconcile the two provisions by providing that the amount of public debt under this Bill is increased by \$2,000,000 rather than \$2,500,000.

The provisions of Senate Bill 563 are desirable as matter of public policy.
