Bills may be introduced and printed in advance of this date to permit review by Joint Standing, Standing, and Joint Survey Committees during the regularly scheduled interim committee work period.

The senate remained standing and Senator Ellis led the senate in the pledge of allegiance to the flag of the United States of America.
