REPORT OF JOINT SURVEY COMMITTEE ON DEBT MANAGEMENT

Appendix to **Senate Bill 32**

CORRECTION

Public Policy Involved

The borrowing-related provisions of **Senate Bill 32** are desirable as a matter of public policy.

The policies of the Joint Survey Committee on Debt Management provide, in part, that state bond issuance should be limited to meet certain tests, including the following:

1. That the projected debt service to be paid from general purpose revenues of the state on outstanding bonds and bonds to be issued during the biennium for previously authorized programs and new authorized projects shall not exceed 4.5% of budgeted general purpose revenues for the next biennium.

2. That the projected debt service to be paid from all revenues of the state on outstanding bonds and bonds to be issued during the biennium for previously authorized programs and new projects shall not exceed 3% of budgeted total revenues for the next biennium.

The amount of debt service provided in **Senate Bills 31, 32 and 33** for the 1989-91 biennium exceeds these recommended limits.
