To the Honorable the Legislature:

Pursuant to s. 710.02(4)(b), Stats., as amended by 1989 Wisconsin Act 31, I am pleased to submit to the Senate the attached report entitled "Status of Alien Land Ownership in the State of Wisconsin, January 1, 1989."

Under s. 710.02(4)(b), Stats., DATCP must annually submit this report to the chief clerk of each house of the legislature for distribution to the appropriate standing committees under s. 13.172(3). The report summarizes information received under s. 710.02(4)(a), Stats.

Under s. 710.02(4)(a), Stats., all foreign persons (including individuals, corporations, companies, firms, partnerships, trusts, and any other legal entity) who acquire or transfer land in Wisconsin must submit a report to DATCP not later than 90 days after the date of acquisition or transfer. The same report must also be filed under federal law, under 7 USC 3501 to 3508. Aliens initially file the ASCE-153 forms with their county

ASC'S office. The reports are then forwarded to Washington, DC, to be verified and recorded before they are filed with DATCP.

The attached report summarizes ownership of Wisconsin land as of January 1, 1989, and purchases during the 1988 calendar year.

To the Honorable, the Senate:

I am vetoing **Senate Bill 170** in its entirety. The bill would set the undesirable precedent of prohibiting the Department of Transportation from ordering the removal of a non-conforming private business sign placed in the U.S. Highway 141 right-of-way. The legislation would allow a condition to continue which is in direct conflict with federal highway administration rules. Failure to abide by those rules can result in the loss of a portion of the state's federal highway aid.

In addition, the particular sign at issue is considered to be a traffic hazard by highway engineers. For both

reasons, the Department of Transportation should not be prevented from requiring the removal of the sign.

Unfortunately, the placement of the sign may have been the result of a series of misunderstandings. While I am very much sympathetic to the business owner who erected the sign, the safety concerns at this location and the potential for federal sanctions outweigh individual concerns.

I am directing the Department of Transportation to fully cooperate with the owner in relocating the sign to an appropriate location.
