To the Honorable the Legislature:

We have completed an evaluation of minority staff and student recruitment and retention practices at Milwaukee Area Technical College (MATC) as required by 1989 Wisconsin Act 31.

The problems of underrepresentation of minorities in employment and in student enrollment and retention at MATC are reflective of problems confronting post-secondary educational institutions nationally. There is a scarcity of qualified minority faculty members in the labor force and minority students often enter MATC with insufficient basic skills to enroll and succeed in technical programs.

In our review of MATC efforts, we found that the District has made progress in employment and student enrollment for minorities and females since our last audit in 1986. Minority and female employment has increased, as has minority enrollment, both in total and in academic programs with the highest career potential.

Ongoing efforts, however, are still necessary to address continued imbalance in female and especially minority representation. The highest concentrations of female and minority representation remain in lower level jobs and in academic programs with the lowest career potential. Employment of minority faculty, especially black faculty, remains concentrated in non-degree programs, such as general education and adult high school.

We also found in our discussions with students, faculty and staff that there are continuing perceptions of discrimination and inequality within the District. These perceptions appear to be at least partially caused by insufficient communication between some minority members and district administration.

Our report includes recommendations to help the District improve its recruitment and retention efforts. In addition, we include suggestions which have been discussed to help the District combat perceptions of inequality.

We appreciate the courtesy and cooperation extended to us by the Board, staff and students of MATC. The District's response to the evaluation is the Appendix.
