### *A Proclamation*

I, Tommy G. Thompson, Governor of the State of Wisconsin, pursuant to Article IV, Section 11 and Article V, section 4 of the Constitution of Wisconsin, do require the convening of a special session of the Legislature at the Capitol in Madison, beginning on Tuesday, May 15, 1990 at 10:00 A.M. solely to consider legislation in the following subject areas:

1. Legislation relating to ratification of certain state employees contracts.

In testimony whereof, I have set my hand and caused the Great Seal of the State of Wisconsin to be affixed. Done at the Capitol in the City of Madison this fourteenth day of May in the year one thousand nine hundred and ninety.
