To the Honorable the Legislature:

Pursuant to 1989 Wisconsin Act 353, the Department of Agriculture, Trade and Consumer Protection is pleased to submit the accompanying study entitled, "Regulation of Supplemental Bovine Somatotropin in Wisconsin: An Evaluation of Dairy Product Labeling".

Under this statutory directive, the Department was required to study the advantages and disadvantages of a labeling system for milk and dairy products from non-BST treated herds, including the advisability of adopting a certification system of milk producers as a method of compliance with labeling standards.

The Department study evaluated three alternative approaches to rBST labeling -- (1) labeling under current regulations which protect against misbranding and fraudulent misrepresentation, (2) regulation of voluntary claims that rBST was not used and certification of producers and processors who make voluntary claims,

and (3) mandatory labeling of rBST and non-rBST products. These alternatives were analyzed comparing the reliability of consumer information, potential impacts of labeling on the dairy industry, and labeling enforceability.

The Department was also directed to report its conclusions and recommendations, if any, to the chief clerk of each house of the Legislature for distribution to appropriate standing committees as provided under s. 13.172(3), Stats.

The study concluded that labeling regulations for rBST should be approached with caution, and that any labeling scenario could place significant operational, administrative and marketing burdens and financial impacts on the dairy industry. While new labeling regulations could be warranted to provide consumers information about the use of rBST if high levels of consumer concern persist, the study concludes that proposals for mandatory labeling should only be considered at the federal level.

The recycling law, 1989 Wisconsin Act 335 s. 85 (2p), directs the Department to prepare a plan and proposed legislation to award supplemental grants to recycling programs for the cost of transporting recyclable material to purchasers.

The enclosed plan and draft legislation represent the Department's findings on this issue. The Department concluded that a short-term program, incorporated as part of the basic recycling grant application, would address concerns about high transportation costs and allow the Department to collect and analyze program cost information.
