To the Honorable, the Legislature:

This report presents statements of fund condition (budgetary basis) of the State of Wisconsin for the fiscal year ended June 30, 1991. This satisfies the requirements of Sec. 16.40(3), Wisconsin Statutes. Displayed are major sources of revenues and major categories of expenditures for the General Fund and other funds compared to the prior year.

The General Fund has an unreserved, undesignated balance of \$113.6 million as of the end of the fiscal year. This is \$15 million higher than the \$98.5 million estimate that was projected in the last fund condition statement compiled at the close of the 1989-91 legislative session.

GPR tax revenues were \$6.073 billion compared to \$5.649 billion in the prior year, an increase of \$424 million or 7.5 percent. GPR expenditures were \$6.366 billion compared to \$5.803 billion in the prior year, an increase of \$561.5 million or 9.7 percent. This increase is primarily attributable to increased school and local assistance.

GPR spending increases in fiscal year 1991 were largely driven by increases in five areas. School aids increased by \$224.1 million, medical assistance increased by \$71.3 million, the University of Wisconsin System spending increased by \$42.6 million, corrections spending increased by \$30 million, and shared revenues increased by \$27.2 million. These increases accounted for over 67.4 percent of the total increase in GPR spending.

In fiscal year 1991, the State of Wisconsin continued to devote the major share of state tax collection to assistance to local school districts, municipalities and counties. Local assistance accounted for 56.7 percent of total GPR spending. Aid payments to individuals and organizations represented 19.5 percent of total GPR expenditures. The University of Wisconsin accounted for 11.5 percent of total GPR spending and state operations spending for all other state agencies accounted for 12.3 percent of the total.

The State of Wisconsin expects to publish its comprehensive annual financial report in March of 1992. The report will be prepared under generally accepted accounting principles.
