When the Managed Forest Law (MFL) was enacted in 1985, a review to determine if the objectives of the program were being met was required. The MFL is an important property tax incentive program to encourage forest stewardship on privately owned woodlands. The law specified that a joint committee from the Department of Natural Resources and UW-Extension conduct the study. Under s 77.91(3), Stats., their findings and recommendations are due to you by January 1, 1992. The report titled "Wisconsin's Managed Forest Law - The First Five Years: 1986-1991" is enclosed.

The recently completed report:

- \* Reviews the purposes of the Managed Forest I aw
- \* Examines participation in the program.
- \* Reviews the impact of the program on land resources management.
- \* Looks at the economic impact of the program on taxpayers and administrative costs.
- \* Offers sixteen recommendations for improvements or technical corrections to the law and for further studies.

After five years of experience with the Managed Forest Law, the Department of Natural Resources and UW-Extension find the program to be sound and effective. The MFL program is a useful tool for promoting the stewardship ethic needed to produce economic goods in a manner responsible to social needs and the environment.

500 copies of a draft of the report were shared with the public in September. Comments on the draft have been incorporated in the report to the extent possible. The Assembly and Senate are encouraged to seek additional public input if legislation to adopt the recommendations is developed.

To the Honorable, the Legislature:

This report is transmitted as required by ss. 20.002(11)(f) of the Wisconsin Statutes, (for distribution to the appropriate standing committees under section 13.172(3) stats.), and confirms that the Department of Administration has found it necessary to exercise the "temporary reallocation of balances" authority provided by this section in order to meet payment responsibilities and cover resulting negative balances during the month of November, 1991.

On November 21, 1991; the Variable Retirement Fund (Fund 51) balance was \$-523 thousand. This shortfall continued until December 2nd when the Variable Retirement Fund balance reached \$2.3 million. The shortfall was due to an accounting allocation error, which has been corrected.

The Variable Retirement Fund shortfall was <u>not</u> in excess of the \$400 million ceiling and <u>did not</u> exceed the balances of the funds available for interfund borrowing.

The distribution of interest earning to investment pool participants is based on the average daily balance in the pool and each fund's share. Therefore, the monthly calculation by State Finance will automatically reflect the use of these temporary reallocations of balance authority.

Section 46.56 of the Wisconsin Statutes (1989 Act 31) instructed the Department of Health and Social Services to establish county pilot programs that would provide integrated services for children with severe disabilities, and to evaluate the outcomes of participating children and their families. Grants were awarded to Kenosha, Marathon, Milwaukee and Waukesha counties in April, 1990.

The attached evaluation report, due January 1, 1992, describes client outcomes, the services provided through the pilots, client satisfaction, and the cost of services. The report also provides information about interagency agreements, goals for diverting children from institutional services, and plans for allocating funding from institutional services to community-based services, as directed in s.46.56. A summary of the findings is presented at the beginning of the report.
