STATE OF THE STATE LEGISLATIVE ADDRESS BY ASSEMBLY SPEAKER KUNICKI

"Thank you Governor Thompson ... Lt. Governor McCallum, Attorney General Doyle, cabinet members, members of the Senate and Assembly, and distinguished guests...

It is an honor to address this body on behalf of Senate and Assembly leadership.

I would like to welcome the citizens of Wisconsin to the Assembly Chamber ... the "people's house of government".

We are pleased to have the public join us tonight on television and radio.

Before I begin ... I should tell you that I knew I shouldn't have left a copy of my remarks up here while the Governor was speaking.

Apparently Tommy Thompson has taken it upon himself to veto my entire speech.

Governor, I thought you used up all your red ink vetoing the budget.

It's lucky I've got another copy. This is one override that's going to stick.

Tonight, Governor Thompson has offered his view of the state of the state. It is positive and upbeat - and rightly so.

As we take stock of 1991 and look ahead ... we find ourselves blessed to live in a state where many prosper.

Where government is efficient ... where business and industry can thrive ... where the environment is prized and protected.

Wisconsin's quality of life is the envy of other states.

Yes, we scrap and tussle here in the Legislature - and call it debate.

One commentator noted we've had only one argument here in the Legislature since statehood. Unfortunately it's lasted 144 years.

As members of representative government we seek answers in debate and consensus.

To coin a phrase: if you build consensus the answers will come.

And it shows in the array of issues ratified in one or both Houses of this Legislature last year.

Issues such as:

Health insurance for workers at small businesses ... a recycling bill that sets the standard for a decade of environmental protection ... intensive sanctions to ease prison overcrowding ... penalties for drive-by-shootings

... a ban on use of BGH by Wisconsin dairy farmers ... and, a lottery-financed tax credit written here in the Legislature.

Tonight we begin to write another chapter in our state's history.

The Senate and Assembly members here are your neighbors ... they come from all walks of life ... plumbers ... clergy ... teachers ... doctors ... bricklayers and farmers.

They are mothers and fathers ... sons and daughters ... who represent great and growing Wisconsin communities stretching from Superior to Kenosha.

When they return home from Madison ... they don't travel with security escorts to a mansion. They live in your neighborhoods. These are your Representatives.

Tonight, as your neighbors gather here at the State Capitol ... they bring with them warm memories of the holidays, and the good temper that comes with a mild winter.

But underlying that good mood is a sense of unease.

They have heard concerns about their constituents' job security ... thread-bare health care coverage ... troubled families ... failing schools ... and rampant crime.

There are worries that Wisconsin is an island of security ... awash in a world of uncertainty.

Worries that those troubled waters threaten to wash away our livelihoods and well being.

While we tout the number of housing sales ... let us keep in mind the number of young couples unable to attain the American Dream.

Your neighbors know the stories.

Sons and daughters forced to move back to their parents' homes.

And young couples making ends meet ... living checkto-check.

While we glory in the state's economic stability let us remember that bankruptcies hit an all-time high in Wisconsin last year.

Let us remember too that welfare cases have reversed their downward trend and have climbed in recent months.

As House Speaker Tom Foley said last night in his response to the President ... "when the economy is wrong ... nothing else is right."

We see jobs out there ... but jobs that pay less than a living wage. In many cases "the boss" has health care coverage - but the workers don't.

My friends ... we are in danger of becoming a "golden arches" economy ... a "McJobs" society.

Names of troubled businesses toll like a warning bell in local communities across the state ... names like "Uni-Royal" in Eau Claire ... the Capitol Court "Sears" store in Milwaukee ... and "J.I. Case" near Wausau.

Tonight, we have heard proposals from Governor Thompson.

Many of his aspirations for Wisconsin are shared in one form or another by lawmakers who have assembled here.

At times, we may differ on the means to the end. Those differences in opinion should not dismay us ... they should not hold us back.

We have important work to do ... too important for petty bickering to stand in the way.

As someone once said ... the only people who never change their opinions are the foolish and dead.

We must come together.

It's a full slate that waits on our desks. As of tonight we have 41 working days to resolve many complex and divisive issues.

While news stories focus on controversy, we legislators will move forward on critical issues with this Governor.

Let me touch on a few of these issues.

ON HEALTH CARE

Tonight as we speak ... more than half a million residents in Wisconsin ... working men and women ... face personal and economic calamity if they become ill.

Some personal tragedies have occurred while we debate...

72-year old Margaret Scott of Madison testified at a recent legislative hearing that she could not afford radiation therapy to treat her pancreas cancer.

Margaret testified that she would have had to pay 65 percent of the treatment - and simply couldn't afford it.

Margaret delivered her testimony October 25.

She died 4 weeks before Christmas.

Ladies and gentlemen: we will pass a cost containment measure to make health care affordable for Wisconsin's residents.

ON EDUCATION

We commend Governor Thompson and the groups he has negotiated with. They have cobbled together elements of reform to put our schools back on their feet.

I expect parents would like to have been included. They weren't.

The same goes for property taxpayers. Because it's high property taxes that have the quality of education up against the wall.

Let's not mistake the heat of action for the light of progress. The legislature - your neighbors - are working with parents and taxpayers. They won't be lost in the rush to reform.

ON THE BUDGET

The Legislature is committed to handling Wisconsin's spending plan in a responsible and fiscally sound manner.

Due to our continuing efforts at reform, the legislature's budget-writing has been the most open in the history of state government.

This year ... in consultation with Senator Helbach and our budget leaders we have established even higher standards of accountability.

ON PROPERTY TAX RELIEF

After considerable debate last year, the Legislature authored a plan that would have sheltered the first \$30,000 of value on a person's home from school taxes.

That figure was vetoed. Governor Thompson slashed the number to \$8,200 ... a more than two-thirds reduction.

Tonight, we issue a challenge: put away your veto pen Governor ... work with us to achieve an even higher amount of tax relief.

You can do that here and now - today - not in some distant future ... in a future dependent on some new form of gambling.

Governor Thompson thinks he has an "ace up his sleeve" by offering increased tax relief through legalized video poker.

We think he's dealing from the bottom of the deck with Wisconsin taxpayers.

Since 1973, residential property taxes have gone up 355-percent. In contrast, corporate property taxes have risen by less than 20-percent.

The rich and well-to-do have feasted on tax breaks at the expense of the working middle class.

Enough's enough.

ON WELFARE

Governor Thompson has provided some short-term stopgap proposals.

But let's face it ... the system is broken, in Milwaukee County officials use the word "crisis" to describe their situation.

In this session of the Legislature ... a new initiative will be formed that incorporates the best ideas of welfare:



Help for the truly needy and restoration of the work ethic.

But let's make it clear. Long welfare lines and unemployment lines have a lot in common - you don't see one without the other.

The top three priorities in fixing any welfare program can be listed as: ... jobs ... jobs ... and jobs that pay living wages.

We stand ready to move the state forward with an eye to the future and forward thinking.
