To the Honorable, the Assembly:

I am pleased to transmit my 1993 Overcharge Plan for consideration by the Joint Committee on Finance at the next s.13.10 meeting. As required by Wisconsin Statute 14.065, I am also forwarding copies to the Co-Chairs of the Joint Committee on Finance for their consideration at their next s.13.10 meeting.

This plan allocate \$3,379,416 plus interest of Stripper XII oil overcharge monies received from the U.S. Department of Energy. Of this available amount,

\$3,111,670 of new monies and a reallocation of \$267,757 of previously committed funds are included.

Oil Overcharge monies must be used on energy programs that provide restitution to Wisconsin citizens. In addition to Joint Finance's action, the U.S. Department of Energy and the Federal Courts must also conduct a review to determine if Wisconsin's Plan conforms with established definitions of restitution.

1983 Wisconsin Act 27, created s. 46.277(5m) of the statutes which required the Department of Health and Social Services to submit an annual report on its federal Medicaid Home and Community-Based Services waiver, the Community Integration Program II (CIP II). The attached report covers calendar year 1991 for the CIP II and COP-W (Community Options Program Waiver).

These waivers are designed to relocate or divert elderly and physically disabled persons from nursing homes and finance their care with Medicaid. The level of Medicaid waiver funding must be no greater than the Medicaid cost for nursing home care. The annual report examines both cost and quality of care in the waiver programs.

To the Honorable the Assembly:

By enacting 1989 Wisconsin Act 122, the State of Wisconsin made a pivotal commitment to the fight against drug abuse. Act 122 expanded state and local law enforcement agencies' anti-drug efforts, and it created innovative neighborhood programs to combat drug crime.

Act 122 also directed the Department of Justice to study the effectiveness of some of the drug enforcement projects funded by the Act. Accordingly, I am pleased to present the Department's reports on:

- 1) State drug enforcement personnel and programs;
- 2) Grants to local law enforcement agencies for drug detectives;
- 3) Local task forces, formerly called multi-jurisdictional enforcement groups; and
- 4) The City of Milwaukee's drug abatement project.

The Act also specified a study of the toll-free drug hotline. Please note that the first report listed above covers this project along with other Department of Justice programs supported by Act 122.

I hope these reports will aid you in strengthening Wisconsin's drug enforcement efforts. I would be happy to assist you in any way I can.

To the Honorable the Legislature:

Pursuant to 1989 Wisconsin Act 186, s. 36.12(3)(a)(b), Wisconsin Statutes (effective April 10, 1990), the Board is required to submit a report to the chief clerk of each house of the legislature on the number of complaints

received from students alleging discrimination at each technical college and the disposition of each such complaint. Also to be reported are the numbers of requests for review received by the Board and the disposition of each such request.

The enclosed report shows the total number of complaints received by each institution broken down by numbers and types of alleged discrimination followed by the disposition of each complaint.

A total of 88 complaints were received during the academic year (1991-92). Of that number 64 have been resolved or were dropped by the student filing the complaint; in 10 there was no discrimination found; and 14 are pending.

The Wisconsin Board of Vocational, Technical and Adult Education has not received any requests for review.

Wisconsin Statutes

Pursuant to action taken by the University of Wisconsin System Board of Regents during its regular meeting on November 6, 1992, I am transmitting the Report on Solid Waste Experiment Centers, required under s. 36.25(3m)(e) of the *Wisconsin Statutes*.

1989 Wisconsin Act 31 created section 36.25(3m)(b) of the statutes which provide that:

"The board may establish one or more solid waste experiment centers for the purpose of developing, demonstrating, promoting and assessing the costs and environmental effects of alternatives to solid

waste disposal. The board shall determine the location of the solid waste experiment centers. In making the determination, the board shall consider the solid waste disposal needs of the various regions of the state. The board may establish, through cooperative agreements, solid waste experiment centers at existing publicly owned or privately owned storage, treatment or disposal facilities."

Section 35.25(3m)(e) provides that:

"Annually, the board shall submit a report to the chief clerk of each house of the legislature for distribution to the appropriate standing committees under s. 13.172(3) on all activities undertaken under this subsection."

This is the third annual report submitted to meet the statutory requirements. the College of Natural Resources at UW-Stevens Point, which was designated as a Solid Waste Experiment Center in June 1990, is in the process of completing a three-year study entitled "Landspreading of Compost on Agricultural Lands," which has been funded with a total of \$254,500. Beginning in fiscal year 1990-91 the recycling law, 1989 Wisconsin Act 335, provided additional research funding and directed the Board of Regents to appoint a Solid Waste Research Council to advise the System concerning the awarding of funds for research projects under 36.15(3m)(c). In response to the requests for proposals issued to disburse \$244,800 of 1992-93 funding, the Council received 30 research proposals from six campuses. The Council reviewed the proposals and sought comments and advice from reviewers not affiliated with the System. I granted approval to fund eleven proposals recommended by the Council. These proposals are summarized in the report.
