To the Honorable the Legislature:

We have completed an evaluation of the General Educational Development (GED) program, which is administered by the Department of Public Instruction. This program provides diplomas to individuals who did not complete traditional high school programs.

Between 1986 and 1989, the number of GED diplomas awarded in Wisconsin declined 66.8 percent. Nationwide, diplomas awarded declined 17 percent. Among Midwestern states, Wisconsin ranked last in the number of diplomas issued during this period. In addition, the number of GED program participants declined 49 percent, while nationally, the number of participants declined 9 percent.

The decline in diplomas and participants appears to be largely the result of changes in the examination score required in Wisconsin to achieve the GED diploma. The Superintendent of Public Instruction raised the score and added program requirements in 1988, citing three goals: reducing the number of high school dropouts, increasing the credibility of the GED diploma with employers, and making the requirements more equivalent to high school standards. Wisconsin's score requirements are now higher than those of all other states.

Staff at district Vocational, Technical and Adult Education campuses and community-based organizations, who assist in administering the program, believe the GED score requirement is too high. Some have suggested the passing score be lowered to ensure more individuals earn the GED diploma.

In addition, some believe the manner in which new program requirements are implemented discourages participants from completing the program. We have, therefore, included recommendations to improve implementation of program requirements to address this concern.

We appreciate the courtesy and cooperation extended to us by the staff at the Department of Public Instruction, the Vocational, Technical and Adult Education system, and community-based organizations. A response from the Department is the appendix.

To the Honorable the Legislature:

We have completed an evaluation of selected state facility construction and maintenance issues. Expenditures by the State Building Commission on facility maintenance projects increased 87 percent during the 1980s. Increasing maintenance needs due to the aging of state facilities is the primary reason for rising costs, and further increases appear likely during the 1990s. Our review indicates, however, that higher costs may also be due to deficiencies in the State's preventive maintenance and construction oversight programs.

Most state agencies do not have adequate preventive maintenance programs because of limited staff and inadequate management. State agencies generally place a low priority on funding preventive maintenance and, in several instances, have shifted maintenance staff to other programs. In addition, construction supervision services provided by the Department of Administration (DOA) are not adequate because staff spend too little time supervising and monitoring contractors.

DOA recently initiated a number of actions to improve construction oversight. We have identified other needed improvements to this program and also suggest ways for better managing preventive maintenance programs. It is doubtful, however, whether agencies can fully improve their preventive maintenance programs without more staff. Limited resources diminish the likelihood that agencies will receive additional state revenues in the 1991-93 biennium for expanding preventive maintenance. However, we note several options the Legislature or the Building Commission could consider, including requiring internal staff reallocations, to increase the extent of preventive maintenance.

We appreciate the courtesy and cooperation extended to us by staff from DOA, the University of Wisconsin, and several other state agencies we contacted. Responses from DOA and the University are attached as appendices.

To the Honorable the Legislature:

Section 3023(3fc) of 1989 Wisconsin Act 31 directs the Department to submit, by January 1, 1991, to the chief clerk of each house of the Legislature, a plan of implementation for a system which would assess Medicaid residents of nursing homes according to their functional levels, health conditions and service needs. The Department was also directed to identify further

study needed in order to use the system to determine the quality of care provided by facilities and the Medicaid reimbursement of facilities. For a number of reasons, which are explained below, the Department will be unable to meet the January 1, 1991 date for completion of the plan.

Delay in completing the plan is mainly related to federal requirements contained in the Omnibus Budget Reconciliation Act of 1987 (OBRA 87) regarding collection of nursing home resident data referred to as the minimum data set. This minimum data set is the same information needed to develop the plan mandated in act 31. Until a meeting last fall with the nursing home industry, the Department and federal Health Care Financing Administration officials, many issues were unresolved regarding the federal requirements. It did not make sense to begin working on the Act 31 plan until these issues were resolved. In addition, with Department staff involved in developing the resident-based data to meet the federal requirements, and nursing home industry personnel involved in other OBRA and nursing home reimbursement issues, it was difficult to get a timely start on the Act 31 plan.

The Department has appointed an advisory committee to help develop the plan. The committee has met twice to develop a draft plan and a final meeting has been scheduled for January 29th. The committee's recommendations will be subsequently reviewed by the Department and a final plan completed. I expect to submit the plan to the Legislature by the end of February.
