To the Honorable the Legislature:

The Legislative Audit Bureau was directed by 1989 Wisconsin Act 31 to contract for the performance of an actuarial audit of the Wisconsin Retirement System (WRS) at least once every five years, with the first actuarial audit to be contracted for by June 30, 1990. An actuarial audit requires a high level of actuarial expertise in a highly technical area, which the Audit Bureau does not have with its own staff.

After a formal request for proposal process, the Audit Bureau awarded a contract to the actuarial firm, Milliman and Robertson, Inc. to perform the audit. Milliman and Robertson had previous experience performing audits and other actuarial services for other large public retirement systems. The scope of audit services provided for in the contract included two

components: 1) an independent verification and analysis of actuarial valuations of WRS; and 2) an evaluation of the statutory provisions and features of the system.

The first required actuarial audit has been completed. Attached is the actuary's audit report, much of which is quite technical, and a response from the Department of Employee Trust Funds and its consulting actuary, Gabriel, Roeder, Smith and Company (GRS). The findings, conclusions, and recommendations in the report are those of Milliman and Robertson, Inc. No Audit Bureau staff were involved in the fieldwork, analysis, or writing of the audit report.

In its report, Milliman and Robertson concluded that all major actuarial functions are being adequately addressed and that GRS uses generally acceptable actuarial techniques in its work for WRS. Suggestions for improvement, which the actuaries characterized as fine-tuning, are included in the report.

In addition to assessing the adequacy of the consulting actuary's work, Milliman and Robertson reviewed WRS's financial objectives and made some general observations about the statutory provisions. Milliman and Robertson concluded that the financial objectives of the system are being met and that the funding status of WRS appears to compare favorably to that of other public retirement systems.

Milliman and Robertson also concluded that the statutory provision of WRS provide an attractive, well-balanced package of benefits, although they indicate the provisions are not overly generous by public plan standards. However, Milliman and Robertson raise general concern with the use of the transaction amortization account for purposes other than as a mechanism to smooth the effects of investment gains and losses, such as its use in partially funding the benefit improvements included in 1989 Wisconsin Act 13. They are concerned that regular use of the transaction amortization account in this fashion might lead to its use for other purposes, since the price of any particular action might be disguised in the transfer of funds, and that the transaction amortization account may be needed in subsequent years to absorb the effect of investment losses. The actuaries also note that some features of the pre-retirement death benefits provisions are inconsistent with the operation of WRS in other areas.

The Department of Employee Trust Funds and GRS generally accepted the recommendations included in the report and indicated they will take steps to implement many of the recommendations in the near future, although several recommendations may require additional review by the Department and GRS.

Milliman and Robertson also will discuss the report at a briefing with the Retirement Research Committee, which may wish to further consider the actuaries' comments on WRS's statutory provisions and the need for any legislative action in response to these comments.

We would like to acknowledge the professionalism of Milliman and Robertson's actuaries and the cooperation of the staff of the Department of Employee Trust Funds and GRS in the performance of this audit.

To the Honorable the Legislature:

Pursuant to 1989 Wisconsin Act 353, the Department of Agriculture, Trade and Consumer Protection is pleased to submit the accompanying study entitled, "Regulation of supplemental Bovine Somatotropin in Wisconsin: An Evaluation of Dairy Product Labeling."

Under this statutory directive, the Department was required to study the advantages and disadvantages of a labeling system for milk and dairy products from non-BST treated herds, including the advisability of adopting a certification system of milk producers as a method of compliance with labeling standards.

The Department study evaluated three alternative approaches to rBST labeling -- (1) labeling under current regulations which protect against misbranding and fraudulent misrepresentation, (2) regulation of voluntary claims that rBST was not used and certification of producers and processors who make voluntary claims, and (3) mandatory labeling of rBST and non-rBST products. These alternatives were analyzed comparing the reliability of consumer information, potential impacts of labeling on the dairy industry, and labeling enforceability.

The Department was also directed to report its conclusions and recommendation, if any, to the chief clerk of each house of the Legislature for distribution to appropriate standing committees as provided under s. 13.172(3), Stats.

The study concluded that labeling regulations for rBST should be approached with caution, and that any labeling scenario could place significant operational, administrative and marketing burdens and financial impacts on the dairy industry. While new labeling regulations could be warranted to provide consumers information about the use of rBST if high levels of consumer concern persist, the study concludes that proposals for mandatory labeling should only be considered at the federal level.
