The recycling law, 1989 Wisconsin Act 335 s. 85(2p), directs the Department to prepare a plan and proposed legislation to award supplemental grants to recycling programs for the cost of transporting recyclable material to purchasers.

The enclosed plan and draft legislation represent the Department's findings on this issue. The Department concluded that a short-term program, incorporated as part of the basic recycling grant application, would address concerns about high transportation costs and allow the Department to collect and analyze program cost information. The parameters of the proposed program are outlined in the attached report.
