Attached is the proposed Clean Water Fund Biennial Finance Plan for FY 1991-1993. This plan is an update of a preliminary Biennial Finance Plan submitted to the Building Commission, the Joint Finance Committee and the Chief Clerk of each House of the Legislature in September 1990. Per s. 144.2415(3)(bm)2, Stats., this is the version of the Biennial Finance Plan prepared in response to the Governor's FY 91-93 biennial budget proposal to the Legislature. As state in other portions of s. 144.2415(3)(bm), Stats., this Biennial Finance Plan will be revised once more to incorporate the adopted biennial budget act.

This plan has been prepared jointly by the Department of Natural Resources and the Department of Administration Capital Finance Office. The preparation, submission, and review of the Biennial Finance Plan by the Joint Committee on Finance, environmental legislative standing committees and Building Commission is required under s. 144.2415(3), Stats. The statute allows the Joint Committee on Finance and each standing committee to submit to the Building Commission its recommendations and comments regarding each version of the Biennial Finance Plan.

The Biennial Finance Plan has been prepared to support the administration of the Clean Water Fund which provides financial assistance to municipalities that are required to construct new wastewater treatment facilities to protect the surface waters and groundwaters of Wisconsin.

As required in s. 144.2415(3)(bm), Stats., we will send you the final version of the FY 1991-1993 Biennial Finance Plan after the Governor signs the biennial budget.
