To the Honorable the Legislature:

We have completed an evaluation of tax incremental financing (TIF) in Wisconsin, as requested by the Joint Audit Committee. Tax incremental financing continues to be a popular local financing method for economic development, with 484 active TIF districts through the end of 1990. Property taxes to be collected in 1991 for TIF districts account for \$93.6 million, more than 2 percent of all property taxes collected in the state.

Since our audit in 1981, which identified numerous abuses in the program, the Legislature has enacted several statutory changes which appear to have reduced or eliminated some serious problems. Nevertheless, we found indications that some problems still remain, such as the creation of TIF districts which include property that does not need TIF subsidy.

The statutes have established only local oversight mechanisms for the program; no state oversight is conducted. To improve local oversight, we have included recommendations for the Departments of

Development and Revenue to provide better educational and informational support to local officials charged with program oversight. In addition, we have included options for establishing some state oversight if the Legislature concludes local oversight is insufficient.

We appreciate the courtesy and cooperation extended to us by staff of the Department of Revenue and Development, and by city, village, school districts, and county staff with whom we spoke.
