To the Honorable the Legislature:

We have completed an evaluation of the Department of Development's Main Street program, as required by 1989 Wisconsin Act 31. The Main Street program provides technical assistance to communities interested in revitalizing their downtown areas, but provides no direct financial assistance.

Communities participating in the Main Street program believe they have received significant benefit from the program in organizing their revitalization efforts. In addition, economic information indicates the program may also have assisted the communities by increasing the number of businesses and jobs and encouraging private and public investment in the downtown area.

The budget for the Main Street program has increased significantly since the program was established, from \$37,500 in fiscal year 1987-88 to \$342,300 in fiscal year 1990-91. This increase reflects, primarily, the growth in the number of communities receiving services, from five communities in 1988 to 15 in 1990. Since the program is designed to provide services to communities over a three-year period, the number of communities receiving services is most likely at a plateau. As a result, the program's budget should not continue to increase significantly unless services are expanded or more than five communities are added annually.

We appreciate the courtesy and cooperation extended to us by the Department of Development staff. The Department's response is Appendix II.
