Executive Order Number 141

*Relating to expanding a Special Session of the
Legislature*

I, Tommy G. Thompson, Governor of the State of Wisconsin, by the authority vested in me by the Constitution and the laws of this state, and specifically by Article IV, Section 11 and Article V, Section 4 of the Constitution of Wisconsin, do amend Executive Order #135 (dated 10/14/91), which required the convening of a special session of the Legislature at the Capitol in Madison, beginning on Tuesday, October 15, 1991 at 10:00 a.m. by adding to its business consideration of legislation in the following subject areas:

- 1. Legislation relating to the establishment of statewide educational goals and a state vision for education.*
- 2. Legislation relating to funding for early childhood education programs and making an appropriation.*
- 3. Legislation relating to extending the school year.*
- 4. Legislation relating to staff development programs and making an appropriation.*
- 5. Legislation relating to school management restructuring programs and making an appropriation.*
- 6. Legislation relating to collaboration between school districts and social service agencies and making an appropriation.*
- 7. Legislation relating to the issuance of promissory notes for providing additional classroom space or educational programming by Milwaukee Public Schools.*
- 8. Legislation relating to studying the feasibility of transferring the authority for long-term borrowing for educational purposes from the City of Milwaukee to the Board of School Directors for Milwaukee Public Schools.*
- 9. Legislation relating to the setting of organizational dates by a board of school directors of a school district of a city of the first class.*
- 10. Legislation relating to the creation and use of uniform student transcripts.*
- 11. Legislation relating to grants for science and mathematics education programs and making an appropriation.*
- 12. Legislation relating to modifications of the postsecondary enrollment options program.*
- 13. Legislation relating to school board authority to require community service as part of the high school curriculum.*
- 14. Legislation relating to requiring school districts to pay the fee for taking advanced placement examinations for students who are eligible to participate in the federal free or reduced price lunch program under 42 USC 1758.*
- 15. Legislation relating to school district consolidation incentives.*
- 16. Legislation relating to publicizing and coordinating teacher exchange programs.*
- 17. Legislation relating to permitting law enforcement officers to take truants into custody and creating a truancy abatement and suppression program in the City of Milwaukee.*
- 18. Legislation relating to creating a committee to study the feasibility of establishing a regional public high school of excellence and making an appropriation.*
- 19. Legislation relating to authorizing the State Superintendent of Public Instruction to require the publication of the contents of college entrance examinations administered in Wisconsin.*
- 20. Legislation relating to requiring school boards to adopt policies to encourage full student participation in extracurricular activities in grades kindergarten through grade 8.*
- 21. Legislation relating to requiring school boards and public postsecondary educational institutions to adopt written policies on who may enter and remain in a locker room used by a team, for the purpose of interviewing or seeking information from any person.*
- 22. Legislation relating to increasing the maximum suspension period for students subject to expulsion hearings.*
