This is the report of the Wisconsin Department of Regulation and Licensing made as required by s. 227.485(9), Stats.

During the fiscal year, 1991-1992, the Department of Regulation and Licensing paid one claim made under s. 227.485, Stats., in the amount of \$14,410.20. The claim paid was made by a motion for costs in a contested case before the Barbering and Cosmetology Examining Board which was captioned as "In the matter of Disciplinary Proceedings against Carol Block, LTD d/b/a Carol Block, LTD, Permanent Hair Removal." The Board awarded costs in an order issued on February 3, 1992. The claims involved in the contested case in which the costs were incurred related to enforcement of an "Order to Correct" issued by an inspector and to the scope of practice of the respondent in the case.

No costs were recovered by the Department under s. 227.485(10), Stats.

The University of Wisconsin System Board of Regents adopted the following resolution at its July meeting:

Pursuant to 1989 Wisconsin Act 186, s. 36.12(3)(a)(b), Wisconsin Statutes (effective April 24, 1990), the Board of Regents hereby accepts the attached report and directs that it be submitted to the chief clerk of each house of the legislature for distribution to the appropriate standing committees under s. 13.172(3).

The referenced report is attached. The report details for the previous academic year: 1) the number of complaints received at each institution and center alleging a violation of the above statute, and 2) the number of requests for review of these complaints received by the Board of Regents.

A total of 117 complaints were received by UW System institutions during the 1991-92 academic year. Of the 117 complaints, 95 were resolved, 10 were withdrawn by the 1 was filed with another agency for investigation and resolution, and 8 are still pending. No data are available for UW-Milwaukee. UW-Milwaukee is currently in the process of reorganizing its Affirmative Action Office and up-dating its record keeping procedures and practices based on recommendations in a recent report issued by the Legislative Audit Bureau.

The Board of Regents did not receive any requests for review of the institutions' decisions in these cases.

1989 Wisconsin Act 122 required the Department of Health and Social Services to submit several reports on alcohol and other drug abuse (AODA) programs by July 1, 1992. The following reports are overdue because of delays in the data collection process:

3. Training in perinatal AODA detection and treatment -- non-statutory provision 3023(9n) of 1989 Wisconsin Act 122.
4. AODA treatment for Milwaukee residents -- non-statutory provision 3023(6y) of 1989 Wisconsin Act 122.
5. Capacity building for treatment programs - - Wisconsin statutes section 46.86.
6. Neighborhood drug use and violence prevention -- non-statutory provision 3023(9v) of 1989 Wisconsin Act 122.
7. American Indian drug abuse prevention, treatment, and education -- non-statutory provision 3023(7) of 1989 Wisconsin Act 122.
8. Foster parent AODA supplement -- non-statutory provision 3023(9p) of 1989 Wisconsin Act 122.

The Department plans to submit these reports by August 1, 1992.
