To the Honorable the Legislature:

Pursuant to the requirements of section 153.10(1), Wis. Stats., I am pleased to submit to the Governor and to the Legislature the third annual *Health Care Data Report*. This report is based on hospital inpatient discharge data reported to the Office of Health Care Information by all general medical-surgical and specialty hospitals operating in Wisconsin from January through December 1991. It also contains selected outpatient surgery utilization and charge data from general medical-surgical hospitals and freestanding ambulatory surgery centers in Wisconsin during the same period.

This report fulfills the statutory requirement to report *"in a manner that permits comparisons among hospitals...the charges for up to 100 health care services or diagnostic-related groups selected by the office."*

To the Honorable, the Senate:

I am pleased to transmit my 1993 Overcharge Plan for consideration by the Joint Committee on Finance at the next s. 13.10 meeting. As required by Wisconsin Statute 14.065, I am also forwarding copies to the Co-Chairs of the Joint Committee on Finance for their consideration at their next s. 13.10 meeting.

This plan allocates \$3,379,416 plus interest of Stripper XII oil overcharge monies received from the U.S. Department of Energy. Of this available amount, \$3,111,670 of new monies and a reallocation of \$267,757 of previously committed funds are included.

Oil Overcharge monies must be used on energy programs that provide restitution to Wisconsin citizens. In addition to Joint Finance's action, the U.S. Department of Energy and the Federal Courts must also conduct a review to determine if Wisconsin's Plan conforms with established definitions of restitution.
