To the Honorable the Legislature:

We have completed an audit of the three state agencies that regulate almost 800 state-chartered financial institutions. The Commissioner of Banking, the Commissioner of Savings and Loan, and the Commissioner of Credit Unions are responsible for ensuring the safety and soundness of state-chartered financial institutions and their compliance with state regulations.

Wisconsin has had few institutional failures in comparison to national experience and, as of December 31, 1993, has only four institutions that require close monitoring. However, changes in the financial service industry and potential administrative efficiencies may prompt the Legislature to consider consolidating the three regulators into a combined agency, which is the

structure used by most other states. We present potential advantages and disadvantages of such a consolidation.

The Office of Commissioner of Banking is also responsible for administering the Wisconsin Consumer Act and regulating over 3,900 businesses in various consumer credit industries. Banking's activities are generally helpful in protecting the Wisconsin consumer in credit transactions. However, we suggest steps to improve its efforts, including the use of complaint information to identify trends in company and industry practices. Further, we suggest that Banking reallocate staff resources from regulation of the declining number of banks and increase the number of consumer credit examinations.

We appreciate the courtesy and cooperation extended to us by the staff of the Office of Commissioner of Banking, the Office of the Commissioner of Savings and Loan, and the Office of the Commissioner of Credit Unions. The responses of the three Commissioners are included in Appendices I through III.
