To the Honorable the Legislature:

Section 9159(2) of 1993 Wisconsin Act 16 required a study of the Youth Conservation Corps (YCC) and the Wisconsin Conservation Corps (WCC). This report is the result of that study which we believe meets the intent and spirit of the mandate. Though brief, it covers the pertinent issues.

The specific charge was:

"The secretary of natural resources and the Wisconsin conservation corps board shall jointly report their evaluation of the youth conservation corps, Chippewa youth and operation hard hat programs, including their missions, whether the programs should remain residential programs, and, if so, where the persons in the programs should be housed, and whether funding for these programs could be better targeted to meet the environmental

education goals and youth employment needs of those agencies."

#### PROGRAM BACKGROUND:

The Youth Conservation Camp program was established in 1961 as part of the initial Outdoor Recreation Act Program (ORAP). It was designed to address youth unemployment and high school dropout concerns as well as a backlog of conservation work projects. Over time the target audience has shifted from troubled boys to a diverse mix of Wisconsin high school aged youth. The focus has shifted from just accomplishing work projects to working, learning, and experiencing natural resource careers and outdoor skills in a summer camp setting.

At present, four YCC facilities accommodate a total of 800 girls and boys, age 15 to 18 per summer in four-week sessions. The campers are paid minimum wage for 32 hours per week and a deduction is made for room and board. Staff include teachers and college students with an interest in youth and in the outdoors. Campers and staff live together 24 hours per day in a fairly structured, yet fun environment.
