Dear Mr. Sanders:

On September 29, 1995, Assembly Bill 591, relating to creating a new public assistance program for families with dependent children, modifying the sunset of the aid to families with dependent children program, modifying administration of the food stamp program, modifying the eligibility requirements of certain recipients of medical assistance, creating a program to provide payment to a relative, other than a parent, who is providing care and maintenance for a child, eliminating postsecondary education and vocational skills training from the job opportunities and basic skills program, applying the learnfare provisions statewide to certain individuals who are 6 to 19 years of age, eliminating child care funded under community aids, modifying eligibility requirements for low-income and at-risk child care, creating a tax exemption, making modifications to the job opportunities and basic skills program, making modifications to the food stamp employment and training program, consolidating state general purpose revenue appropriations for public assistance and local aid, providing an exemption from emergency rule procedures, providing an exemption from rule-making procedures, granting rule-making authority and making appropriations, was referred to the Joint Survey Committee on Tax Exemptions. Pursuant to the authority provided by Assembly Rule 42(3)(c), I hereby withdraw Assembly Bill **591** form the Joint Survey Committee on Tax Exemptions and rerefer it to the committee on Welfare Reform.

Representative Robert Zukowski and Senator George Petak, co-chairs of the Joint Survey Committee on Tax Exemptions, have consented to this rereferral.

Keppler said that there are already enough political "plums" in Wisconsin and it would be most inappropriate to allow the Governor ... any governor... to reward political supporters by appointing them to top positions in state government, such as Secretary of the Department of Natural Resources. "I should like to point out" said Keppler, "that I am not saying that every cabinet appointment would be made strictly on the basis of politics. I must add, however, that over the years a great many gubernatorial appointments by both Republican and Democratic Governors have been political. I do not think we can afford to have our major state agencies being headed by political appointees who may at times put politics above what is actually best for the majority of Wisconsin citizens." Granted.
