Total administrative expenditures for FY96 and FY97 were \$482,212,642 and \$431,146,441, respectively. These amounts represent 11.79% of gross lottery revenues for FY96 and 12.63% of gross lottery revenues for FY97. Both years are well within the 15% limitation imposed by Section 25.75(3)(b).
