### EXECUTIVE COMMUNICATIONS

#### *Executive Order Number 331*

#### **Relating to Amending Executive Order No. 329**

I, **TOMMY G. THOMPSON**, Governor of the State of Wisconsin, pursuant to Article IV, Section 11 and [Article V, section 4 of the Wisconsin Constitution](#), do hereby amend Executive Order No. 329 and require the Legislature to consider and act upon the following legislation in addition to the legislation listed in Executive Order No. 329:

4. Legislation relating to excluding agricultural transactions from provisions of the Wisconsin consumer act.
5. Legislation relating to the permit guarantee program of the department of natural resources and requiring the exercise of rule-making authority.
6. Legislation relating to income tax and franchise tax credits for sales taxes paid on fuel and electricity used in manufacturing, the apportionment of income for the corporate income tax and franchise tax and requiring and permitting the promulgation of rules.
7. Legislation relating to food stamps for qualified aliens and making an appropriation.
8. Legislation relating to changing requirements for hospitals, organ procurement organizations, coronors and medical examiners with respect to the potential donation of anatomical gifts and procurement and use of body parts by an organ procurement organization.
