Additional info: Our AB 54 allows optional dealer plates for salvage pools. If LRB 0798 were enacted, it would allow salvage pools as well as any other dealer to put dealer plates on consignment vehicles....but, AB 54 would create a separate treatment of salvage pools so that they could still have optional dealer plates, and we think that would still be a good idea because very often salvage pools get vehicles on consignment that are so damaged they couldn't be driven on a test drive anyway, and it would be useful for salvage pools to not HAVE to obtain dealer plates if they didn't feel they needed them. Also, just a point of clarification—the LRB-0798 memo says that dealers CAN'T let people test ddrive vehicles because they can't use dealer plates on them.this is not exactly true: the precise statement is, that if the old owner has taken THEIR plates off the vehicle and the vehicle has NO plates on it, then it can't be test driven—but as long as the old owner plates are on the vehicle it can be test driven.

We are introducing this legislation on behalf of the Wisconsin Automobile and Truck Dealers Association. Currently, if a Wisconsin citizen desires to sell a vehicle on consignment through a licensed dealer, prospective buyers may not test drive the vehicle in most cases. Dealers are prohibited from using their dealer, demonstrator or transporter plates on consigned vehicles left in their charge because they do not have any ownership rights on the vehicle.

This legislation would allow a licensed dealer to use dealer, demonstrator or transporter plates when appropriate on consigned vehicles, so that prospective purchasers can test drive the vehicle before buying it.

This legislation is needed to assist the stream of commerce, especially in the area of heavy trucks where there is an increasing demand for consignment sales. A new heavy truck can cost well over \$60,000 and it represents a major investment and provides a livelihood for thousands of independent truck drivers. To maximize their investment and business, many heavy truck owners prefer to sell their trucks on consignment through a licensed dealer. Under current law, dealers can not allow prospective buyers of consigned trucks to test drive them, or carry a load with them prior to purchase, because there is no way to legally register the vehicle for that purpose. This legislation would allow for the proper and legal registration of consigned vehicles for test driving purposes.

## Analysis by the Legislative Reference Bureau

Under current law, a dealer, distributor, manufacturer or transporter of certain vehicles who registers with the department of transportation may be issued registration plates, in lieu of regular registration plates, for use on vehicles that are owned or repossessed by a dealer, distributor, manufacturer or transporter and that are being offered for sale.

This bill permits these registration plates to be used on vehicles that are consigned to a dealer, distributor, manufacturer of transporter and that are being offered for sale on consignment

I would like to bring your attention to five bills, Assembly Bills 54, 55, 56, 58 and 59, which have been referred to the Senate Insurance, Tourism, Transportation and Corrections Committee.

As you know, all five of these bills were introduced at the request of the Department of Transportation. Assembly Bill 54 makes the purchase of dealer plates by motor vehicle salvage pools optional. Assembly Bill 55 eliminates the mandatory revocation of a dealer license for misuse of dealer plates. Assembly Bill 56 equalizes the penalties for noncompliance with the Single State Insurance Registration System. Assembly Bill 58 eliminates the word "retail" in statutory references relating to motor vehicle auction dealer penalties and Assembly Bill 59 eliminates the three remaining statutory specified vehicle registration expiration dates.

During the public hearings on these bills, no one testified or registered in opposition. All of them were unanimously approved by the Assembly Transportation Committee and passed the Assembly on voice votes. Thus, I am respectfully requesting that Assembly Bills 54, 55, 56, 58 and 59 be scheduled for consideration by your committee. If you have questions regarding any of these bills, please let me know.

- 3. AB 56, relating to motor carriers and the single-state insurance registration system.

- 6. AB 59, relating to motor vehicle registration expiration dates.

- 9. AB 206, relating to creating a permit authorizing the operation upon a highway of a specialized hauling rig that exceeds statutory size and weight limits.
