Comments

5. Clarity, Grammar, Punctuation and Use of Plain Language

The second occurrence of the word "hunters" in s. NR 10.40 (3) (f) should be replaced with "hunter's" and both occurrences of the word "permits" in this paragraph should be drafted in the singular.

ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD AMENDING AND CREATING RULES

The Wisconsin Natural Resources Board proposes an order to amend NR 10.145(5)(d) and (6)(b), 10.27 (intro.), 10.40(3)(f), 15.13 (title) and (intro.) and to create NR 10.12(12) relating to hunting, trapping and wildlife research.

Analysis Prepared by the Department of Natural Resources

Statutory authority: ss. 29.014, 29.089, 29.327, 29.053(3) and 227.11, Stats. Statutes interpreted: ss. 29.014, 29.089, 29.327 and 29.053(3), Stats.

In this order:

Section 1. Requires the name and address of owner to be attached to all waterfowl blinds constructed on public property, in English letters one-inch square or larger.

Section 2. Allows the registration of otter in the whole carcass condition.

Section 3. Requires bobcat pelts to have attached registration tags in the event the pelt is transferred, given, traded, sold, or purchased.

Section 4. Clarifies state park deer seasons to refer only to the portions of those properties owned by the state.

Section 5. Authorizes zone T deer permits to be filled during disabled hunts.

Section 6. Establishes a no permit policy for wildlife research conducted on university of Wisconsin arboretum and university bay lands and waters. A report listing these research projects shall be submitted to the Department of Natural Resources annually for Department approval.

Section 1. NR 10.12(12) is created to read:

NR 10.12(12) WATERFOWL BLIND IDENTIFICATION. No person may maintain, occupy or use a blind situated on state-owned property for hunting waterfowl unless the owner's name, address and customer identification number, in the English language and in lettering one-inch square or larger, is affixed permanently to the blind. The name and address shall be readily visible on the blind and shall be kept legible at all times.

Section 2. NR 10.145 (5)(d) is amended to read:

NR 10.145 (5)(d). Mounting. Persons who intend to have a fisher or bobcat, fisher or otter mounted by a taxidermist may exhibit the fisher or bobcat, fisher or otter to the department for registration in whole carcass condition without separating the pelt and need not shall surrender the skinned carcass to the department until the taxidermist has separated the pelt within 30 days of registration.

Section 3. NR 10.145 (6)(b) is amended to read:

NR 10.145 (6)(b) *Transfer*. Transfer, give, trade, sell or purchase any <u>bobcat</u>, fisher or otter pelt without a registration tag being attached and locked to the head of the pelt.

Section 4. NR 10.27(intro.) is amended to read:

NR 10.27 State park deer hunting. (intro.) No person may hunt deer on the state owned portions of state parks and recreation land areas except as provided in this section. Portions of the properties listed may be posted closed to deer hunting.

Section 5. NR 10.40 (3)(f) is amended to read:

NR 10.40 (3)(f) *Rule compliance*. Unless otherwise provided by the department, all disabled hunters and accompanying persons shall comply with all hunting rules and laws applicable to the regular gun deer season specified under s. NR 10.01 (3)(e). The bag limit is one deer per hunters choice and antlerless deer permits issued under s. NR 10.104, and special permits issued under s. NR 10.117.

Section 6. NR 15.13 (title) and (intro.) are amended to read:

NR 15.13 (title) University bay and the university of Wisconsin arboretum. (intro.) Wildlife research in all phases, including the experimental harvest of wild animals and birds, may be conducted on lands and waters within the boundaries of the arboretum as described in s. NR 15.12 and University bay as described in s. NR 15.01 (5) (e). Research may be conducted by the department and its agents and by the regents of the university of Wisconsin or their agents without restriction. The university shall provide a list of all research projects conducted on the university arboretum and university bay properties annually to the department for department approval.

NR 10 and 15, Wis. Adm. Code Hunting, trapping and wildlife research

Board Order No. WM-2-00 Clearinghouse Rule No. 00-032

Statement of Need

The proposed rule contains housekeeping rule changes that are minor in nature and noncontroversial. The proposed changes involve clarifications, definitions, increasing management efficiency and altering limitations on hunters. The specific changes are:

In order to have control over the placement and subsequent removal of waterfowl hunting blinds, owners are required to put their names on the blind. The requirement of placing only a name on the blind is not adequate to help locate a person violating this section. This proposal requires all blinds on state-owned property to be permanently labeled with the owner's name and address in English letters one-inch square or larger.

Current rules allow for the registration of fisher and bobcat in whole condition, without pelt removal, if plans are to have a taxidermist mount the animal. This proposal adds otters to the existing rule. Current rules also do not specify a return time for department receipt of necessary carcasses. This proposal establishes a 30-day requirement.

Bobcat are added to an existing rule which requires a registration tag to be locked to the head of the pelt prior to transferring, giving, trading, selling or purchasing the pelt.

The current rule regarding state park deer seasons is clarified that it only pertains to those portions of the referenced state parks which are owned by the department.

The current rule regarding disabled hunts and special hunt authorizations does not specifically describe what tags may be used during these hunts. Currently zone T tags cannot be used during a disabled hunt. This proposal authorizes zone T permits to be filled during disabled hunts.

The proposed rule allows for research to be conducted on lands and waters of the university of Wisconsin arboretum and university bay. The university shall provide a list of research projects annually for Department approval.

Modifications as a Result of Public Hearing

Final Regulatory Flexibility Analysis
