1 **AN ACT to create** 77.52 (2) (a) 21. of the statutes; **relating to:** imposing the sales  
2 tax on beauty and barber services.

**Analysis by the Legislative Reference Bureau**

Under current law, the sale of beauty or barber services is not subject to the sales tax. This bill imposes the sales tax on beauty and barber services. For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.
