**CAUCUS SENATE AMENDMENT
TO SENATE SUBSTITUTE AMENDMENT 1,
TO 2001 SENATE BILL 55**

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 1195, line 24: after that line insert:

3 "SECTION 3793m. 767.51 (3m) of the statutes is created to read:

4 767.51 (3m) (a) Upon the request of both parents, the court shall include in the
5 judgment or order determining paternity an order changing the name of the child to
6 a name agreed upon by the parents.

7 (b) Except as provided in par. (a), the court may include in the judgment or order
8 determining paternity an order changing the surname of the child to a surname that
9 consists of the surnames of both parents separated by a hyphen or, if one or both

1 parents have more than one surname, of one of the surnames of each parent
2 separated by a hyphen, if all of the following apply:

3 1. Only one parent requests that the child's name be changed, or both parents
4 request that the child's name be changed but each parent requests a different name
5 change.

6 2. The court finds that such a name change is in the child's best interest.

7 (c) Section 786.36 does not apply to a name change under this subsection.”.
