**Assumptions Used in Arriving at Fiscal Estimate**

This legislation provides for GPR funding of Supreme Court campaigns. Grant amounts of \$100,000 are available to eligible candidates in the primary and \$300,000 to eligible candidates in the election. The number of eligible candidates will vary depending on whether it is an open seat or an incumbent is seeking reelection. Presently no election is scheduled for Supreme Court justice in 2002, 2004 and 2008.

When an incumbent is challenged there is generally only one challenging candidate. It is assumed that both candidates would qualify for the \$300,000 grant.

If it is an open seat is assumed there will be a primary with between 3 and 8 candidates contesting the election. For purposes of this estimate it is assumed that there will be 5 candidates qualifying for primary grants of \$100,000 each and 2 candidates qualifying for a grant of \$300,000 each.

The Elections Board will incur one-time costs for revising, preparing, printing and distributing forms, information materials, manuals and training materials.
