Assumptions Used in Arriving at Fiscal Estimate

Because this bill creates a new criminal offense, it would increase the SPD's costs of providing representation. Please note that under current law, a prosecutor can proceed under the general theft (criminal) statute or under the forfeiture provision.

The bill might also increase county costs for incarceration, either pretrial or after sentencing.
