#### Assumptions Used in Arriving at Fiscal Estimate

This bill expands the type of relationships that adults may be in for purposes of domestic abuse injunctions to include an adult who is being cared for by another and adults who have a dating relationship. It also increases the maximum duration time of the orders.

It is expected that additional domestic abuse restraining orders will be sought because of the expansion of the definition. The exact increase is impossible to predict with the data available. Additional judge, court commissioner, court reporter and court staff time would be needed to handle the additional proceedings. Such costs are borne by both the state and the county. Any additional revenue from filing fees for the restraining orders is also impossible to estimate. That revenue is split between the state and the county.
