To the Honorable, the Legislature:

This report is transmitted as required by sec. 20.002(11)(f), Wis. Stats. (for distribution to the appropriate standing

committees under sec. 13.172(3), Wis. Stats.), and confirms that the Department of Administration has found it necessary to exercise the "temporary reallocation of balances" authority provided by this section in order to meet payment responsibilities and cover resulting negative balances during the month of January 2002.

On January 1, 2002 the <u>Agricultural Producer Security</u> <u>Fund</u> balance was -\$122 thousand. This shortfall continued until January 4, 2002 when the balance reached a positive \$172 thousand. The shortfall was due to the initial start-up of the fund and a delay in the transfer of revenues into the fund.

The Agricultural Producer Security Fund shortfall was not in excess of the statutory interfund borrowing limitation and did not exceed the balances of the Funds available for interfund borrowing.

The distribution of interest earnings to investment pool participants is based on the average daily balance in the pool and each fund's share. Therefore, the monthly calculation by the State Controller's Office will automatically reflect the use of these temporary reallocations of balance authority.
