REPORT OF COMMITTEES

The committee on **Senate Organization** reports and recommends:

In accordance with Senate Rule 21, it is moved that the Senate Committee on Organization create two special committees, one to be named the "Education Finance Task Force", consisting of 15 members of the legislature and the public. The other special committee shall be named the "Task Force on Telecommunications Issues", consisting of 19 members of the legislature and the public. The special committees shall post meeting notices as a standing committee of the Senate, and shall be afforded the support afforded a standing committee of the Senate, granted authorization to contract for professional assistance and shall be eligible for reimbursement of actual and necessary expenses related to attendance at meetings of the special committee. Education Finance Task Force shall submit a report to the Senate no later than December 31, 2002. The Task Force on Telecommunications Issues shall submit a report to the Senate no later than February 15, 2002.
