### **CLEARINGHOUSE RULE 02-105**

### Comments

[NOTE: All citations to "Manual" in the comments below are to the Administrative Rules Procedures Manual, prepared by the Revisor of Statutes Bureau and the Legislative Council Staff, dated September 1998.]

### 1. Statutory Authority

In s. SFC 6.02, a certified advanced practice social worker may engage in psychotherapeutic activities only under the supervision of a person authorized by the board or by the Department of Health and Family Services to supervise the practice of clinical social work; however, s. 457.035 (2), Stats., specifies a different list of individuals [listed under s. 457.08 (4) (c) 1., 2., 3., and 4., Stats.] who are authorized to supervise a certified advanced practice social worker who engages in psychotherapy. This same problem occurs in s. SFC 6.03 for independent social workers who engage in psychotherapeutic activities. Why does the rule fail to incorporate the provisions of s. 457.08 (4) (c), Stats.?

## 2. Form, Style and Placement in Administrative Code

- a. In the statement of statutes interpreted in the analysis, the phrase "repealed and recreated" should be replaced by the word "affected."
- b. In the analysis, the citation in the explanation of SECTION 57 should read: "s. SFC 16.04."
- c. The treatment clause of SECTION 7 states that s. SFC 1.07 (intro.) is amended. However, the text of the rule shows no amendment to the introduction. Is it intended that the word "certificate" be replaced by the word "credential"?
  - d. It appears that the text following s. SFC 1.11 (intro.) is missing from the rule.

- e. In s. SFC 4.01, if the note is renumbered s. SFC 4.01 (2), then the current s. SFC 4.01 (2) should be repealed or renumbered. The best method is to repeal the note and then repeal and recreate s. SFC 4.01 (2). Next, SECTION 29 renumbers s. SFC 4.01 (1) (a) as s. SFC 4.01 (3). However, the text of the rule does not treat current s. SFC 4.01 (3). Finally, the treatment clause of SECTION 30 should read: "s. SFC 4.01 (1) (b) is repealed."
- f. In s. SFC 8.02 (5), the phrase "as a result of the nonstatutory provisions of Act 80" should be deleted and the phrase "will be required" should be replaced with "shall."
- g. In the SFC 11 chapter title, "Certification" should be replaced with "Licensure." A similar problem occurs in the title of chs. SFC 16 and 17.
- h. Since s. SFC 12.01 is repealed and recreated in SECTION 50, the treatments of s. SFC 12.01 in SECTIONS 48 and 49 are unnecessary and should be deleted from the text of the rule. The same comment applies to SECTION 51 of the rule which repeals s. SFC 12.02 (2) (a); that is, SECTION 51 should be deleted because of the treatment of s. SFC 12.02 (2) in SECTION 52. Finally, in s. SFC 12.01, the introduction should be renumbered as sub. (1); the remaining subsections should be renumbered accordingly; and in the first sentence of the newly renumbered sub. (1), it appears that the word "certificate" should be replaced by the word "license."
- i. In s. SFC 16.01 (2) (a), it appears that the notation "MPS" should be replaced by the notation "SFC."

### 5. Clarity, Grammar, Punctuation and Use of Plain Language

- a. In the treatment clause for s. SFC 8.02, the comma between (1) and (b) should be replaced by ", and."
- b. In s. SFC 8.02 (1), the rule should specify how a certified or licensed person should verify compliance as part of his or her application.
  - c. In s. SFC 8.02 (1) (b), how is the regulatory digest obtained?
  - d. In s. SFC 10.01 (4), the apostrophe in "cognition's" should be deleted.
- e. Section SFC 12.02 (2) (f) provides that supervision of a period of supervised practice of professional counseling may be exercised by an individual who is approved in advanced by the professional counselor section. This format is repeated in other provisions of the rule. By what process will individuals be approved in advance for supervision? This should be explained in the rule, possibly in a note.
- f. In s. SFC 17.03, it would be helpful to include a note explaining how the application form can be obtained from the department. [See s. 227.14 (3), Stats.]

### PROPOSED ORDER

An order of the Examining Board of Social Workers, Marriage and Family Therapists and Professional Counselors to repeal SFC 2.01 (19), 4.01 (1) (b), 1. and 2. and the Note following SFC 4.01 (4), ch. SFC 7, 8.01, 10.01 (7) and (8), 12.01 (1) (title), 12.02 (2) (a), ch. SFC 13, 16.04, 16.05 (1) (b) and (c); to renumber the Note following SFC 4.01 (1); to renumber and amend SFC 2.01 (3), 4.01 (1) (a), 12.01 (1) and 16.05 (1) (a); to amend SFC 1.02 (1) and (3), 1.04 (2), the Note following SFC 1.04 (2) (b), 1.05 (1), (5), (7), 1.07 (intro.) and (2), 1.08 (title) and (1) to (5), 2.01 (intro.), (11), (13), (16), ch. SFC 3 (title), 3.01 (4), 3.05 (4), 3.07 (3) and (5), 3.09 (intro.), (3) and (5), 3.12 (title), (4) (intro.) and (a), ch. ### **ANALYSIS**

Statutes authorizing promulgation: ss. 15.08 (5) (b) and 227.11 (2), Stats., and chapter 457, Stats. as repealed and recreated by 2001 Wisconsin Act 80.

Statutes interpreted: Chapter 457, Stats., as repealed and recreated by 2001 Wisconsin Act 80.

This proposed rule-making order implements the statutory changes made as a result of 2001 Wisconsin Act 80, relating to the Examining Board of Social Workers, Marriage and Family Therapists and Professional Counselors.

The rule changes are as follows:

Sections 1, 3, 5 and 33 changes the name of the board to the Marriage and Family Therapy, Professional Counselors and Social Worker Examining Board.

Section 2 creates definitions for "clinical practice" and "credential."

Sections 4, 6, 7, 8, 11, 14, 16, 20, 24, 26, 27, 29, 37, 41, 42, 44, 46, 47, 49, 55, 61, 62 and 65 replaces certification with licensure for marriage and family therapists, professional counselors and clinical social workers and replaces the word "certificate" with "credential" where appropriate.

Section 9 establishes rules under which credential holders may engage in alcohol and drug counseling, establishes a requirement that practitioners of psychotherapy obtain professional liability insurance, and establishes the rules under which credential holders may engage in psychometric testing.

Sections 13, 17, 18, 43, 50, 55, 56 adopts the legislature's new unified definition of post-degree supervised practice, i.e. 3,000 hours of supervised practice in the relevant field, including 1,000 hours of face-to-face client contact.

Sections 10, 12, 28 and 54 correct errors and oversights in the existing rules.

Section 19 creates temporary certificates for advanced practice social workers and independent social workers, and temporary licenses for clinical social workers.

Sections 21, 22, 23 and 25 require applicants for certification or licensure by reciprocity to take and pass an examination on the Wisconsin statutes relevant to the profession.

Sections 30, 31, 32, 51, 52, 59 and 60 adopt the legislature's list of acceptable supervisors for the post-degree and pre-certification practice.

Section 33 authorizes applicants to take both the national examination and the jurisprudence examination prior to the completion of other requirements.

Section 34 clarifies the scope of practice of advanced practice social workers, independent social workers, and clinical social workers, and includes an explicit reference to supervision by a person authorized by the department of health and family services.

Section 35 repeals ch. SFC 7.

Sections 36, 37, 38, 39 and 40 clarify rules regarding continuing education for social workers.

Section 45 permits applicants for licensure as professional counselors to take both parts of the examination prior to completing the required period of supervision.

Section 48 repeals the title of s. SFC 12.01 (1).

Section 42 replaces a definition of "psychotherapy" with the one specified by the legislature.

Section 52 adds a category of supervisor for the pre-certification practice of professional counseling.

Section 53 repeals ch. SFC 13.

Section 57 repeals s. 16.04.

Section 58 adds a category of supervisor for the pre-certification practice of marriage and family therapy.

Section 63 creates a marriage and family therapy training certificate.

Section 64 permits applicants for licensure as marriage and family therapists to take both parts of the examination prior to completing the required period of supervision.

### **TEXT OF RULE**

SECTION 1. SFC 1.02 (1) is amended to read:

SFC 1.02 (1) "Board" means the examining board of social workers, marriage and family therapists and professional counselors marriage and family therapy, professional counseling and social work examining board.

SECTION 2. SFC 1.02 (1i) and (1q) are created to read:

SFC 1.02 (1i) "Clinical practice" means professional practice that may involve psychotherapy.

(1q) "Credential" means a certificate or a license granted by the board.

SECTION 3. SFC 1.02 (3) is amended to read:

SFC 1.02 (3) "Section" means either the social worker section, the marriage and family therapists section, or the professional counselor section of the examining board of social workers, marriage and family therapists and professional counselors marriage and family therapy, professional counseling and social work examining board.

SECTION 4. SFC 1.04 (2) is amended to read:

SFC 1.04 (2) An applicant for any certificate credential under ch. 457, Stats., shall make application on forms prescribed by both the examination provider for the examination for the certificate credential for which the applicant is applying and the board. The applicant may not sit

for an examination unless the applicant meets the requirements of both the examination provider and the interested section of the board.

SECTION 5. The Note following SFC 1.04 (2) (b) is amended to read:

SECTION 6. SFC 1.05 (1), (5) and (7) are amended to read:

- SFC 1.05 (1) The board or its designee shall administer the examinations required of applicants for certification as a social worker, advanced practice social worker, or independent clinical social worker, or for licensure as a clinical social worker, marriage and family therapist or professional counselor at least once a year.
- (5) The board may deny release of grades or issuance of a <u>certificate</u> <u>credential</u> if the board determines that the applicant violated rules of conduct or otherwise acted dishonestly.
- (7) An applicant for certification as a social worker, advanced practice social worker, or independent social worker or independent for licensure as a clinical social worker, need not take part II of the examination if within the 5 years preceding the date of application, the applicant took and passed part II in the process of applying for and receiving another social worker certification credential from the section.

SECTION 7. SFC 1.07 (intro.) and (2) are amended to read:

SFC 1.07 Claims of examination error. (intro.) An applicant for any certificate issued by the board who claims an error in the examination may file a written request for board review in the board office within 30 days of the date the examination was reviewed. The board shall review the claim and notify the applicant in writing of the board's decision and any resulting grade changes. Claims of examination error which are not filed within 30 days of an examination review shall be denied. The request shall include:

(2) The type of certificate credential applied for.

SECTION 8. SFC 1.08 (title) and (1) to (5) are amended to read:

SFC 1.08 (title) Certificate Credential renewal procedures for all sections of the board. (1) Each person granted a certificate credential under ch. 457, Stats., is certified or licensed for the current certification period only. To renew certification or licensure, a certificate credential holder shall by July 1 of the odd-numbered year following initial certification or licensure and every 2 years thereafter file with the board an application for renewal on a form prescribed by the board, and submit the fee under s. 440.08 (2), Stats.

- (2) A certificate credential holder who fails to renew certification or licensure shall cease and desist from using practice and from use of the professional title. Within 5 years following the renewal date, a certificate credential holder may renew the expired certificate credential without examination by filing with the required renewal application, the renewal fee, and the late renewal fee under s. 440.08 (3), Stats. A certificate credential holder who fails to renew certification or licensure within 5 years of the renewal date may be reinstated by complying with the requirements for obtaining initial certification or licensure, including educational and examination requirements which apply at the time application is made.
- (3) An applicant for reinstatement of certification or licensure following disciplinary action shall meet requirements in sub. (1) and may be required to successfully complete an examination as the board prescribes. An applicant who applies for reinstatement more than 5 years after the date of the order imposing discipline against the applicant may be reinstated by complying with the requirements for obtaining initial certification or licensure, including educational and examination requirements which apply at the time the application for reinstatement is made.
- (4) The <u>certificate</u> <u>credential</u> and certificate of biennial certification <u>or licensure</u> shall be displayed in a prominent place by each person while certified <u>or licensed</u> by the board.
- (5) Every certificate credential holder shall notify the department, in writing, of a change of name or address within 30 days of the change.

SECTION 9. SFC 1.09, 1.10 and 1.11 are created to read:

- SFC 1.09 Alcohol and drug counseling. A person credentialed by the board may use the title "alcohol and drug counselor" or "chemical dependency counselor," and may treat alcohol or substance dependency or abuse as a specialty only if he or she is certified as a substance abuse counselor under s. HFS 75.02 (84).
- SFC 1.10 (1) Professional liability insurance. Except as provided in sub. (2), a person licensed as a clinical social worker, marriage and family therapist, or professional counselor may not practice clinical social work, marriage and family therapy, or professional counseling unless he or she has in effect professional liability insurance in the amount of at least \$1,000,000 for each occurrence and \$3,000,000 for all occurrences in one year.
- (2) Subsection (1) does not apply to a person practicing clinical social work, marriage and family therapy, or professional counseling as an employee of a federal, state, or local governmental agency, if the practice is part of the duties for which he or she is employed and is solely within the confines of or under the jurisdiction of the agency by which he or she is employed.

The marriage and family therapist section shall grant a certificate license as a marriage and family therapist under s. 457.10, Stats., to an applicant who pays the fee required by s. 440.05 (2), Stats., and provides evidence of all of the following to the section:
- (2) The requirements for the grant of the credential in the other state or territory of the United States are substantially equivalent to the requirements for the grant of a certificate license under s. 457.10, Stats.
- (4) If the applicant has been convicted of a crime, or of a traffic offense which did or could result in the suspension or revocation of the applicant's driver's license, or the applicant has such charges pending against the applicant, the applicant has disclosed all information necessary for the section to determine whether the circumstances of the pending charge or conviction are substantially related to the duties of practice under a marriage and family therapist certificate license.

SECTION 63. SFC 17.03 is created to read:

- SFC 17.03 Training certificate. (1) The marriage and family therapist section shall grant a marriage and family therapist training certificate to any individual who does all of the following:
- (a) Submits an application for the certificate to the department on a form provided by the department.
  - (b) Pays the fee specified in s. 440.05 (6), Stats.
  - (c) Satisfies the requirements in s. 457.10 (2), Stats.
- (d) Submits evidence satisfactory to the marriage and family therapist section that he or she is employed full-time, or has an offer of full-time employment, as a marriage and family therapist in a supervised marriage and family therapist practice or in a position in which the applicant will, in the opinion of the marriage and family therapist section, receive training and supervision equivalent to the training and supervision received in a full-time supervised marriage and family therapist practice.
- (2) A marriage and family therapist training certificate is valid for 24 months or until the date on which the holder of the certificate ceases to be employed in a position specified

in sub. (1) (d), whichever occurs first, and may not be renewed by the marriage and family therapist section. A marriage and family therapist training certificate authorizes the holder to use any title specified in s. 457.04 (5), Stats., and to practice marriage and family therapy within the scope of his or her training or supervision during the period in which the certificate is valid.

SECTION 64. SFC 18.01 is amended to read:

- SFC 18.01 Examination. An applicant for a certificate license as a marriage and family therapist shall successfully complete the examination consisting of the Wisconsin statutes and rules examination and the examination in marriage and family therapy of the association of marital and family therapy regulatory boards. Both parts of the examination may be taken prior to the completion of the required period of supervision.

- (9) Practicing or attempting to practice while the certificate credential holder is impaired due to the utilization of alcohol or other drugs, or as a result of an illness which impairs the certificate credential holder's ability to appropriately carry out the functions delineated under the credential in a manner consistent with the safety of a client, patient, or the public.
- (15) Employing or claiming to have available secret techniques or procedures that the certificate credential holder refuses to divulge.
- (17) Failing to inform the client of financial interests which are not obvious and which might accrue to the <u>certificate</u> <u>credential</u> holder for referral to or for any use of service, product or publication.
- (20) Failing to notify the board that a license, certificate or registration for the practice of any profession previously issued to the certificate credential holder has been revoked, suspended, limited or denied, or subject to any other disciplinary action by the authorities of any jurisdiction.
- (21) Failing to make reasonable efforts to notify a client or a client's authorized representative when professional services will be interrupted or terminated by the professional credential holder.

The total cost to implement the rule is estimated to be \$64,400. The Department can not absorb these costs.

Several areas of work will be required as a result of rule implementation. - 4. Recognize the potential for substance use disorders to mimic a variety of medical and psychological disorders and the potential for medical and psychological disorders to co-exist with addiction and substance abuse.

## (b) Treatment knowledge.

- 1. Describe the philosophies, practices, policies and outcomes of the most generally accepted and scientifically supported models of treatment, recovery, relapse prevention, and continuing care for addiction and other substance-related problems.
- 2. Recognize the importance of family, social networks, and community systems in the treatment and recovery process.
- 3. Understand the importance of research and outcome data and their application in clinical practice.

4. Understand the value of an interdisciplinary approach to addiction treatment.

### (c) Application to practice.

- 1. Understand the established diagnostic criteria for substance use disorders and describe treatment modalities and placement criteria within the continuum of care.
- 2. Describe a variety of helping strategies for reducing the negative effects of substance use, abuse and dependence.
- 3. Tailor helping strategies and treatment modalities to the client's stage of dependence, change or recovery.
- 4. Provide treatment services appropriate to the personal and cultural identity and language of the client.
  - 5. Adapt practice to the range of treatment settings and modalities.
- 6. Be familiar with medical and pharmacological resources in the treatment of substance use disorders.
- 7. Understand the variety of insurance and health maintenance options available and the importance of helping clients access those benefits.
- 8. Recognize that crisis may indicate an underlying substance use disorder and may be a window of opportunity for change.
- 9. Understand the need for and the use of methods for measuring treatment outcome.

### (d) Professional readiness.

- 1. Understand diverse cultures and incorporate the relevant needs of culturally diverse groups, as well as people with disabilities, into clinical practice.
- 2. Understand the importance of self-awareness in one's personal, professional and cultural life.
- 3. Understand the addiction professional's obligations to adhere to ethical and behavioral standards of conduct in the helping relationship.
- 4. Understand the importance of ongoing supervision and continuing education in the delivery of client services.

- 5. Understand the obligation of the addiction professional to participate in prevention as well as treatment.
- 6. Understand and apply setting-specific policies and procedures for handling crisis or dangerous situations, including safety measures for clients and staff.

- 8. Testing individuals with disabilities.
- (b) An affidavit from a professional qualified to supervise psychometric testing that the individual licensee has acquired supervised experience and acquired specific qualifications for the responsible selection, administration, scoring and interpretation of one or more particular psychometric tests, including, if appropriate, use of the test(s) in particular settings or for specific purposes. Particular settings include an employment context, an educational context, a career and vocational counseling context, a health care context, or a forensic context. Specific purposes include classification, description, prediction, intervention planning, tracking, training and supervision.

(b) Of the 30 required hours, at least 4 hours shall be in the subject area of social work ethics. At least 2 of the 4 hours shall be in issues concerning professional and boundaries. such requirement will be published in the regulatory digest that is mailed to all credential holders.

SFC 17.03 Training certificate. (1) The marriage and family therapist section shall grant a marriage and family therapist training certificate to any individual who does all of the following:

- (a) Submits a completed, signed application form.
- (b) Pays the fee specified in s. 440.05 (6), Stats.

- (c) Satisfies the requirements in s. 457.10 (2), Stats.
- (d) Submits evidence satisfactory to the marriage and family therapist section that he or she is employed full-time, or has an offer of full-time employment, as a marriage and family therapist in a supervised marriage and family therapist practice or in a position in which the applicant will, in the opinion of the marriage and family therapist section, receive training and supervision equivalent to the training and supervision received in a full-time supervised marriage and family therapist practice.
- (2) A marriage and family therapist training certificate is valid for 24 months or until the date on which the holder of the certificate ceases to be employed in a position specified in sub. (1) (d), whichever occurs first, and may not be renewed by the marriage and family therapist section. A marriage and family therapist training certificate authorizes the holder to use any title specified in s. 457.04 (5), Stats., and to practice marriage and family therapy within the scope of his or her training or supervision during the period in which the certificate is valid.

SECTION 75. SFC 18.01 is amended to read:

SFC 18.01 Examination. An applicant for a certificate license as a marriage and family therapist shall successfully complete the examination consisting of the Wisconsin statutes and rules examination and the examination in marriage and family therapy of the association of marital and family therapy regulatory boards. Both parts of the examination may be taken prior to the completion of the required period of supervision.

SECTION 76. Chapter SFC 19 is created to read:

#### CHAPTER SFC 19 CONTINUING EDUCATION

- SFC 19.01 Continuing education requirements for license renewal. (1) Unless granted a postponement or waiver of the continuing education requirement, every licensed marriage and family therapist is required to complete at least 30 continuing education credit hours in approved continuing education programs during each 2 year licensure period. This requirement will apply for the first time to the 2 year period beginning July 1, 2003.
- (2) A licensee who treats alcohol or substance dependency or abuse as a specialty must complete at least 10 of the required 30 continuing education hours in alcohol or substance dependency or abuse education, and will be granted credit against the required 30 hours for no more than 18 hours in alcohol or substance dependency or abuse education.
- (3) Unless granted a postponement or waiver of the continuing education requirement, a licensee who fails to meet continuing education requirements by the renewal deadline must discontinue the use of the title "marriage and family therapist" and must cease the practice of marriage and family therapy until he or she completes the continuing education requirement.

- (4) During the time between initial licensure and commencement of a full 2 year certification period, a new license holder is not required to meet continuing education requirements for the first renewal of his or her license.
- (5) Applicants for licensure by reciprocity shall submit proof of completion of at least 30 continuing education hours substantially meeting the requirements of this chapter within the 2 year period prior to application.
- (6) Continuing education hours may apply only to the 2 year license period in which the credit hours are acquired, unless either of the following applies:
- (a) Continuing education hours required as a consequence of a disciplinary proceeding may not be counted towards the fulfillment of generally applicable continuing education requirements.
- (b) If the licensee fails to meet the continuing education requirement during a 2 year license period, any additional continuing education hours obtained on or after the renewal date to satisfy the requirement of the preceding period will not apply to the period in which they are earned.
- (7) To obtain credit for completion of continuing education programs, a marriage and family therapist shall certify on his or her application for renewal of license that he or she has completed all continuing education credits as required in this section for the previous 2 year license period. A licensee shall retain for a minimum period of 4 years, and shall make available to the board or its agent upon request, certificates of attendance issued by the program sponsor for all continuing education programs for which he or she claims credit for purposes of renewal of his or her license.
- (8) A licensee may apply to the section for a postponement or waiver of the requirements of this chapter on grounds of prolonged illness, disability, or other grounds constituting extreme hardship. The section shall consider each application individually on its merits, and the section may grant a postponement, partial waiver or total waiver as deemed appropriate in the circumstances.
- (9) The section may grant an exemption from the requirements of this chapter to a licensee who certifies to the section that he or she has permanently retired and no longer uses the title "marriage and family therapist" and no longer practices marriage and family therapy. A licensee who has been granted an exemption from the requirements of this chapter based on retirement may not return to the active practice of marriage and family therapy or use the title "marriage and family therapist" without submitting evidence satisfactory to the section that he or she completed at least 30 continuing education hours for each of the biennia during which the licensee was granted an exemption.
- (10) The section may conduct audits or investigations, including random audits, to determine compliance by licensees with this chapter.

- **SFC 19.02 Approved continuing education programs.** The following continuing education programs and other educational activities are approved as continuing education programs under this chapter:
- (1) Any continuing education program sponsored by the American association for marriage and family therapy (AAMFT).
- (2) Any continuing education program approved, sponsored or authorized by the Wisconsin association for marriage and family therapy (WAMFT).
- (3) Any continuing education program or course offered by a training program accredited by the commission on accreditation for marriage and family therapy education (COAMFTE).
- (4) Any course or continuing education program offered by an accredited college or university.
- SECTION 77. SFC 20.02 (intro.), (1), (4), (9), (15), (17), (20), (21) and (23) are amended to read:
- SFC 20.02 (intro.) Unprofessional conduct related to the practice under the <u>a</u> credential issued under ch. 457, Stats., includes, but is not limited to, engaging in, attempting to engage in, or aiding or abetting the following conduct:
- (1) Performing or offering to perform services for which the eertificate credential holder is not qualified by education, training or experience.
  - (4) Using fraud or deception in the application for a certificate credential.
- (9) Practicing or attempting to practice while the <u>certificate credential</u> holder is impaired due to the utilization of alcohol or other drugs, or as a result of an illness which impairs the <u>certificate credential</u> holder's ability to appropriately carry out the functions delineated under the credential in a manner consistent with the safety of a client, patient, or the public.
- (15) Employing or claiming to have available secret techniques or procedures that the <u>certificate credential</u> holder refuses to divulge.
- (17) Failing to inform the client of financial interests which are not obvious and which might accrue to the <u>certificate credential</u> holder for referral to or for any use of service, product or publication.
- (20) Failing to notify the board that a license, certificate or registration for the practice of any profession previously issued to the eertificate credential holder has been revoked, suspended, limited or denied, or subject to any other disciplinary action by the authorities of any jurisdiction.

#### **FISCAL ESTIMATE**

- 1. The anticipated fiscal effect on the fiscal liability and revenues of any local unit of government of the proposed rule is: \$0.00.
  - 2. The projected anticipated state fiscal effect during the current biennium of the proposed rule is:

The total cost to implement the rule is estimated to be \$64,400. The Department can not absorb these costs.

Several areas of work will be required as a result of rule implementation. These include: 1) application development; 2) Renewal notice revision; 3) Establishment of AODA certification process including Board review of applicant qualifications; 4) Continuing Education development and review; 5) Development of a training licensure process; 6) Enforcement of new credentials, continuing education and AODA standards; and 7) IT work related automated systems; 8) Response to questions regarding Act 80 from licensees; and 9) notification via mail to current certificate holders.

The inclusion of a provision for the Social Work section to review and certify a person as a substance abuse counselor, rather than relying solely on the DFS process, will have a substantial impact on costs to the Department. It is estimated that this provision alone will incrementally increase costs by \$30,000. Additional time will be need by processing staff to review submitted materials. The Board will need to be convened and staffed for review and interview of potential credential holders. Follow-up will be needed with applicant credentials that fail to satisfy the Board.

3. The projected net annualized fiscal impact on state funds of the proposed rule is: On-going costs of the proposed rule are estimated at \$35,000 annually.
