**PROPOSED ADMINISTRATIVE RULES - HFS 112
ANALYSIS FOR LEGISLATIVE STANDING COMMITTEES
PURSUANT TO S. 227.19 (3), STATS.**

Need for Proposed Rules

Under chs. 146 and 250, Stats., the Department of Health and Family Services licenses emergency medical technicians-paramedic (EMTS-paramedic) and approves the operational plans that counties, cities, towns, villages and hospitals propose for using EMTs-paramedic to deliver emergency medical care. The Department's rules are in ch. HFS 112, Wis. Adm. Code. No individual may perform the duties of an EMT-paramedic unless licensed by the Department.

Through repeal and recreation, this rulemaking order modifies ch. HFS 112 to reflect changes in the practice of emergency medical services since the chapter was last revised in September 1996. The Department is proposing these changes based on extensive discussions with EMS advisory bodies and other interested parties. Significant changes to the chapter include use of the term "interfacility" to distinguish between facilities and prehospital 911 care; clarification regarding the term "medical director;" raising the minimum number of hours required for EMT-paramedic coursework from 750 to 1000; and the addition of flexibility for ambulance providers to use fewer than 2 paramedics in certain circumstances. The updating also adds renewal requirements for instructor-coordinators and increases authority for a medical director to remove medical authority for an EMT to practice if there are concerns about the EMTs training, skills, ability or judgment. Educational modifications were discussed with the Education Committee of the EMS Board, which includes representation from the Wisconsin Technical College System.

The Department's authority to repeal and recreate these rules is found in ss. 146.50 (4) (c), (5) (b), (6) (b) 2. and (13) and 250.04 (7), Stats. The rules interpret s. 146.50, Stats.

Response to Clearinghouse Recommendations

All comments of the Legislative Council's Rules Clearinghouse were accepted, except the following:

2.f. Comment (partial): In s. HFS 112.04 (5) (b) 2., by what mechanism does the department intend to monitor whether a person with an EMT license maintains valid CPR certification throughout the license period?

Response: The department does not monitor whether a person with an EMT license maintains valid CPR certification throughout the license period. The department only informs the ambulance service and EMT that a valid CPR certification must be maintained. The individual and the service self-monitor compliance.

2.i. Comment: Section HFS 112.06 (1) (c) sets forth several affirmative requirements for training centers which should not be included in that section, since the provision intends to be a listing of application materials. The rule should be reorganized to set forth certain of these items as requirements which must be met to gain certification of a training center rather than items which must be included in its application. For example, s. HFS 112.06 (1) (c) 3. requires the application to include "identification and documentation of the qualifications of the Wisconsin licensed physician who will function as medical director of the training center, with responsibility for medical coordination, direction and conduct of the EMT-paramedic training program." The rule should be reorganized to clearly require each EMT-paramedic training center to have a medical director who must be a Wisconsin-licensed physician and the rule should set forth the responsibilities of the

medical director. As further examples, s. HFS 112.06 (1) (c) 1., in the second sentence, sets forth specific training requirements which must be met, and subd. 5. sets forth a listing of the responsibilities of a "field preceptor." This comment also applies to s. HFS 112.06 (3) (b).

Response: No change. This formatting is consistent with ch. HFS 110, which was recently updated and published. The recent clearinghouse review of ch. HFS 110 did not show a problem with the corresponding section of ch. HFS 110 [s. HFS 110.07 (1) (c).] Given that one of the Department's goals of updating its EMS rules (chs. HFS 110, 111 and 112) is to have consistent language among them, the Department does not propose to make the suggested changes. The responsibilities of the medical director are specified in s. HFS 112.06 (1) (c) 4.

2.L. Comment: Should s. HFS 112.07 (2) (e) set forth any guidelines regarding the determination of the "service area" of a licensed ambulance service provider?

Response: No. If the comment implied that the Department should approve service areas of licensed ambulance service providers, the Department believes that it lacks sufficient statutory authority to do so. If the comment suggests that the Department provide guidelines on how a licensed ambulance service provider should determine or specify the provider's service area, the Department does not believe it necessary to do so.

2.m. Comment: Section 112.07 (2) (i) requires an EMT-paramedic operational plan to include "a description of the relationship of the proposed EMT-paramedic services to other emergency medical and public safety services in the geographic area covered in the plan." Does the rule require that there be a relationship? If so, that requirement should be affirmatively stated in the rule. Likewise, par. (m) requires the plan to contain "a description of the method of data collection..." Is there a requirement that certain data be collected? If so, what data must be collected and by whom must it be collected?

Response: A relationship will always exist between a proposed EMT-paramedic service and other emergency medical and public safety services in a given geographic area. The requirement in par. (i) is to describe the relationship that exists, not whether there is a relationship. There needs to be coordination of emergency medical and public safety services in a response area. The operational plan needs to describe that relationship. The Department has never denied a plan because of this description, but it has, in some cases, facilitated meetings to improve the relationship.

With respect to par. (m), the Department proposal to require operational plans to describe how data is collected and agree to provide data to the Department, when requested by the Department, is currently for informational purposes only. The Department is trying to develop a statewide EMS data collection system and knowing how each provider collects data helps the Department in planning that system. The language to submit data, when requested, provides a placeholder in the rule that will enable the Department to collect pertinent data when doing so is feasible for both the Department and the ambulance service providers.

With respect to both pars. (i) and (m), the Clearinghouse review of ch. HFS 110 did not show a problem with the corresponding provisions of ch. HFS 110. One of the Department's goals of updating its EMS rules (chs. HFS 110, 111 and 112) is to have consistent language among them. For this additional reason, the Department also does not propose to make the suggested changes.

2.n. Comment: The rule should explain what is meant by "mutual aid and backup agreements" referred to in s. HFS 112.07 (2) (s). Are such agreements required? If so, that requirement should be clearly set forth in the rule in detail.

Response: By virtue of being listed in under sub. (2), the Department requires ambulance services to have mutual aid and backup agreements. The Department added a definition of "mutual aid and backup agreements" to clarify what those agreements consist of.

2.o. Comment: In s. HFS 112.07 (5) (b), is the "operational plan" referred to the same as the operational plan required and described under sub. (2)? If not, the rule should set forth the required elements of the operational plan which is required for special event EMT-paramedic coverage. This comment also applies to sub. (6) (b) and (c).

Response: It can be the same operational plan. The Department has clarified the wording of s. HFS 112.07 (5) (a) to make it clearer what circumstances trigger the need to have an operational plan for "special event" coverage and has modified the wording of s. HFS 112.07 (5) (b) to clarify that a plan or a plan amendment is necessary only if the existing plan does not encompass or address "special event" coverage.

2.p. Comment: Section HFS 112.07 (7) (a) 5. refers to "the other physicians involved in the plan." Is there a requirement that other physicians be involved? If so, that requirement should be set forth clearly in the rule.

Response: No, additional physicians are not required. The Department has modified the language to clarify that other physicians are optional.

2.q. Comment: Section HFS 112.07 (7) (a) 7. refers to the implementation of the "findings and recommendations of the quality assurance program." Should the rule set forth a requirement that a quality assurance program be established, that it contain findings and recommendations and that those findings and recommendations be implemented?

Response: No change. In s. HFS 112.07 (2) (L), the Department requires providers to have a quality assurance plan. The Department sees no practical difference between requiring a "plan" versus a "program." Section HFS 112.07 (2) (L) specifies that the plan must contain copies of policies and procedures to be used in medical control, implementation and evaluation of the program.

2.r. Comment: The requirements that must be met by an "on-line medical control physician" included in s. HFS 112.07 (7) (b) should be placed in a separate section of the rule. (Section HFS 112.07 (7) is entitled "medical director roles and responsibilities.") In addition, must the EMT-paramedic operational plan contain documentation verifying that the requirements set forth in s. HFS 112.07 (7) (b) have been met?

Response: No change. The Department has not accepted the suggestion for two reasons. First, ch. HFS 110, which the Department recently promulgated, has similar language in the section describing the roles and responsibilities of the medical director. The Clearinghouse did not make this suggestion with respect to ch. HFS 110 and, to promote consistent interpretation, the Department wants chs. HFS 110, 111 and 112 to be consistent. Moreover, the Department believes that there is no more appropriate location within the rule for these requirements than to associate them with the roles and responsibilities of the medical director. One of the medical director's responsibilities is to designate on-line medical control physicians.

2.s. Comment: In s. HFS 112.07 (7), the note following par. (c) contains substantive material and should be placed in the text of the rule.

Response: The Department changed the wording to the extent that the note no longer contains substantive material, but refers to substantive provisions in ch. HFS 110. It now clarifies the distinction that there may be 2 physicians with different roles and contains a clarifying note similar to one that is also in ch. HFS 110.

4.c. Comment: Section HFS 112.04 (5) (b) 5. should contain a cross-reference to any other portions of the rule which set forth any additional eligibility requirements for being licensed as an EMT-paramedic.

Response: Agree. The Department has modified the wording to allow the department to request further documentation from out-of-state EMTs who get "equivalent" training, but don't take the Wisconsin-approved course and has cross-referenced s. HFS 112.04 (1) (d).

5.c. Comment (in part): What is "first-in emergency medical care"?

Response: "First-in emergency medical care" means the ambulance that is the primary responder to an area. The Department uses this term as part of its criteria for receiving EMS funding assistance money and has included this definition in the proposed rules as s. HFS 112.03 (16).

5.d. Comment: In s. HFS 112.04 (1) (d), how is it to be determined if training is "equivalent" and if it is "acceptable" to the department?

Response: No change. Section HFS 112.04 (1) (d) indicates that alternative training, e.g., from another state, whose coursework gives evidence of covering all the areas listed in s. HFS 112.06 (3), would be acceptable and, therefore, approved by the Department. The Department determines whether the coursework and training is acceptable by comparing it to the elements of the approved curriculum specified in s. HFS 112.06 (3).

5.e. Comment: In s. HFS 112.04 (1) (f), what is meant by "successful completion" of the examination? Should the rule set forth a percentage score which must be achieved? In addition, why does the rule refer to a "department approved" written examination when it appears, under sub. (2), that the department administers all examinations?

Response: The Department has supplemented the term "successfully completed" with the term "passing" to clarify the required threshold of success. The Department prefers to retain the ability to define and redefine, as necessary, a passing score without engaging in a lengthy rule promulgation process. With respect to the "department approved" written examination question, the general wording leaves open the opportunity for the Department to change both examinations and who administers those exams without having to alter the rule's wording. The Department may, in the future, delegate the actual administration of the exam and the wording also leaves that option open. Finally, the word "written" examination has been deleted in response to public comment.

5.f. Comment: In s. HFS 112.04 (1) (g), how is it determined whether a course in cardiopulmonary resuscitation is approved by the department?

Response: The course is reviewed against a set of standards that include course prerequisites, curriculum content, instructor standards, student to teacher ratio, and evaluation

methods. The specific criteria are included in the EMS Section Policy and Procedure Manual. A copy of the criteria is attached.

5.g. Comment: In s. HFS 112.04 (4) (b) 2., how is it to be determined which additional medications have been approved by the department?

Response: Additional medications are approved based on the process described in s. HFS 112.04 (4) (b) 2. A list of medications is included in the approved curriculum. Providers are also notified when changes are made to the medication list.

5.h. Comment: In s. HFS 112.04 (5) (e) 1. (intro.), it appears that the number "3" should be replaced by the number "4" in order to treat all time periods. [For example, see s. HFS 112.04 (5) (e) 3.]

Response: The Department intended to have a uniform 3-year timeframe and therefore changed the reference in s. HFS 112.04 (5) (e) 3. to 3 years instead.

5.i. Comment: Section HFS 112.06 (1) (b) states that any organization may apply for certification to provide EMT-paramedic training or to offer "training courses." However, there does not appear to be any difference between the two. The remainder of the rule appears to only set forth requirements for a complete training program and does not appear to allow for the provision of only a portion of the EMT-paramedic training program. This point should be clarified.

Response: The Department changed the language to read "apply the the department for certification to provide EMT-paramedic training courses," which means an entire course in paramedic instruction. This is an initial approval that remains in effect as long as the training center meets the requirements.

5.j. Comment: Who must sign the "commitment" referred to in s. HFS 112.06 (1) (c) 2.?

Response: The Department has clarified in the rule that a training center representative must sign the commitment.

5.k. Comment: In s. HFS 112.06 (1) (c) 5. b., could a medical director designate a person to act as a preceptor if the person did not have at least two years of full-time experience? Is this provision a redundant restatement of subpar. d.? This point should be clarified. In addition, subpar. e. should set forth the specific records which must be maintained by the field preceptor and the length of time which those records must be maintained.

Response: The Department has substituted the word "and" for "or" in what is now s. HFS 112.06 (1) (c) 6. b. to add medical director designation to the 2 years experience requirement. Subdivision paragraph d. of the previously proposed rules has been deleted. With respect to what was previously subdiv. par. e., the Department also modified the record keeping language requirement for preceptors in what is now subd. par. d. The recordkeeping responsibility requirement has been shifted to the training center as specified in s. HFS 112.06 (1) (c) 3.

5.p. Comment: In s. HFS 112.06 (2) (d) 1., what is meant by "equivalent licensure?" Is this in conflict with par. (a) 1.?

Response: The term "equivalent licensure" was deleted in response to public comment.

5.q. Comment: Is there a time limit by which an application for renewal of certification must be submitted under s. HFS 112.06 (2) (d)?

Response: No. However, EMT-paramedic instructor-coordinators cannot teach unless they meet the requirements and renew their certifications.

5.r. Comment (partial): ...In addition, the rule should set forth the number of hours that are required to be devoted to classroom training, clinical training and supervised field experience. In addition, why does that subdivision make the submission of a copy of the course curriculum optional when pars. (d) and (e) appear to require submission of the curriculum?

Response: The number of hours that are required to be devoted to classroom training, clinical training and supervised field experience are specified in s. HFS 112.06 (4) (e). Subdivision 1. does not require submission of a copy of the course curriculum if the EMT-paramedic training course agrees to use the Wisconsin curriculum in its entirety. The Department only requires submission of a copy of the course curriculum if it varies from the Wisconsin curriculum.

5.s. Comment: Section HFS 112.06 (3) (b) 2. d. appears to require an EMT-paramedic training center to include clinical experience within a teaching hospital. Is this accurate? If so, that requirement should be clearly set forth in the rule.

Response: The Department changed the reference from "teaching hospital" to "hospital," defined clinical experience in s. HFS 112.03 (9), and further described the training requirement in s. HFS 112.06 (4).

5.t. Comment: How is it to be determined how often it is "necessary" for a training center to resubmit its curriculum and training plans to the department, as required under s. HFS 112.06 (3) (e)?

Response: The training center must resubmit its curriculum and training plans if the scope of the curriculum changes. The Department has modified the paragraph's wording to indicate this.

5.v. Comment: How is it to be determined whether the content and behavioral objectives are "at least equivalent to" the Wisconsin Revision of the National Standard Curriculum for Training EMTs-paramedic, as required under s. HFS 112.06 (4) (b)?

Response: Department staff determines equivalence by comparing the curriculum content and objectives with the content and objectives in the Wisconsin Revision of the National Standard Paramedic Curriculum. The Department has also added a note that the Curriculum is available.

5.w. Comment Section HFS 112.06 (4) (c) speaks of subsequent applications for course approval. For what period of time is initial course approval valid?

Response: Each course is individually approved initially, and is valid indefinitely for that specific course only. If the course provider wants to modify the course, a subsequent application is required.

5.x. Comment: The rule should clarify the meaning of the terms "clinical training," "supervised field training" and "patient care setting," used in s. HFS 112.06 (4) (d). In addition, what are the "minimum skill and patient assessment requirements identified by the department" referred to in that paragraph?

Response: The Department has added definitions for the three terms at s. HFS 112.03 (9), (41) and (28) respectively. The minimum skill and assessment requirements are a table of minimum competencies that have to be met to complete training and are a part of the curriculum. A reference note indicating the availability of skill and assessment requirements has been added after par. (d).

5.y. Comment: How is it to be determined what equipment and supplies "are necessary to effectively render EMT-paramedic services," as required under s. HFS 112.07 (2) (q)?

Response: By providing the protocols for use of drugs, equipment and skills to be used by the provider in s. HFS 112.07 (2) (o), the operational plan describes the skills and medications the provider will use. All equipment and supplies listed must be stocked on the ambulance.

5.z. Comment: In s. HFS 112.07 (2) (u) 2., has the scope of practice statement been incorporated by reference under s. 227.21, Stats.?

Response: The Department has not incorporated the Scope of Practice Statement by reference into ch. HFS 112 or included it as an appendix to ch. HFS 112 primarily because the Statement interprets provisions of United States Code 42 USC 1395dd and reflects current medical practice regarding interfacility transport. Accepted medical practices change periodically. Therefore, the Department believes that not including the Statement as an appendix to the chapter gives the Department needed flexibility to modify the Statement relatively quickly in response to changing medical practices, and in so doing, benefits the patients being transported. Furthermore, in the recently promulgated ch. HFS 110, a similar reference is made to the Scope of Practice Statement, but the Clearinghouse did not make a comment similar to 5.z. For these reasons, the Statement has neither been incorporated by reference nor included as an appendix to the chapter. However, the federal code sources are identified in the rule and a note has been inserted informing readers how to obtain the current version of the Scope of Practice Statement.

5.aa. Comment: Must an amendment, referred to in s. HFS 112.07 (4) (c), be approved by the department before it may be implemented?

Response: Yes. All plans and plan amendments need to be approved before being implemented as stated in s. HFS 112.07 (8) and (9) (a).

Public Hearings

The Department held five public hearings on the proposed rules. The hearings were in Madison (June 22, 2000), Milwaukee (June 23, 2000), Eau Claire (June 27, 2000), Wausau (June 28, 2000) and Green Bay (June 29, 2000). There were approximately 200 people registered at the hearings; of which most presented testimony on either s. HFS 110 or HFS 112. Approximately 350 other persons submitted written comments on s. HFS 110 during the public comment period ending July 7, 2000. A list of persons who attended a hearing or submitted comments in writing after the hearings, and the Department's responses to the comments, are included in this document.

The Department made a number of modifications in the rules in response to public comments. Generally, the Department did all of the following:

- Modified some definitions to clarify intent.

- Modified language on a medical director's authority to encourage a remediation process for any EMT who had medical director authority removed for cause.
- Made several other clarifications as suggested by commenters.

Final Regulatory Flexibility Analysis

These rules apply to the following organizations: The Department of Health and Family Services, the Division of Hearings and Appeals in the Department of Administration, ambulance service providers and emergency medical technicians.

There are 14 ambulance service providers that may be "small businesses" as defined in s. 227.114 (1) (a), Stats. These rules implement new requirements, but any additional training costs are covered by the department and there should be no additional expenses for businesses.
