## CRITERIA FOR APPROVAL OF CURRICULUM FOR CARDIOPULMONARY RESUSCITATION AND PUBLIC ACCESS DEFIBRILLATION

Curriculum submitted for department approval to provide CPR and Public Access Defibrillation (PAD) training must meet the following criteria:

1. The curriculum covers the material necessary to properly provide CPR or Public Access Defibrillation. The curriculum should include:
  - List of any prerequisites necessary to take course (CPR training prior to AED).
  - Safety precautions when using the defibrillator.
  - Written course objectives.
  - Performance guidelines to measure competency.
  - Written and practical examinations.
2. The curriculum is consistent with other curriculums that have been approved so some degree of standardization is maintained. The curriculum should include:
  - Written protocol that follows the State defibrillation protocol.
  - Written scenarios.
  - Illustrated teaching materials.
  - A method to indicate successful course completion (card, etc.).
  - A method to maintain training records and lists of individuals that successfully complete training.
3. The curriculum clearly describes instructor qualifications and the method of evaluation for instructors. The curriculum should include:
  - An instructor manual.
  - Description of the method to document and maintain instructor competencies.
4. The curriculum clearly describes the ratio of students to instructors and the ratio is consistent with national standards (6:1 CPR, 10:1 AED maximum).
5. The curriculum clearly describes what research or model is the basis for development of the course.
6. The curriculum clearly describes how the course is evaluated to maintain quality assurance and promote continuous quality assurance.

Auxiliary information in making the decision would include:

1. Any formal recognition or endorsement by national or state organizations.
2. A research component that is part of continuous quality improvement.
3. Proof of insurance to cover training center for liability during training or for care provided after training.
