Dear Carol:

Thank you very much for your interest and efforts to make our school crossings safer. The draft legislation that you have developed will go a long way toward increasing that safety.

Under our current law, State Statute 346.57, enforcement in school zones is possible only when children are present. Our local judges have determined that this means that two or more children must be in a crossing zone before drivers have to slow down to 15 miles per hour.

In addition to child safety issues, the current law does not provide any consideration for the safety of our crossing guards. Our crossing guards risk their safety each time that they enter an intersection to stop traffic for children crossing. In addition to this, they also risk their lives as they have to cross the street to reposition themselves to wait for the next child to come. Adding language that includes crossing guards will go along way to making this most important job a lot safer.

As a final item, I feel that this legislative change will be less open to interpretation and with that, provide more uniformly applied enforcement across the state. This will make it easier for the motoring public to understand and far less ambiguous.

I want to thank you very much for your efforts on behalf of our crossing guards and hope that this legislative change is successful.

How do I know? Well, I'm a school crossing guard on Ninth Avenue and Minnesota Street and I've almost been hit five times last school year.

I'll be in the street with my stop sign high in the air, with traffic stopped to let children cross. Cars still come speeding down these parking lanes to get by the stopped traffic. I'm walking back to by corner and all of a sudden they see me and hit their brakes.

I've been fortunate that all my children are out of the cross walk and safely on the sidewalk.

School starts Aug. 29, and drivers beware. I'll be taking down your license plate number and turning you into the Oshkosh Police Department. You can be fined \$138.20 for disobeying a School Crossing Guard the first time and \$187.40 the second time.

Divers can also be fined \$273.50 for passng a vehicle stopped for pedestrians.

Please drive safely in all school zones and when you come down Ninth Avenue to Minnesota Street, I'll be there. You can't miss me, I'm dressed all in orange.
