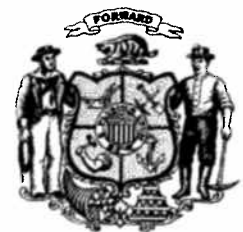

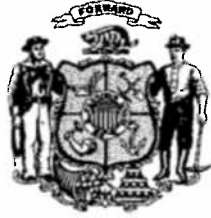

Clearinghouse Rule 03-090, relating to the acceptance of foreign degrees that have been determined to be equivalent to a degree from an accredited school in the United States. The Professional Counselor Section and the Marriage and Family Therapist Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board do not have an adequate means of evaluating applications from individuals who have received their education in foreign institutions of higher learning.

I. THE PROPOSED RULE:

The proposed rule, including the analysis and text, is attached.

II. REFERENCE TO APPLICABLE FORMS:

No new or revised forms are required by these rules.

III. FISCAL ESTIMATES:

There will be no additional cost to the Department of Regulation and Licensing to certify these applicant social workers than for current applicants with degrees from schools in the United States that are accredited by the Council.

IV. STATEMENT EXPLAINING NEED:

This rule was originally submitted to the Clearinghouse in October 2003. At that time only the Social Work Section requested a rule change. Since then the Professional Counselor Section and the Marriage and Family Therapist Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board have requested that sections of the rule address their applicants. All three sections receive numerous inquiries and applications from individuals who have received their education in foreign institutions of higher learning. The sections in the past have not had an adequate means of evaluation of the education of these applicants. Currently, accrediting organizations in each of the professions have instituted processes for evaluating whether foreign degrees are equivalent to degrees granted by domestic institutions of higher learning. The rules allow the sections to take advantage these means of evaluation to further serve the needs of the public. The rules also allow the sections to insure that applicants from foreign institutions have an adequate command of the English language.

V. NOTICE OF PUBLIC HEARING:

A public hearing was held on January 13, 2004. No comments were made either in favor or in opposition to the proposed rule either at the hearing or subsequently in writing.

VI. RESPONSE TO LEGISLATIVE COUNCIL STAFF RECOMMENDATIONS:

Comments 1. In response to the inquiry to explain the statutory authority for this rule proposal, the rule is a reasonable extension of accreditation authority of the Council on Social Work Education. The new rules simply allow the Council to determine the equivalency of foreign degree programs to domestic degree programs which have been accredited by the council.

Comment 2. a. and b. The recommendations have been adopted.

Comment 5. The recommendation has been adopted as practicable to indicate the rule is concerned with social work degrees.

PROPOSED ORDER

An order of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board to amend MPSW 3.01 (2), 3.05 (2), 3.07 (2), 3.09 (2), 11.01 (1) (b) and 16.01 (1) (a) 3., relating to the determination of the equivalency of a foreign degree to a degree from an institution accredited in the United States, and to require some candidates to demonstrate English proficiency.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes authorizing promulgation: ss. 15.085 (5) (b), 227.11 (2) and 457.03 (1), Stats.

Statutes interpreted: ss. 457.08, 457.10 and 457.13, Stats.

SECTIONS 1. to 4. Under current requirements, applicants for social worker certification or licensure must have earned a social work degree from a school accredited by the Council on Social Work Education. Applicants otherwise qualified are prevented from obtaining Wisconsin certification or licensure if the applicant obtained a degree in another country. The Council on Social Work Education has a process for determining equivalency of degrees, and in fairness to graduates of foreign schools, the Social Worker Section wishes to rely on that process for accepting equivalent degrees. These sections amend the rules to permit the Social Worker Section to accept from applicants for social worker certification or licensure a foreign degree determined by a national accrediting organization to be equivalent to a degree from an accredited school. The amendment would require candidates to demonstrate proficiency in English. These sections specify the new process and requirement.

SECTION 1. addresses the qualifications of applicants for the basic level social worker certification.

SECTION 2. addresses the qualifications for certification as an advanced practice social worker.

SECTION 3. addresses the qualifications for certification as an independent social worker.

SECTION 4. addresses qualifications for licensure as a clinical social worker.

SECTION 5. Under current requirements, licensure as a professional counselor requires that candidates be graduates of programs accredited by the Commission for Accreditation of Counseling (CACREP) and Related Educational Programs or the Council on Rehabilitation Education. The National Board of Certified Counselors provides a service to evaluate whether foreign degrees are equivalent to a degree program accredited by CACREP. The amendment would require candidates to demonstrate proficiency in English. This section specifies the new process and requirement.

SECTION 6. Under current requirements, licensure as a marriage and family therapist requires that candidates be graduates of programs accredited by the Commission on Accreditation for Marriage and Family Therapy Education (COAMFTE) of the American Association of Marriage and Family Therapy. This amendment permits an individual who is a graduate of a program from a foreign institution to seek licensure when an organization approved by the Marriage and Family Section determines that the program is equivalent to a program accredited by COAMFTE. The amendment would require candidates to demonstrate proficiency in English. This section specifies the new process and requirement.

TEXT OF RULE

SECTION 1. MPSW 3.01 (2) is amended to read:

MPSW 3.01 (2) Verification that the school or program which awarded the social work degree was accredited by, or a pre-accreditation program, of the ~~council on social work education~~ Council on Social Work Education (CSWE) at the time the applicant graduated from the program or school, or that a degree awarded by a foreign institution of higher learning has been determined by the CSWE to be equivalent to a program accredited by the CSWE. If the applicant's education was not received in English, the applicant must demonstrate proficiency in English by achieving a score of 550 (or 213 on the computer-based exam) or above on the test of English as a foreign language (TOEFL) or an equivalent score on an equivalent examination.

SECTION 2. MPSW 3.05 (2) is amended to read:

MPSW 3.05 (2) Verification that the school or program which awarded the social work degree was accredited by, or a pre-accreditation program, of the ~~council on social work education~~ Council on Social Work Education (CSWE) at the time the applicant graduated from the program or school, or that a degree awarded by a foreign institution of higher learning has been determined by the CSWE to be equivalent to a program accredited by the CSWE. If the applicant's education was not received in English, the applicant must demonstrate proficiency in English by achieving a score of 550 (or 213 on the computer-based exam) or above on the Test Of English as a Foreign Language (TOEFL) or an equivalent score on an equivalent examination.

SECTION 3. MPSW 3.07 (2) is amended to read:

MPSW 3.07 (2) Verification that the school or program which awarded the social work degree was accredited by, or a pre-accreditation program, of the ~~council on social work education~~ Council on Social Work Education (CSWE) at the time the applicant graduated from the program or school, or that a degree awarded by a foreign institution of higher learning has been determined by the CSWE to be equivalent to a program accredited by the CSWE. If the applicant's education was not received in English, the applicant must demonstrate proficiency in English by achieving a score of 550 (or 213 on the computer-based exam) or above on the Test Of English as a Foreign Language (TOEFL) or an equivalent score on an equivalent examination.

SECTION 4. MPSW 3.09 (2) is amended to read:

MPSW 3.09 (2) Verification that the school or program which awarded the social work degree was accredited by, or a pre-accreditation program, of the ~~council on social work education~~ Council on Social Work Education (CSWE) at the time the applicant graduated from the program or school, or that a degree awarded by a foreign institution of higher learning has been determined by the CSWE to be equivalent to a program accredited by the CSWE. If the applicant's education was not received in English, the applicant must demonstrate proficiency in English by achieving a score of 550 (or 213 on the computer-based exam) or above on the Test Of English as a Foreign Language (TOEFL) or an equivalent score on an equivalent examination.

SECTION 5. MPSW 11.01 (1) (b) is amended to read:

MPSW 11.01 (1) (b) Verification that the institution which awarded the degree was a regionally accredited college or university, or accredited by the commission for accreditation of counseling and related educational programs (CACREP), or the council on rehabilitation education at the time the applicant graduated from the school, or that a degree awarded by a foreign institution of higher learning has been determined by the National Board for Certified Counselors (NBCC) or by another organization approved by the section to be equivalent to a degree from a program accredited by CACREP. If the applicant's education was not received in English, the applicant must demonstrate proficiency in English by achieving a score of 550 (or 213 on the computer-based exam) or above on the Test Of English as a Foreign Language (TOEFL) or an equivalent score on an equivalent examination.

SECTION 6. MPSW 11.01 (1) (a) 3. is amended to read:

MPSW 16.01 (1) (a) 3. An applicant who has a master's or doctoral degree in marriage and family therapy from a program which was not accredited by the commission on accreditation for marriage and family therapy education (COAMFTE) of the American association for marriage and family therapy must submit satisfactory evidence of having completed education equivalent to a master's or doctoral degree in marriage and family therapy from a program accredited by the commission on accreditation for marriage and family therapy education of the American association for

marriage and family therapy, pursuant to s. MPSW 16.02, or that a degree awarded by a foreign institution of higher learning has been determined by an organization approved by the section to be equivalent to a degree from a program accredited by COAMFTE. If the applicant's education was not received in English, the applicant must demonstrate proficiency in English by achieving a score of 550 (or 213 on the computer-based exam) or above on the Test Of English as a Foreign Language (TOEFL) or an equivalent score on an equivalent examination.

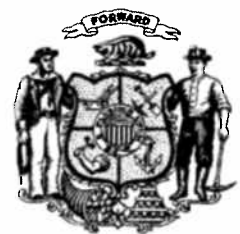

Comments

[NOTE: All citations to "Manual" in the comments below are to the Administrative Rules Procedures Manual, prepared by the Revisor of Statutes Bureau and the Legislative Council Staff, dated October 2002.]

1. Statutory Authority

Section 457.08 (1) (b), (2) (b), (3) (b) and (4) (b), Stats., require the social worker section of the board to grant a license or certificate to a person who, in addition to meeting other requirements, submits evidence of having one of the following: (1) a bachelor's or master's degree in social work from a program accredited by, or a preaccreditation program of, the Council on Social Work Education (CSWE); or (2) a doctorate degree in social work. The current rule reflects these two options while the proposed rule adds a third option -- a degree awarded by a foreign institution of higher learning that has been determined by the CSWE to be equivalent to a CSWE-accredited program. The board should explain the statutory authority for adding a third educational option when the statute lists only two options.

2. Form, Style and Placement in Administrative Code

a. The acronym CSWE should be defined either in a new s. MPSW 3.001 or in current s. MPSW 1.02. Parenthetical acronyms should be avoided in rules. [See s. 1.01 (6) and (8), Manual.]

b. Although there is a title "FISCAL ESTIMATE" following the rule, there is no text following the title. A fiscal estimate should be provided.
