HFS 163 is one piece of Wisconsin's efforts to eliminate childhood lead poisoning. It establishes a training and certification program for persons who identify or remove lead-based paint or lead-based paint hazards. The lead training and certification program is administered under the authorization of EPA and must comply with EPA lead-based paint regulations.

Effective March 1, 2002, a subchapter was added to HFS 163 that established procedures for the lead-free/lead-safe registry of properties created under 1999 Wisconsin Act 113.

Clearinghouse Rule 03019 revises HFS 163 to bring it into compliance with EPA regulations that establish what constitutes a lead-based paint hazard. People and organizations involved with the development of the lead-free/lead-safe registry were aware that this rule revision was coming and did not object. The primary impact of this revision is that properties with bare lead-contaminated soil must cover the bare soil with material such as grass or landscaping stone before the property will qualify for a lead-safe certificate.
