Assumptions Used in Arriving at Fiscal Estimate

This bill prohibits providing martial arts instruction to a minor for a fee without a license granted by the Department of Regulation and Licensing (DRL). Under the bill, DRL is required to grant a license to an applicant who pays a fee, if DRL determines that the applicant has not been convicted of certain disqualifying offenses specified in the bill, including certain violent crimes, crimes against children, and drug crimes.

This proposal would cost DRL \$52,530 to administer.

DRL estimates that it would need to screen, investigate and prosecute complaints of unlicensed practice requiring:

[all staff cost hourly amounts include fringe benefits at 40.64% of salary]

500 hours paralegal @ 25 hour 12,500

500 hours investigator @ 26 hour 13,000

500 hours prosecutor @ 53 hour 26,500

Hearing on 1 complaint of the above

10 hours Administrative law judge @ 53 hour 530

Revenue:

Martial arts instructors applying for licensure would be required to pay a biennial fee of \$53. DRL has no data to estimate how many applicants for licensure there would be each biennium.
