**2005 Assembly Bill 511**

**Assembly Substitute  
Amendment 1**

Under *current law*, second-degree sexual assault is a Class C felony, punishable by a fine not to exceed \$100,000 and a term of confinement in prison and extended supervision not to exceed 40 years, or both. Second-degree sexual assault includes, for example, having sexual contact or sexual intercourse with another person without the consent of that person by use of threat or force or violence or, as an employee of an adult family home, a community-based residential facility, an inpatient health care facility, or a state treatment center, having sexual contact or sexual intercourse with a person who is a patient or resident of the facility or center.

*Assembly Bill 511* provides that it is second-degree sexual assault to have sexual contact or sexual intercourse with an individual who is under the age of 18 and for whom the actor is a foster parent or to have sexual contact or sexual intercourse with a person who is under the age of 18 and who is placed in a shelter care facility, a group home, or a residential care center for children and youth, if the actor works or volunteers at the facility or is directly or indirectly responsible for managing it.

*Assembly Substitute Amendment 1* places the offense created by the bill in a new provision of the chapter of the statutes setting forth crimes against children (ch. 948, Stats.). In addition, under the substitute amendment, having sexual contact or sexual intercourse with a child if the actor is the child's stepparent is included in the crime of incest under s. 948.06, Stats. This offense is also a Class C felony.

**Legislative History**

The Assembly Committee on Children and Families offered Assembly Substitute Amendment 1 on September 8, 2005. Also on that date, the committee voted to recommend adoption of the substitute amendment on a vote of Ayes, 6; Noes, 0, and to recommend passage of the bill, as amended, on a vote of Ayes, 6; Noes, 0.

After discussing potential amendments to AB511 with the Legislative Reference Bureau, it was discovered that the drafters had made a mistake in the original version of the bill.

As written, AB511 would amend Chapter 940.225 of the state statutes to include sexual abuse of children placed in substitute (foster) care. As you know, Chapter 940.225 relates to general sexual assault. The Reference Bureau has since realized that Section 948.02, relating to sexual assault of a child, would be a more appropriate place to direct the new language of AB511.

Our intent under AB511 was to ensure that any individual who exploits his or her position of power over a child be prosecuted to the full extent of the law. District Attorneys across the state agreed that foster parents, and likewise step parents, should not receive a more lenient penalty than a teacher or camp counselor convicted of the same crime.

The Legislative Reference Bureau discovered that, under certain situations, prosecuting a foster or step parent under Chapter 940 could result in a lesser penalty than the same charges under Chapter 948. An example of this would be the "two strikes law" for sex offenders under Chapter 948. The "two strikes" formula would not be applicable if AB511 were implemented under Chapter 940.

To correct this error, LRB is drafting a substitute amendment that will be introduced during tomorrow's executive session. The amendment will address the mistake described above, redirecting AB511 to Chapter 948 of State Statutes. Due to the complex nature and extensive cross-referencing found in Chapter 948, the amendment will likely be significantly longer than the original version. The amendment will also cover both foster parents and step parents, as suggested by Representative Albers during the August committee hearing.

The Legislative Reference Bureau has prepared a summary of some of the more concerning oversights that will be addressed in the substitute amendment. I have attached a copy of their table for your review. I will also circulate a copy of the amendment as soon as it is available from LRB. Please feel free to contact my office should you have any questions or concerns. I appreciate your understanding as we work together to correct this oversight.
