Dear Senator Kanavas,

I am writing today to urge you to schedule a hearing and executive action on Senate Bill 373, which would create the crime of price gouging in the State Statutes.

As you know under current state law price gouging is not a crime. As a result we have little recourse when consumers are taken advantage of by those who would exploit natural or economic disasters for their own financial gain. This is a major hole in state law which needs to be addressed.

The vast majority of business owners are law-abiding, decent members of our communities. As such this bill is not aimed at them, but rather those who would take undue advantage of others at the retail or wholesale level. Those who would prey upon people in desperate times are beneath contempt but should not be above the law. Instead, there should be suitable penalties on the books that will both punish and deter this type of behavior.

Senate Bill 373 would provide that protection. This bill would give the Attorney General the power to prosecute these unscrupulous businesses that seek to profit on the misery of other by fining them up to \$10,000 for each violation.

I respectfully request that Senate Bill 373 be given a public hearing so we can take the necessary steps toward this much-needed updating of Wisconsin's consumer protection laws.
