City Arry: deam's lealing Fiscal Effect: No fiscal effect has been prepared for SB 329 **Questions:**

- Why can't Milwaukee already do this? Don't other cities around the state Madison, River Falls, Green Bay?
- All municipalities receive local road aids, meaning everyone in the state pays for at least a portion of every road in the state. Why then is it fair to prevent some people from parking, while allowing someone else to do so. In other words, why is it fair for the City of Milwaukee to prevent my constituent in Waukesha from parking around UW-Milwaukee, but not allow Waukesha to prevent a Milwaukee resident from parking around Carroll College or UW-Waukesha?
- The bill allows Milwaukee, around UW-Milwaukee to reserve 721 parking spots. on city streets for residents, their quests and commercial enterprises. While I assume residents can be given a sticker, how can a Milwaukee enforce the guests and commercial enterprise vehicles? Further, if residences can control who parks in front of their home under the "guests" provision, is there anything to prevent them from selling the spots?
- How will Milwaukee administer this. Who will determine who a resident is. Is it only a person immediately adjacent to where they are parking or homes around the corner, or homes a couple of blocks away. Can one resident park only 1 vehicle, or can they park 5 vehicles in the restricted areas?

Assembly Bill 240 (Rep. Zepnick and Sen. Darling)

Relating to: the immobilization, impoundment, and disposal of unregistered motor vehicles.

Summary: This bill changes the definition of "unregistered motor vehicle" so that it applies to any motor vehicle that is located upon a highway, and that is not displaying valid license plates, a temporary operation plate, or, for vehicles registered with DOT on a quarterly or consecutive monthly basis, other evidence of registration for the vehicle's current registration period or a registration period that expired the preceding month, rather than to a motor vehicle that is currently not registered and that reasonably appears to have been unregistered for at least 30 days. The bill eliminates the provision that specifies that a person may not be convicted of violating an ordinance or subject to immobilization or impoundment costs if, at the time of the offense, the vehicle was exempt from registration in this state or a complete registration application had already been submitted to DOT. Finally, the bill provides that parking enforcers who are employed by a municipality or county or the state may enforce such ordinances.

Fiscal Effect: A fiscal estimate prepared by the Department of Transportation indicates passage of the bill will have to state fiscal effect.)

Questions:

- Would AB 240 allow law enforcement to impound any vehicle the see parked on a roadway without a license plate or Temporary plate? Doesn't the 30 day grace period in current law help address circumstances where a plate may be stolen or fall off (blown off for temp plates) and the owner might not know?
- The bill deletes a current law provision which stipulates that a person couldn't be convicted of this ordinance (and be required to pay for impoundment costs on their vehicle) if they could show that registration had already been sent to the DOT. Why would we want to remove this protection for people who wrongly have their car impounded?
- The bill allows parking enforcers the ability to impound vehicles, whereas current law requires a law enforcement official? Do these individuals have any sort of training equivalent to what law enforcement must go through? If not, should we be granting the authority to seize property to someone that doesn't have any type of specialized training?

Dear Chairman Kedzie and Members of the Committee:

As the lead author of AB 240 I would like to thank you for holding a public hearing on this bill. This bill attempts to resolve the growing problem of unregistered and unlicensed motor vehicles that continue to park on city streets. The proliferation of unregistered and unlicensed vehicles on city streets leads to many problems, including: increased difficulty for law-abiding citizens to find on-street parking; stolen vehicles being sold to unsuspecting individuals; streets becoming used car lots where vehicles are sold by individuals who have no legal authority to do so; and public safety concerns that arise as a result of unregistered or unlicensed vehicles impeding the safe passage of emergency vehicles.

Under current law, an "unregistered motor vehicle" is defined as any motor vehicle located upon a highway that is currently not registered and that reasonably appears to have been unregistered for at least 30 days. Unfortunately, the city of Milwaukee's current policy is to not tow unregistered vehicles because of the difficulty of proving the criteria or that it "reasonably appears" to be abandoned. This bill will make it easier for parking enforcement officials to cite and tow vehicles that are not displaying valid license plates or a temporary operation plates, or have the VIN Number obscured.

Each year the Milwaukee Department of Public Works Parking Enforcement Division receives a significant number of complaints of unregistered vehicles that are illegally parked. In many instances the vehicle identification number is covered, the vehicle does not have a license plate, and the parking enforcement officer cannot determine how long the vehicle has been parked in its current location. Without the necessary identifying information available it is impossible to remove the vehicle in this circumstance.

This bill will benefit those citizens who do abide by the laws and register their vehicles, and it will give parking enforcement officials a better tool for addressing the proliferation of unregistered vehicles on city streets.

I would like to thank Chairman Kedzie and the members of the Natural Resources and Transportation Committee again for having a public hearing on AB 240, and I respectfully request that the committee give its unanimous support to this important legislation.

Dear Chairman Kedzie,

We are writing to request that the Senate Committee on Natural Resources and Transportation add Assembly Bill 240, relating to the immobilization, impoundment, and disposal of unregistered motor vehicles, to the committee's upcoming public hearing on May 26, 2005.

We believe the passage of AB 240 is important for Milwaukee and other municipalities to curb the problems related to the proliferation of unregistered and unlicensed vehicles on city streets. Many of the problems include: increased difficulty for law-abiding citizens to find on-street parking; stolen vehicles being sold to unsuspecting individuals; streets becoming used car lots where vehicles are sold by individuals who have no legal authority to do so; and, public safety concerns that arise as a result of unregistered or unlicensed vehicles impeding the safe passage of emergency vehicles.

Under current law, if a vehicle's vehicle identification number is covered, Milwaukee has difficulty ticketing and towing the vehicle. This bill will allow a car to be ticketed and towed after a 31-day period if it is not displaying valid license plates, a temporary operation plate, or other evidence of registration, even if the vehicle identification number has been covered.

AB 240 will put an end to the abandoned vehicles littering the streets and the illegal used car lots around Milwaukee. The bill was passed unanimously out of the Assembly Committee on Transportation and passed the Assembly May 10, 2005.

We respectfully request that you add this bill to the committee's public hearing scheduled for May 26, 2005.

Thank you for your concern for the citizens of Wisconsin and the fire and law enforcement officials of Milwaukee. We look forward to passing this bill into law so that Milwaukee can begin to address this growing problem.

Dear Senator Kedzie,

We are writing to request that you give Assembly Bill 240 a public hearing before the Senate Committee on Natural Resources and Transportation at your next committee meeting. We understand you have a backlog in this committee and we would appreciate a commitment to this bill once you are caught up after this October 20, 2005 meeting. This legislation is a bipartisan effort to give cities and parking officials a better tool for addressing the proliferation of unregistered vehicles on city streets.

Under current law, if a vehicle's vehicle identification number is covered, Milwaukee has difficulty ticketing and towing the vehicle. This bill will allow a car to be ticketed and towed after a 31-day period if it is not displaying valid license plates, a temporary operation plate, or other evidence of registration, even if the vehicle identification number has been covered.

AB 240 will put an end to the abandoned vehicles littering the streets and the illegal used car lots around Milwaukee. The bill was passed unanimously out of the Assembly Committee on Transportation.

The legislation has passed the Assembly with broad support, passing 97-1; and it was previously passed in the Assembly on a voice vote during the 2003-2005 session.
