Assembly Bill 286, relating to bows used for hunting

AB 286 is scheduled for Assembly floor action on September 20, 2005, and I am wiriting today to inidicate the DNR's support for AB 286.

This bill will eliminate the 100-pound draw weight minimum for crossbow bows, when the crossbow is simply conventional compound bow that are equipped with a device that holds the bow at full draw. Under current law, crossbows may only be used for hunting by:

- 1. Persons with certain disabilities,
- 2. Persons who are visually handicapped, and
- 3. Residents who are age 65 or older.

This bill does not change or expand restrictions on who may use a crossbow or what is considered a crossbow. A crossbow is defined as any device using a bow which, once drawn, is held solely by means other than the effort of the person firing it. If a hunter attaches a device to an otherwise legal compound bow that holds the bow at full draw (a device known as a draw-loc), that compound bow is then considered a crossbow.

For a crossbow to be used in hunting however, it must have a minimum draw weight of 100 pounds. Most compound bows do not have draw weights that meet or exceed 100 pounds. Disabled Hunters or residents who are age 65 or older that already own a compound bow, can not legally use their compound bow if they attach a full draw "draw-loc" device to it. These hunters have requested this change to allow them to use bows they already own.

Unfortunately, neither Delmer Liebe, or I are able to attend the hearing this morning on AB 286. I do, however, want to thank you for bringing the bill along this far, this quickly.

Up until a few years ago, Delmer was bow hunting with the use of a full draw bow lock. I'm sure that other seniors were using them as well. Then, Chief Warden Stark wrote a memorandum which stated that compound bows with full draw bow locks satisfied the definition of a crossbow. This, in itself was not a problem. Because of his age, Delmer was already qualified to use a crossbow. However, to be legal in Wisconsin, crossbows must have a minimum draw weight of 100 pounds. If Delmer were capable of drawing a 100 pound bow, he would probably not need a draw lock. A warden who knew that Delmer used a full draw lock, advised him that he could no longer legally use it.

Delmer spent two years working through the Conservation Congress process to make his bow lock legal again. When he was about to jump through the last hoop, it was decided that new language in the administrative code would not be adequate to bring about the change. A statutory change is really needed.

This is really a human interest bill. The number of hunters who opted to use the locks, when they were considered legal, was few. Some who could use crossbows will elect to use the locks instead. Only those who can legally use a crossbow will be allowed to use the locks. The locks will allow people, like Delmer, to continue to bow hunt in a way which is very similar to the hunting experience which they have enjoyed for their entire lives.

Hopefully, AB 286 will become law before this fall. Because we are dealing primarily with seniors, every season is important.

Thank you again for moving the bill along. It was on the Department of Natural Resources list of desired legislation for the 2005 legislative year. With the Department, and the Conservation Congress on board, and with you continued efforts, we hope to see Delmer's proposal become law.
