Dear Chair Brown and Committee Members:

I regret that I am unable to attend today's hearing on Senate Bill 399 (SB 399), but would like to extend my appreciation for your holding a public hearing and for allowing me to provide written testimony in strong support of this legislation.

SB 399 would create a new "Class D" alcohol beverage license classification to allow the sale of unopened bottles of wine for consumption off the premises where it is sold. Under current law, a business must hold a "Class A" license, which authorizes the sale of both liquor and wine, in order to sell bottles of wine off-sale.

The suggestion for an additional license classification was made by a grocer and small business owners in my district. As the demand for fine wines increases, some businesses might like to offer wine for off-sale, but have no interest in selling liquor. In other instances, businesses have encountered challenges in obtaining "Class A" licenses in municipalities that are seeking to limit the number of such licenses issued. A new "Class D" license would provide another option to small businesses and grocers that are seeking simply to sell bottles of wine off-sale.

SB 399 would also provide flexibility to municipalities that would like to limit the number of "Class A" licenses in their communities. Allowing municipalities to issue "Class D" licenses to niche businesses, such as wine shops and gift stores, would allow municipalities to encourage small business growth while assigning "Class A" licenses to liquor stores.

Thank you again for holding a public hearing on SB 399 and I urge your support of this legislation.
