The Honorable, The Legislature:

As required by Article V, Section 6 of the Wisconsin Constitution, I am submitting the annual Executive Clemency Report to the Legislature, covering those clemency cases upon which final dispositions were rendered for applicants during the 2010 calendar year. Below are the one hundred and seventy seven applicants who received a pardon in 2010:

Donald Blank (date of birth March 5, 1951), convicted on September 20, 1971, of two counts of Sale of Dangerous Drug (Marijuana), was sentenced to eighteen months in jail (stayed) and eighteen months of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Ball was granted a pardon on February 11, 2010, based on his positive adjustment, extensive personal growth and development, lack of other criminal justice system contacts, the length of time since the crime, and the non–violent nature of the crime.

Angela Byrd (date of birth June 19, 1963), convicted on August 7, 1991, of Failure to Report Receipt of Income and Food Stamp Fraud, was sentenced to five years of probation, 100 hours of community service, and restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Ms. Byrd was granted a pardon on February 11, 2010, based on her extensive personal growth and development, no previous or subsequent criminal justice system contacts, low risk of reoffending, the non–violent nature of the offenses, the length of time since the offenses, and her documented substantial need.

Bruce Conard (date of birth August 26, 1960), convicted on November 14, 1983, of Delivery of a Controlled Substance (THC), was sentenced to forty–five days in jail and two years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Conard was granted a pardon on February 11, 2010, based on Mr. Conard's positive adjustment, lack of other criminal justice system contacts,

community achievements, the length of time since the crime and valid employment concerns.

Chris Falkowski (date of birth December 28, 1973), convicted on October 17, 1994, of Burglary, was sentenced to three months of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Falkowski was granted a pardon on February 11, 2010, based on his extensive personal growth and development by furthering his education, his substantial need for employment, no prior or subsequent criminal justice system contacts and the length of time since the offense.

Paul Fidlin (date of birth April 15, 1981), convicted on October 7, 1999, of Knowingly Fleeing/Eluding an Officer, was sentenced to two years in prison (stayed), nine months in jail with Huber privileges, three years of probation, and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–1. Following the Board's recommendation, Mr. Fidlin was granted a pardon on February 11, 2010, based on his extensive personal growth and development by obtaining his Bachelor's Degree in Social Work, his significant commitment to public service, positive adjustment, personal growth and development, and community achievements.

Colin Hirthe (date of birth June 27, 1963), convicted on or about February 16, 1987, of two counts of Burglary, was sentenced to thirty days in jail, three years of probation, and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Hirthe was granted a pardon on February 11, 2010, based on his positive adjustment, person growth and development, community achievements, lack of other criminal justice system contacts, and the length of time since the crime.

Gerald Knies (date of birth October 13, 1939), convicted on February 8, 1958, of two counts of Burglary, was sentenced to one year in prison, one year of probation, and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Knies was granted a pardon on February 11, 2010, based on his positive adjustment, lack of other criminal justice system contacts, the length of time since the crime, and the recommendation of the district attorney.

Cherise McKinney (date of birth May 2, 1969), convicted on September 17, 1992, of Possession of a Controlled Substance (Cocaine Base) with Intent to Deliver and Obstructing an Officer (False Information), was sentenced to

one year in jail, three years of probation, and ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Ms. McKinney was granted a pardon on February 11, 2010, based on her positive adjustment, personal growth and development, the non–violent nature of the crime, and her service to her community as a Pastor.

Ebony Morrow (date of birth August 26, 1976), convicted on August 5, 2002, of Uttering, was sentenced to six months in jail and eighteen months of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Ms. Morrow was granted a pardon on February 11, 2010, based on her positive adjustment, valid job concerns, substantial need, and the non–violent nature of the crime.

Amanda Pennington (date of birth June 21, 1964), convicted on April 9, 1992, of Failure to Report Receipt of Income, Food Stamp Fraud, and Theft of Moveable Property, was sentenced six years in prison, six years of probation, and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Ms. Pennington was granted a pardon on February 11, 2010, based on her positive adjustment, extensive personal growth and development, lack of other criminal justice system contacts, and the non–violent nature of the crime.

Karen Potnek (date of birth November 17, 1969), convicted on April 23, 1993, of Theft by Fraud, was sentenced to two years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Ms. Potnek was granted a pardon on February 11, 2010, based on her positive adjustment, extensive personal growth and development, lack of prior and subsequent criminal justice system contacts, the non–violent nature of the crime, and a low risk of reoffending.

Jeffrey Schneider (date of birth December 31, 1972), convicted on October 28, 1992, of Conspire to Possess with Intent to Deliver THC, was sentenced to two months in jail with Huber privileges, thirty months of probation, and ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Schneider was granted a pardon on February 11, 2010, based on his positive adjustment, extensive personal growth and development, valid job concerns, lack of other criminal justice system contacts, the length of time since the crime, and the non–violent nature of the crime.

Michael Schwalbach (date of birth March 18, 1954), convicted on December 6, 1973, of Armed and Masked Robbery (PTAC), was sentenced to ten years in prison. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Schwalbach was granted a pardon on February 11, 2010, based on his positive adjustment, extensive personal growth and development, lack of previous and subsequent criminal justice system contacts, then length of time since the crime, and community achievements.

Darryl Sims (date of birth July 23, 1961), convicted on May 8, 1997, of five counts of Issuing Worthless Checks (>\$1000), was sentenced to four months in jail with Huber

privileges, ten years of probation, 200 hours of community service, and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Sims was granted a pardon on February 11, 2010, based on his positive adjustment, extensive personal growth and development, the non–violent nature of the crime, the recommendation of the judge, and community support.

George Vaughn (date of birth September 11, 1941), convicted on January 11, 1965, of Burglary, was sentenced to three years in prison (stayed), three years of probation, and restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Vaughn was granted a pardon on February 11, 2010 based the length of time since the offense, his honesty with the Board, his young age at the time of the crime, his positive adjustment, and his extensive personal growth and development.

Darrel Wilber (date of birth September 6, 1950), convicted on October 25, 1968, of three counts of Burglary, two counts of Petty Threft, and one count of Grand Theft, was sentenced to thirty–six months in prison. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Mr. Wilber was granted a pardon on February 11, 2010, based on his extensive personal growth and development, a lack of prior or subsequent criminal justice system contacts, the length of time since the offenses, a low risk of reoffending, and his positive adjustment.

Nicholas Rathmann (date of birth May 24, 1980), convicted on May 29, 1998, of two counts of Burglary ? Building or Dwelling and two counts of Burglary ? Building or Dwelling (PTAC), was sentenced to eight months in jail with Huber release, five years of probation, and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Mr. Rathmann was granted a pardon on April 5, 2010, based on his positive adjustment, personal growth and development, lack of other criminal justice system contacts, the non–violent nature of the offense, the length of time since and young age at the time, valid job concerns, and recommendation of various members in his community.

Stewart Garson (date of birth February 14, 1955), convicted on June 11, 1973, of Burglary (PTAC), was sentenced to two years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Mr. Garson was granted a pardon on April 5, 2010, based on his extensive personal growth and development through furthering his education, positive adjustment, the length of time since the crime, and low risk of re–offending.

Keith Best (date of birth June 28, 1953), convicted on May 2, 1973, of Burglary (PTAC), was sentenced to three years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Mr. Best was granted a pardon on April 5, 2010, based on his positive adjustment, extensive personal growth and development, no subsequent criminal justice system contacts, the length of time since the crime and young age at the time, low risk of re–offending, and achievements in his community.

Steven Huebner (date of birth October 3, 1963), convicted on August 24, 1981, of two counts of Burglary, was sentenced to 18 months in prison. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Huebner was granted a pardon on April 5, 2010, based on his positive adjustment, the length of time since, and recommendation from various members of in his community.

Daniel Brede (date of birth June 1, 1960), convicted on February 6, 1981, of Burglary (PTAC), was sentenced to three years in prison (stayed), 89 days in jail with Huber privileges, and three years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–2. Following the Board's recommendation, Mr. Brede was granted a pardon on April 5, 2010, based on his positive adjustment, personal growth and development, and the length of time since the offense.

Todd Jarvey (date of birth November 12, 1963), convicted on December 9, 1985, of Delivery of a Controlled Substance (Cocaine), was sentenced to two years probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–2. Following the Board's recommendation, Mr. Jarvey was granted a pardon on April 5, 2010, based on his positive adjustment, personal growth and development, lack of prior or subsequent criminal justice system contacts, and the length of time since the crime.

Michael Schuchardt (date of birth November 21, 1959), convicted on May 24, 1993, of Theft by Contractor, was sentenced to ten years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 4–3. Following the Board's recommendation, Mr. Schuchardt was granted a pardon on April 5, 2010, based on his positive adjustment, personal growth and development, the full payment of his substantial order for restitution in a timely manner, and his early discharge from probation.

Gregory Frazier (date of birth March 17, 1969), convicted on January 31, 1992, of Delivery of Controlled Substances (PTAC), was sentenced to four months in jail (stayed 60 days), three years of probation, and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 4–3. Following the Board's recommendation, Mr. Frazier was granted a pardon on April 5, 2010, based on his positive adjustment, lack of subsequent criminal justice system contacts, the non-violent nature of the crime, the length of the time since the offense, and low risk of reoffending.

Jayson Schafer (date of birth June 26, 1978), convicted on April 3, 1997, of four counts of Burglary (PTAC), was sentenced to six months in jail (count one), one month jail (concurrent), four years in prison (stayed), three years probation, and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 4–3. Following the Board's recommendation, Mr. Schafer was granted a pardon on April 5, 2010, based on his positive adjustment, lack of other criminal justice system contacts, the non-violent nature of the crime, and length of time since.

Ronald Crass (date of birth May 15, 1940), convicted on April 23, 1958, of Breaking and Entering with Intent to Commit

Larceny and Theft, was sentenced to eighteen months in prison. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 4–3. Following the Board's recommendation, Mr. Crass was granted a pardon on April 5, 2010, based on the length of time since the offense and his young age at the time of the crime.

David Aderman (date of birth November 14, 1955), convicted on August 26, 1976, of Causing Bodily Harm to a Peace Officer, was sentenced to eighteen months in prison (stayed), six months jail, and two years probation. The Governor's Pardon Advisory Board was split by a vote of 3–3 on its recommendation. Mr. Hughes was granted a pardon on April 5, 2010, based on the lack of subsequent criminal justice system contacts, the support of the Assistant District Attorney and victim, and the length of time since the offense.

Daniel Stebnitz (date of birth August 30, 1957), convicted on March 3, 1981, of six counts of Forgery, was sentenced to five years in prison (stayed), five years of probation, and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Stebnitz was granted a pardon on April 5, 2010, based his extensive personal growth and development, positive adjustment, the non-violent nature of the offense, the length of time since the offense, a lack or prior and subsequent criminal justice system contacts, and the recommendation from both the district attorney and judge.

Michael Butz (date of birth March 28, 1958), convicted on December 7, 1984, of Forgery, was sentenced to two years of probation, and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Butz was granted a pardon on April 5, 2010, based on his positive adjustment, personal growth and development, no subsequent criminal justice system contacts, and the non-violent nature of the crime.

Darek Johnson (date of birth May 24, 1971), convicted on March 17, 1998, of four counts of Felony Non Support, was sentenced to six months in jail, five years of probation, and ordered to pay the outstanding child support. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Johnson was granted a pardon on April 5, 2010, based on his positive adjustment, extensive personal growth and development, the non-violent nature of the crime, the length of time since the offense, and the recommendation from various members in his community.

Tammy Farnsworth (date of birth December 24, 1966), convicted on July 19, 1999, of Food Stamp Fraud, was sentenced to two years probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Ms. Farnsworth was granted a pardon on April 5, 2010, based on her positive adjustment, the non-violent nature of the crime, valid job concerns, and recommendation from the district attorney.

Dana Zimmerman (date of birth August 31, 1979), convicted on February 12, 2002, of Disorderly Conduct, was ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Zimmerman was granted a pardon on April 5, 2010, based on his positive adjustment,

extensive personal growth and development, no subsequent or prior criminal justice system contacts, the non-violent nature of the offense, community achievements, and recommendation from various members of his community.

Derrick James (date of birth April 7, 1980), convicted on August 21, 1998, of Possession with Intent to Deliver (Cocaine), was sentenced to thirty months in prison and ordered to pay a \$500 fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7-0. Following the Board's recommendation, Mr. James was granted a pardon on April 5, 2010, based on his positive adjustment, lack previous and subsequent criminal justice system contacts, the length of time since the crime, and extensive personal growth and development.

David Brueggeman (date of birth July 18, 1956), convicted on February 8, 1985, of Delivery of a Controlled Substance and Possession with Intent to Deliver, was sentenced to ninety days in jail. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7-0. Following the Board's recommendation, Mr. Brueggeman was granted a pardon on April 5, 2010, based on his extensive personal growth and development, lack of other criminal justice system contacts, the non-violent nature of the crime, recommendation from various members in his community, the recommendation from the district attorney, and no objection from the judge.

Robert James Clark (date of birth December 17, 1951), convicted on March 27, 1972, of False Wisconsin Identification Card and Forgery, was sentenced to one year of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7-0. Following the Board's recommendation, Mr. Clark was granted a pardon on May 7, 2010, based on his positive adjustment, extensive personal growth and development, the non-violent nature of the offense, the length of time since the crime, and his young age at the time of the crime.

John Hecker, (date of birth December 31, 1960) convicted on January 20, 1981, of Criminal Damage to Property (PTAC), and sentenced to one year of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7-0. Following the Board's recommendation, Mr. Hecker was granted a pardon on May 7, 2010, based on his positive adjustment, lack of other criminal justice system contacts, his low risk of reoffending, and the length of time since the crime.

Christopher L. Johnson (date of birth April 24, 1972), convicted on April 21, 1992, of Burglary, was sentenced to three years of probation, six months in jail, and community service. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7-0. Following the Board's recommendation, Mr. Johnson was granted a pardon on May 7, 2010, based on his positive adjustment, lack of prior or subsequent criminal justice system contacts, the length of time since the crime, and the recommendation of the judge.

Derrick Loyde (date of birth January 6, 1974), convicted on February 28, 1994, of Delivery of Controlled Substance—Cocaine (PTAC) and Possession with Intent to Deliver Controlled Substance—Cocaine (PTAC), and sentenced to two years in prison, each count (concurrent); and on April 25, 1995, of Possession with Intent to Deliver Controlled Substance

Cocaine—Second or Subsequent Offense and sentenced to eight years in prison. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7-0. Following the Board's recommendation, Mr. Loyde was granted a pardon on May 7, 2010, based on his positive adjustment, personal growth and development, community achievements, military service, and valid job concerns.

David Maier (date of birth September 19, 1979), convicted on July 3, 2001, of Possession of Heroin, was sentenced to three years of probation and six months license suspension. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7-0. Following the Board's recommendation, Mr. Maier was granted a pardon on May 7, 2010, based on his positive adjustment, extensive personal growth and development, lack of prior or subsequent criminal justice system contacts, and the non-violent nature of the crime.

Kevin O'Leary (date of birth June 23, 1958), convicted on December 16, 1980, of Delivery of a Controlled Substance, was sentenced to three years of probation and four months in jail. The Governor's Pardon Advisory Board was split by a vote of 3-3 on its recommendation. Mr. O'Leary was granted a pardon on May 7, 2010, based on his positive adjustment, extensive personal growth, the support of the district attorney, the length of time since the offense, the non-violent nature of the offense, and the low risk of reoffending.

Paul Powell (date of birth November 9, 1970), convicted on July 12, 1993, of Possession of a Controlled Substance, was sentenced to ninety days HOC and eighteen months of probation; convicted on December 4, 1996, of Possession with Intent to Deliver a Controlled Substance—THC (PTAC) and sentenced to thirty months of probation; and convicted on September 21, 1998, of Possession of THC (Second or Subsequent Offense) and sentenced to eight months in jail, six months license suspension, and ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7-0. Following the Board's recommendation, Mr. Powell was granted a pardon on May 7, 2010, based on his positive adjustment, extensive personal growth and development, valid job concerns, and support from his community.

Gavin Robinson (date of birth November 13, 1963), convicted on January 12, 1993, of Possession with Intent (Cocaine) and Possession of a Controlled Substance, was sentenced to three years of probation, each count (concurrent) and ten months HOC. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7-0. Following the Board's recommendation, Mr. Robinson was granted a pardon on May 7, 2010, based on his positive adjustment, extensive personal growth and development, no prior or subsequent criminal justice contacts, and the recommendation of the judge.

Frederica Renner (date of birth November 14, 1963), convicted on February 20, 1996, of Failure to Report Receipt of Income and Food Stamp Fraud, was sentenced to five years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7-0. Following the Board's recommendation, Ms. Renner was granted a pardon on May 7, 2010, based on her positive adjustment, extensive personal growth and development in furthering her education, a lack of prior or

subsequent criminal justice system contacts, the non-violent nature of the crime, valid job concerns, and the recommendation of the judge.

Roland Rybarczyk (date of birth October 24, 1945), convicted of Theft of an Automobile, was sentenced to two years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7-0. Following the Board's recommendation, Mr. Rybarczyk was granted a pardon on May 7, 2010, based on his positive adjustment, lack of prior or subsequent criminal justice system contacts, the non-violent nature and length of time since the crime, and no objection from the district attorney.

Penny Treanor (date of birth July 10, 1970), convicted on February 9, 1998, of Perjury Before Court, was sentenced to twenty-six days in jail. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 4-2. Following the Board's recommendation, Ms. Treanor was granted a pardon on May 7, 2010, based on a lack of prior or subsequent criminal justice system contacts, the non-violent nature of the crime, her low-risk of reoffending, and the recommendations of the judge and district attorney.

Matthew Umentum (date of birth August 19, 1976), convicted on February 23, 1995, of Delivery of THC, was ordered to pay restitution and a fine. The Governor's Pardon Advisory Board was split by a vote of 3-3 on its recommendation to grant a pardon. Mr. Umentum was granted a pardon on May 7, 2010, based on his extensive personal growth and development, positive adjustment, and the non-violent nature of the offense.

James Weddig (date of birth August 3, 1969), convicted on April 6, 1989, of Delivery of a Controlled Substance, was sentenced to two years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6-0. Following the Board's recommendation, Mr. Weddig was granted a pardon on May 7, 2010 based on a lack of other criminal justice system contacts, his young age at the time of the offense, the non-violent nature of the crime, his extensive personal growth and development, positive adjustment, and valid job concerns.

Kevin Wheeler (date of birth December 15, 1962), convicted on June 29, 1981, of Operating Without Owner's Consent, was sentenced to three years of probation, ninety-one days in jail, and one year license suspension. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7-0. Following the Board's recommendation, Mr. Wheeler was granted a pardon on May 7, 2010, based on his positive adjustment, extensive personal growth and development, the length of time since the crime, valid job concerns, and the recommendation from the judge.

Victor Misurelli (date of birth May 2, 1952), convicted on November 2, 1989, of two counts of Delivery of Cocaine, was sentenced to four years of probation for each count to run consecutive, and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6-0. Following the Board's recommendation, Mr. Misurelli was granted a pardon on August 9, 2010, based on his positive adjustment, extensive personal growth and development, the length of time since the conviction, a lack of previous and subsequent criminal justice system contacts,

community achievements, and recommendations from the district attorney, judge, and various members of the community.

Timothy Jackson (date of birth January 26, 1977), convicted on October 27, 1997, of Possession with Intent to Deliver Cocaine ($\leq 5g$), was sentenced to two years in prison and license suspension for six months. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5-1. Following the Board's recommendation, Mr. Jackson was granted a pardon on August 9, 2010, based on his positive adjustment, extensive personal growth and development shown by furthering his education, a lack of previous and subsequent criminal justice system contacts, valid job concerns, substantial need, and the recommendation of the district attorney.

Sean Lucey (date of birth May 3, 1974), convicted on June 24, 1993, of Burglary, was sentenced to ninety days in jail, two years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5-1. Following the Board's recommendation, Mr. Lucey was granted a pardon on August 9, 2010, based on the length of time since the crime, valid job concerns, substantial need, his low risk of re-offending, and his young age at the time of the offense.

Maria Ruskiewicz, (date of birth November 30, 1978), convicted on June 9, 1997, of Possession of THC with Intent to Deliver, was sentenced to three years of probation and license suspension for six months. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6-0. Following the Board's recommendation, Ms. Ruskiewicz was granted a pardon on August 9, 2010, based on her positive adjustment, the recommendation from the district attorney, and achievements in her community.

Jonathan Stier (date of birth December 6, 1977), convicted on July 1, 1998, of Possession with Intent- THC (PTAC), was sentenced to forty-two months in prison; and convicted of Maintaining a Drug Trafficking Place, and sentenced to twelve months in prison to run concurrent to count 1. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6-0. Following the Board's recommendation, Mr. Stier was granted a pardon on August 9, 2010, based on his positive adjustment, extensive personal growth and development, a lack of other criminal justice system contacts, the non-violent nature of the crime, the length of time since the offense, valid job concerns and substantial need, achievements in his community, a low risk of re-offending, and the recommendations from the judge, district attorney, and various members of his community.

John Chitwood (date of birth May 30, 1969), convicted on January 12, 1990, of Delivery of Cocaine, was sentenced to an indeterminate term of not more than five years in prison and ordered to pay restitution; convicted on January 22, 1990 of Delivery of a Controlled Substance and sentenced to two years in prison (concurrent to La Crosse County sentence) and ordered to pay restitution; and convicted on February 15, 1990 of a Controlled Substance (PTAC), and sentenced to three years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6-0. Mr. Chitwood was granted a pardon on August 9, 2010, based on his positive adjustment, extensive personal growth and development, the length of time since the offense,

his young age at the time of offense, and support from both the judge and district attorney.

Loretta Zetting (date of birth May 31, 1979), convicted on June 3, 1999, of Theft—Moveable Property > \$1000–\$2500 (PTAC), was sentenced to thirty months of probation and ordered to pay restitution. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Ms. Zetting was granted a pardon on August 9, 2010, based on her positive adjustment, extensive personal growth and development, lack previous and subsequent criminal justice system contacts, the non–violent nature of the crime, valid job concerns, and her low risk of re–offending.

Terry Dunwald (date of birth October 14, 1971), convicted on June 25, 1990, of Theft of Moveable Property, was sentenced to three years of probation. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Mr. Dunwald was granted a pardon on August 9, 2010, based on his positive adjustment, personal growth and development through furthering his education, the non–violent nature of the crime, his young age at the time of the crime, and the recommendations of the judge and various members in his community.

Matthew Hedden (date of birth April 14, 1975), convicted on March 20, 1995, of Burglary (PTAC), was sentenced to thirty days in jail, two years of probation, and ordered to pay restitution. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Mr. Hedden was granted a pardon on August 9, 2010, based on his positive adjustment, the length of time since the offense, a lack of previous and subsequent criminal justice system contacts, and no objection from the district attorney.

Deborah Mejchar (date of birth September 14, 1953), convicted on March 1, 1995, of one count of Possession with Intent to Manufacture or Deliver a Controlled Substance—Schedule I (PTAC) (Second or Subsequent Offense), was sentenced to ten years in prison; one count of Possession with Intent to Manufacture or Deliver a Controlled Substance—Schedule II (PTAC) (Second or Subsequent Offense), and sentenced to ten years in prison (consecutive to count 1); one count of Possession with Intent to Manufacture or Deliver a Controlled Substance—Schedule II (PTAC) (Second or Subsequent Offense), and sentenced to eight years of probation (consecutive to counts 1 and 2); and of Maintaining a Drug Trafficking Place (PTAC) (Habitual Criminality), and sentenced to three years of probation (concurrent to count 3, consecutive to counts 1 and 2), and ordered to pay restitution. The Governor’s Pardon Advisory Board was split by a vote of 3–3 on its recommendation to grant a pardon. Ms. Mejchar was granted a pardon on August 9, 2010, based on her positive adjustment, extensive personal growth and development, the non–violent nature of the offense, achievements in her community, and the support from various members of her community.

Tina Biskupski (date of birth March 7, 1975), convicted on April 21, 1997, of Forgery—Uttering, was sentenced to three years of probation; and convicted on March 3, 1999, of Maintaining Drug Trafficking Place (PTAC), was sentenced to two years of probation and six months of license suspension. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 4–2. Following the Board’s recommendation, Ms. Biskupski was granted a pardon on

August 9, 2010, based on her positive adjustment, extensive personal growth and development, and the non–violent nature of the offense.

Derrick Hodges (date of birth August 21, 1974), convicted on December 8, 1995, of 2nd Degree Sexual Assault of a Child, was sentenced to six months in jail and ordered to pay child support. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board’s recommendation, Mr. Hodges was granted a pardon on August 9, 2010, based on his positive adjustment, extensive personal growth and development, and community achievements through volunteering and youth counseling.

Peter Jon Hoefler (date of birth December 29, 1958), convicted on April 14, 1980, of Burglary and Entry into a Locked Vehicle, was sentenced to three years of probation. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board’s recommendation, Mr. Hoefler was granted a pardon on August 9, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, the length of time since the offense, and the recommendations from both the district attorney and judge.

William Donis (date of birth March 10, 1955), convicted on February 5, 1974, of Burglary and Theft, was sentenced to ninety days in jail with Huber and two years of probation. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board’s recommendation, Mr. Donis was granted a pardon on August 9, 2010, based on his positive adjustment, extensive personal growth and development, the non–violent nature of the offense, the length of time since the crime, a lack of other criminal justice system contacts, and his low risk of reoffending.

Sonji Turner (date of birth August 14, 1965), convicted on February 8, 1990, of Failure to Report Changes in Circumstances, was sentenced to five years of probation and ordered to pay restitution. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board’s recommendation, Ms. Turner was granted a pardon on August 9, 2010, based on her positive adjustment, extensive personal growth and development, lack of previous and subsequent criminal justice system contacts, the length of time since the crime, and her low risk of re–offending.

Darin Noyes (date of birth July 3, 1970), convicted on January 16, 1991, of Delivery of Cocaine, was sentenced to sixty days in jail with Huber privileges, three years of probation and ordered to pay restitution. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board’s recommendation, Mr. Noyes was granted a pardon on August 9, 2010, based on his positive adjustment, extensive personal growth and development, a lack of previous or subsequent criminal justice system contacts, the length of time since the conviction, valid job concerns, his involvement through the volunteer fire department, and the recommendation of the district attorney and various members of his community.

Nicole Funches (date of birth November 2, 1974), convicted on February 8, 2000, of Hit and Run causing Injury, was sentenced to eighteen months in prison (stayed), three years of probation, and fifty hours of community service for

each year of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 4–2. Following the Board's recommendation, Ms. Funches was granted a pardon on August 9, 2010, based on a lack of other criminal justice system contacts, her positive adjustment, the recommendation from the judge and support from various members in her community.

Erskin Henderson (date of birth January 1, 1957), convicted on July 17, 1975, of Carrying a Concealed Weapon, was sentenced to thirty days in jail with work release; and on March 2, 1992, was convicted of Possession of a Controlled Substance—Cocaine, and sentenced to one year of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Henderson was granted a pardon on September 16, 2010, based on his positive adjustment, the non-violent nature of the offense, the length of time since the crime, and valid job concerns.

Michael Tompkins (date of birth August 12, 1973), convicted on June 14, 1995, of Manufacture/Deliver Cocaine Base (<= 3 grams), was sentenced to three years of probation and thirty days in jail with Huber. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Tompkins was granted a pardon on September 16, 2010, based on his positive adjustment, personal growth and development, the non-violent nature of the offense, and the support of the district attorney and various members of his community.

Angela Binder (date of birth March 17, 1971), convicted on November 15, 1989, of Delivery of a Controlled Substance, was sentenced to thirty days in jail with work release and three years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Ms. Binder was granted a pardon on September 16, 2010, based on her positive adjustment, extensive personal growth and development, lack of other criminal justice system contacts, and the non-violent nature of the offense.

Jeffrey Kallenbach (date of birth November 12, 1960), convicted on December 19, 1978, of Burglary, was sentenced to two years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Kallenbach was granted a pardon on September 16, 2010, based on his positive adjustment, the length of time since the crime, and support from members in his community.

Troydell Brooks (date of birth October 2, 1970), convicted on February 9, 1996, of PTAC Delivery of a Controlled Substance—Tetrahydrocannabinols, was sentenced to one year in the House of Corrections and two years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Brooks was granted a pardon on September 16, 2010, based on his positive adjustment, personal growth and development through furthering his education, the non-violent nature of the offense, and the length of time since the crime.

Dawn Horacek (date of birth June 20, 1963), convicted on December 12, 1984, of four counts of Burglary, was sentenced to four months in jail, four years of probation for each count (to run concurrent), and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Ms. Horacek was granted a pardon on September 16, 2010, based on her positive adjustment, personal growth and development, a lack of other criminal justice system contacts, the non-violent nature of the offense, length of time since the crime, valid job concerns, and a low risk of reoffending.

Frederick Clements (date of birth June 3, 1952), convicted on September 21, 1976, of Burglary, was sentenced to eighteen months of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Clements was granted a pardon on September 16, 2010, based on his positive adjustment, the non-violent nature of the offense, the length of time since the crime, and the recommendations of the judge, district attorney, and various members of his community.

Peter Schweitzer (date of birth December 30, 1958), convicted on August 25, 1977, of PTAC Operating Auto without Owner's Consent, was sentenced to ninety days in jail and five years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Schweitzer was granted a pardon on September 16, 2010, based on his positive adjustment, extensive personal growth and development, a lack of other criminal justice contacts, the non-violent nature of the offense, and the length of time since the crime.

Terrance Gerlach, (date of birth January 25, 1970), convicted on February 1, 1989, of Theft, was sentenced to three years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Gerlach was granted a pardon on September 16, 2010, based on his positive adjustment, the non-violent nature of the offense, the length of time since the crime, and support from various members of his community.

William Trickel, (date of birth December 22, 1971), convicted on September 9, 1996, of Forgery, was sentenced to one year of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Trickel was granted a pardon on September 16, 2010, based on his positive adjustment, the non-violent nature of the offense, no past record, and valid job concerns.

Frank James II, (date of birth November 19, 1967), convicted on November 14, 1986, of PTAC Attempted Armed Robbery, was sentenced to eight years in prison. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. James was granted a pardon on September 16, 2010, based on his positive adjustment; lack of other criminal justice system contacts; the length of time since the crime; extensive personal growth and development;

community achievements; and the recommendation of the district attorney, judge, and various members of his community

Kim VanderWerf, (date of birth October 28, 1964), convicted on April 25, 1991, of three counts of Issuing Worthless Checks, was sentenced to thirty days in jail with Huber and two years or probation each count (to run concurrent). The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Ms. VanderWerf was granted a pardon on September 16, 2010, based on her positive adjustment, the non-violent nature of the crime, the recommendation of the district attorney, and no objection from the judge.

Jeffrey Kultgen, (date of birth July 19, 1963), convicted on July 18, 1983, of PTAC Delivery of a Controlled Substance, was sentenced to sixty days in jail and two years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Kultgen was granted a pardon on September 16, 2010, based on his positive adjustment, extensive personal growth and development, a lack of other criminal justice system contacts, the non-violent nature of the offense, the length of time since the crime, and the recommendations of both the district attorney and judge.

Vanessa Mannery, (date of birth December 9, 1972), convicted on November 4, 1997, of Second Degree Recklessly Endangering Safety, was sentenced to three years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Ms. Mannery was granted a pardon on September 16, 2010, based on her positive adjustment, extensive personal growth and development, and a low risk of re-offending.

Shawn Stelzer, (date of birth February 26, 1964), convicted on January 27, 1992, of PTAC Manufacture of THC, was sentenced to ninety days in jail and three years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 4–3. Following the Board's recommendation, Mr. Stelzer was granted a pardon on September 16, 2010, based on his extensive personal growth and development, positive adjustment, the non violent nature of the offense, and the length of time since the crime.

Gordon Strauss, (date of birth November 15, 1949), convicted on February 26, 1990, of PTAC Maintain Dwelling for Delivery of Controlled Substances and Delivery of Cocaine, was sentenced to two years in prison and two years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. Strauss was granted a pardon on September 16, 2010, based on his positive adjustment, personal growth and development, the non-violent nature of the offense, the length of time since the crime, valid job concerns, substantial need relating to participation with the Honor Guard, achievements in his community, and support from various members in his community.

Lillian Nash, (date of birth June 16, 1971), convicted on July 29, 1996, PTAC Possession of a Controlled Substance—Cocaine— within 1,000 Feet of a School, was sentenced to thirty months in prison. The Governor's Pardon Advisory Board

recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Ms. Nash was granted a pardon on September 16, 2010, based on her positive adjustment, extensive personal growth and development, and the length of time since the crime.

Olney McClure, (date of birth May 2, 1959), convicted on December 15, 1978, of five counts of Burglary, was sentenced to eight years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 7–0. Following the Board's recommendation, Mr. McClure was granted a pardon on September 16, 2010, based on his extensive personal growth and development, substantial need relating to employment, a lack of other criminal justice system contacts, his positive adjustment, the non-violent nature of the offense, and the length of time since the crime.

Richard Grethe, (date of birth February 13, 1967), convicted on September 24, 1992, of Delivery of THC, was sentenced to one month in jail with work release, three years of probation, and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–1. Following the Board's recommendation, Mr. Grethe was granted a pardon on September 16, 2010, based on his positive adjustment, the non-violent nature of the offense, the length of time since the crime, and the recommendation of the district attorney.

Jamaal Abdul-Alim, (date of birth May 11, 1973), convicted on February 16, 2001, of Fleeing or Eluding an Officer by Vehicle Operator. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–2. Following the Board's recommendation, Mr. Abdul-Alim was granted a pardon on September 16, 2010, based on his positive adjustment, extensive personal growth and development, lack of other criminal justice system contacts, community achievements, and a low risk of re-offending.

Lynn Paiter, (date of birth November 6, 1948), convicted on October 8, 1970, of Forgery— Uttering, was sentenced to one year of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a conditional pardon by a vote of 5–0. Ms. Paiter was granted a conditional pardon that does not allow the possession of a firearm on October 27, 2010, based on her positive adjustment and the length of time since the crime.

Oliver Martin, (date of birth June 5, 1970), convicted on May 2, 1990, of Theft, was sentenced to two years of probation, twenty days in jail, and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–2. Following the Board's recommendation, Mr. Martin was granted a pardon on October 27, 2010, based on the length of time since his conviction.

Robert Meyer, (date of birth November 27, 1972), convicted on April 4, 1991, of Two Counts of Burglary (PTAC), was sentenced to three years in prison on each count, to run concurrent and ordered to pay restitution; convicted on April 11, 1991, of Burglary (PTAC) and sentenced to three years in prison, concurrent with previous sentence and ordered to pay restitution; and convicted on June 27, 1991 of Burglary and sentenced to three years in prison, concurrent with previous sentences and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a

vote of 6–0. Following the Board’s recommendation, Mr. Meyer was granted a pardon on October 27, 2010, based on a lack of other criminal justice system contacts, the length of time since the offense, and the support of the judge.

Alan Freed, (date of birth March 12, 1954), convicted on July 28, 1986, of Possession with Intent to Deliver THC, was sentenced to not more than four years in prison. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board’s recommendation, Mr. Freed was granted a pardon on October 27, 2010, based on his positive adjustment, extensive personal growth and development, the non–violent nature of the offense, the length of time since the crime, no past record, a low risk of re–offending, and the support of the district attorney.

Jessie DeMars, (date of birth March 6, 1973), convicted on June 24, 1996, of Burglary– Building or Dwelling while Concealing Identity (PTAC), was sentenced to three years in prison and ordered to pay restitution. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board’s recommendation, Mr. DeMars was granted a pardon on October 27, 2010, based on his positive adjustment, extensive personal growth and development, lack of other criminal justice system contacts, and support from the sentencing judge.

James Tolly, (date of birth February 9, 1962), convicted on December 10, 1985, of Burglary, was sentenced to thirty days in jail and three years of probation; and convicted on May 5, 1987, of Burglary and sentenced to two years of probation and ordered to pay restitution. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board’s recommendation, Mr. Tolly was granted a pardon on October 27, 2010, based on his positive adjustment, extensive personal growth and development, a lack of previous and subsequent criminal justice system contacts, the length of time since the crime, and valid job concerns.

Anna Walton, (date of birth May 23, 1949), convicted on April 13, 1989, of Failure to Report Receipt of Income, was sentenced to ten years of probation and ordered to pay restitution. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board’s recommendation, Ms. Walton was granted a pardon on October 27, 2010, based on her positive adjustment, extensive personal growth and development, a lack of other criminal justice system contacts, the non–violent nature of the crime, the length of time since the offense, and substantial need relating to job concerns.

Michelle Sneed, (date of birth June 28, 1964), convicted on May 15, 1985, of Forgery– Uttering, was sentenced to three years of probation. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 5–1. Following the Board’s recommendation, Ms. Sneed was granted a pardon on October 27, 2010, based on the non–violent nature of the offense, the length of time since the crime, and a low risk of re–offending.

Steven Tucci, (date of birth November 19, 1949), convicted on May 7, 1985, of Delivery of a Controlled Substance– Cocaine (PTAC), was sentenced to two years of probation. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board’s

recommendation, Mr. Tucci was granted a pardon on October 27, 2010, based on his positive adjustment, the non–violent nature of the offense, the length of time since the crime, and valid job concerns.

Mark Manthei, (date of birth March 3, 1960), convicted on February 4, 1981, of Delivery of Marijuana, was ordered to pay a fine. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board’s recommendation, Mr. Manthei was granted a pardon on October 27, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, the non–violent nature of the offense, and the length of time since the crime.

William Hess, (date of birth July 7, 1964), convicted on August 17, 1983, of Burglary, was sentenced to one year of probation. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board’s recommendation, Mr. Hess was granted a pardon on October 27, 2010, based on his positive adjustment, lack of other criminal justice system contacts, the length of time since the offense, his low risk of re–offending, and the support of the judge.

Scott Mielke, (date of birth October 26, 1963), convicted on August 12, 1988, of Delivery of Cocaine and Possession of Cocaine, was sentenced to three years of prison on count one and one year in prison on count two, to run concurrent. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 4–1. Following the Board’s recommendation, Mr. Mielke was granted a pardon on October 27, 2010, based on his positive adjustment, the non–violent nature of the offense, valid job concerns related to tribal gaming, the support of both the district attorney and judge in the county of conviction, and support from various members in his community.

Donald Sedlar Jr., (date of birth October 29, 1966), convicted on December 21, 1989, of Two Counts of Delivery of a Controlled Substance (PTAC), was sentenced to two years of probation on each count, to run concurrent. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 4–1. Following the Board’s recommendation, Mr. Sedlar was granted a pardon on October 27, 2010, based on a lack of other criminal justice system contacts, the length of time since the offense, no past record, and the support of the judge.

Nicholas Schroeder, (date of birth April 23, 1983), convicted on July 16, 2002, of Possession of THC as a Repeater, was sentenced to thirty days in jail with Huber and six month license suspension. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 4–1. Following the Board’s recommendation, Mr. Schroeder was granted a pardon on October 27, 2010, based on his positive adjustment, the non–violent nature of the offense, extensive personal growth and development through furthering his education and maintaining steady employment, and his community involvement through volunteer efforts and coaching.

Thomas Kamrowski, (date of birth September 9, 1969), convicted on October 2, 1991, of Burglary (PTAC), was sentenced to six months in jail with Huber privileges, five years of probation, and ordered to pay restitution. The Governor’s Pardon Advisory Board recommended granting a pardon by a vote of 5–1. Following the Board’s recommendation, Mr. Kamrowski was granted a pardon on October 27, 2010, based

on a lack of other criminal justice system contacts and the length of time since the crime.

Katherine Wynn, (date of birth April 18, 1956), convicted on or about March 20, 1979, of Prostitution, was sentenced to one year of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 3–2. Following the Board's recommendation, Ms. Wynn was granted a pardon on November 24, 2010, based on her extensive personal growth and development, the non–violent nature of the crime, and the length of time since the offense.

Donna Deal, (date of birth July 30, 1956), convicted on April 30, 1992 of Failure to Report Receipt of Income, was sentenced to two years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 3–2. Following the Board's recommendation, Ms. Deal was granted a pardon on November 24, 2010, based on her positive adjustment, a lack of other criminal justice system contacts, the non–violent nature of the offense, and the length of time since the crime.

Princess Haney, (date of birth June 12, 1980), convicted on February 17, 1999, of Attempted Theft of Movable Property (PTAC), was sentenced to two years of probation and fifty hours of community service. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 4–1. Following the Board's recommendation, Ms. Haney was granted a pardon on November 24, 2010, based on her positive adjustment, extensive personal growth in continuing her education, her young age at the time of the offense, a lack of other criminal justice system contacts, the non–violent nature of the crime, and the length of time since the offense.

James Granahan, (date of birth July 24, 1966), convicted on September 16, 1996, of Vehicle Operator Flee/Elude Officer and was ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–1. Following the Board's recommendation, Mr. Granahan was granted a pardon December 15, 2010 based on the lack of other criminal justice system contacts and the length of time since offense.

Laurence Fox, (date of birth February 29, 1960), convicted on June 9, 1980 of two counts of Burglary and Receiving Stolen Property, was sentenced to two years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–1. Following the Board's recommendation, Mr. Fox was granted a pardon on December 15, 2010, based on his positive adjustment and the length of time since the offense.

Ramonita Rodriguez, (date of birth April 2, 1974), convicted on August 28, 1995, of Failure to Report Receipt of Income, was sentenced to five years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–1. Following the Board's recommendation, Ms. Rodriguez was granted a pardon on December 15, 2010, based on her positive adjustment, extensive personal growth and development, the non–violent nature of the crime, the length of time since the offense, her substantial need, and valid job concerns.

Michael Lunz, (date of birth June 29, 1943), convicted on January 18, 1977, of Transfer Encumbered Property, was

sentenced to three years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 4–2. Following the Board's recommendation, Mr. Lunz was granted a pardon on December 15, 2010, based on the non–violent nature of the crime, the length of time since the offense, and his low risk of reoffending.

Michael Tirado, (date of birth November 28, 1958), convicted on June 12, 1987, of Delivery of a Controlled Substance– Marijuana, was sentenced to two years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 4–2. Following the Board's recommendation, Mr. Tirado was granted a pardon on December 15, 2010, based on his positive adjustment, the length of time since the offense and his extensive personal growth & development.

Rita Blue, (date of birth July 9, 1967), convicted on August 27, 1997, of Public Assistance– Fail/Notify Changes, was sentenced to eight years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board was split of 3–3 on its recommendation to grant a pardon. Ms. Blue was granted a pardon on December 15, 2010, based on the non–violent nature of the crime and the length of time since the offense.

Anthony Liesenfelder, (date of birth November 24, 1964), convicted on May 7, 1985, of Second Degree Sexual Assault, was sentenced to forty–five days in jail with work release and two years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 3–2. Following the Board's recommendation, Mr. Liesenfelder was granted a pardon on December 15, 2010, based on a lack of other criminal justice system contacts, the length of time since the offense, and valid job concerns.

Paul Luitze, (date of birth June 18, 1964), convicted on October 31, 1984, of two counts of Burglary, was sentenced to five years of probation on each count, to run concurrent. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Luitze was granted a pardon on December 15, 2010, based on his positive adjustment, the lack of other criminal justice system contacts, and the length of time since the offense.

Alfred Kemp, (date of birth August 28, 1958), convicted on February 11, 1986, of 21 counts Burglary, was sentenced to eight years of probation, one year in jail, and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Kemp was granted a pardon on December 15, 2010, based on a lack of other criminal justice system contacts, the length of time since the offense, and the recommendation of the district attorney.

Darryl Kozak, (date of birth July 5, 1959), convicted on March 16, 1983, of Aiding a Felon, was sentenced to eighteen months of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Kozak was granted a pardon on December 15, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, the non–violent nature of the crime, the length of time since offense, no past record,

valid job concerns, substantial need, extensive personal growth and development, and a low risk of reoffending.

Gregg Brunclik, (date of birth December 31, 1951), convicted on January 16, 1973, of Delivery of a Controlled Substance, was sentenced to three years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Brunclik was granted a pardon on December 15, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, the non-violent nature of the offense, the length of time since offense, no past record, valid job concerns, extensive personal growth and development, community achievements, and a low risk of reoffending.

Todd Kagelmann, (date of birth September 25, 1964), convicted on December 30, 1985, of Delivery of a Controlled Substance, was sentenced to four years of probation and ordered to pay a fine; and convicted of Delivery of a Controlled Substance on July 22, 1991, and sentenced to fifteen months in prison, two years of probation, and ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Kagelmann was granted a pardon on December 15, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, the length of time since the offense, valid job concerns, substantial need, and his community achievements.

Amy Eaton, (date of birth November 8, 1969) convicted on September 5, 1990, of Burglary (PTAC), was sentenced to three years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Ms. Eaton was granted a pardon on December 15, 2010, based on the length of time since the offense and her valid job concerns.

Rebecca Sellars, (date of birth July 28, 1974), convicted on April 16, 2002, of two counts of Manufacture/Deliver Cocaine, was sentenced to three years of probation on each count, to run concurrent and six months license suspension on each count, to run concurrent. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Ms. Sellars was granted a pardon on December 15, 2010, based on her positive adjustment, a lack of other criminal justice system contacts, her extensive personal growth and development, community achievements, and a low risk of reoffending.

Channing Worzalla, (date of birth September 8, 1968), convicted on May 2, 1995, of Possession of a Controlled Substance with Intent to Deliver and two counts of Delivery of a Controlled Substance, was sentenced to three years of probation on each count, to run concurrent and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Worzalla was granted a pardon on December 15, 2010, based on his positive adjustment, the non-violent nature of the offense, and his extensive personal growth and development.

Gerald Burger, (date of birth July 10, 1963), convicted on September 9, 1985, of Burglary, was sentenced to two years of probation. The Governor's Pardon Advisory Board

recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Burger was granted a pardon on December 15, 2010, based on the length of time since the offense and his valid job concerns.

William McMurtrey, (date of birth April 25, 1967), convicted on July 27, 1988, of Operating Auto Without Owner's Consent, was sentenced to three years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. McMurtrey was granted a pardon on December 15, 2010 based on his positive adjustment, the length of time since the offense, his substantial need, his extensive personal growth and development, his community achievements, and his low risk of reoffending.

Jason Ferstl, (date of birth May 29, 1978), convicted on February 13, 1996, of Issue of Worthless Check, was sentenced to three years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Mr. Ferstl was granted a pardon on December 15, 2010, based on his young age at the time of the crime, the non-violent nature of the offense, valid job concerns, and his substantial need for enlisting in the military.

Rochelle Matthaues, (date of birth August 19, 1962), convicted on June 17, 1993, of Failure to Report Income and Food Stamp Fraud, was sentenced to five years of probation on each count, to run concurrent and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Ms. Matthaues was granted a pardon on December 15, 2010, based on her positive adjustment, the non-violent nature of the crime, the length of time since the offense and her extensive personal growth and development.

Yvette Burems, (date of birth May 1, 1962), convicted on April 29, 1997, of Public Assistance Fraud– Failure to Notify Income (>\$2500), was sentenced to fifteen months in prison. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Ms. Burems was granted a pardon on December 15, 2010, based on her positive adjustment, the non-violent nature of the crime, the length of time since the offense, and her extensive personal growth and development.

Gracelene Owens, (date of birth January 8, 1963), convicted on September 2, 1992, of Keeping a Drug House and Possession with Intent to Deliver– Marijuana, was sentenced to nine months in jail on count one, two years in jail, on count two to run concurrent with count one, and three years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Ms. Owens was granted a pardon on December 15, 2010, based on her positive adjustment, a lack of other criminal justice system contacts, and the length of time since the offense.

Lynn Barian, (date of birth December 6, 1952), convicted on September 24, 1984, of Welfare Fraud, was sentenced to two years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6–0. Following the Board's recommendation, Ms. Barian was granted a pardon on December 15, 2010, based on her positive adjustment, a lack of other criminal justice system contacts, the non-violent nature

of the crime, the length of time since the offense and her extensive personal growth and development.

Ethan McIntire, (date of birth January 17, 1973), convicted on February 18, 1992, of Forgery and sentenced to forty-five days in jail; and convicted on August 13, 1991, of Fourth Degree Sexual Assault and Bail Jumping, and sentenced to two years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6-0. Following the Board's recommendation, Mr. McIntire was granted a pardon on December 15, 2010, based on his positive adjustment, the length of time since the offense, valid job concerns and his substantial need.

Dean Wood, (date of birth January 7, 1962), convicted on February 5, 1982, of Burglary and sentenced to one year in prison; and convicted on February 11, 1983, of Burglary, and sentenced to five years in prison. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 6-0. Following the Board's recommendation, Mr. Wood was granted a pardon on December 15, 2010, based on his positive adjustment, the length of time since the offense, his extensive personal growth and development, the low risk of reoffending and the recommendation of the district attorney.

Ronald Slavin II, (date of birth March 11, 1975), convicted on September 26, 1996, of Delivery of Cocaine, Possession of Cocaine with Intent to Deliver, and Possession of Psilocybin Mushroom, was sentenced to ten years of probation on count one; ten years of probation on count two, concurrent to count one; and three years of probation on count three, concurrent to count two. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5-1. Following the Board's recommendation, Mr. Slavin was granted a pardon on December 15, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, the non-violent nature of the crime, the length of time since the offense, his extensive personal growth and development, a low risk of reoffending, and the recommendation of the judge.

Coletta Dukes, (date of birth January 9, 1964), convicted on June 24, 1996, of Failure to Report Income, was sentenced to five years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 4-2. Following the Board's recommendation, Ms. Dukes was granted a pardon on December 15, 2010, based on the non-violent nature of the crime, the length of time since the offense, valid job concerns, and her extensive personal growth and development through furthering her education.

Lisa Schomaker, (date of birth May 6, 1975), convicted on August 16, 1996, of Forgery- Writings or Objects and sentenced to three years of probation, and convicted on April 9, 1999 of two counts Forgery, and sentenced to three years of probation on each count. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5-0. Following the Board's recommendation, Ms. Schomaker was granted a pardon on December 20, 2010, based on her positive adjustment, a lack of other criminal justice system contacts, the non-violent nature of the offense, and her extensive personal growth and development.

Daniel Dey, (date of birth April 14, 1964), convicted on August 24, 1990, of Delivery of a Controlled Substance and

sentenced to one year in prison and ordered to pay restitution; and convicted on October 7, 1996, of four counts of Failure to Support Child (120 days +) and sentenced to three years of probation on each count and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5-0. Following the Board's recommendation, Mr. Dey was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, the non-violent nature of the offense, the length of time since the crime, valid job concerns, and his extensive personal growth and development.

Debra Parker, (date of birth April 17, 1956), convicted on August 12, 1993, of Delivery of a Controlled Substance, was sentenced to three years of probation and ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 2-3. Mr. Parker was granted a pardon on December 20, 2010, based on the length of time since the crime and her valid job concerns.

Maria Rees, (date of birth December 1, 1959), convicted on April 11, 2006, of Violate/Harassment Restraining Order, was sentenced to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 3-2. Following the Board's recommendation, Ms. Rees was granted a pardon on December 20, 2010, based on her positive adjustment, lack of prior or subsequent criminal justice system contacts, extensive personal growth and development, and achievements in her community.

Samuel Clemons, (date of birth June 21, 1952), convicted on June 21, 1973, of Four Counts Forgery and sentenced to two years of probation and ordered to pay restitution; and convicted on February 26, 1975, of Conspiracy to Commit Armed Robbery and sentenced to two years in prison. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 3-2. Following the Board's recommendation, Mr. Clemons was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of subsequent criminal justice system contacts, the length of time since the offense, and his extensive personal growth and development.

Nathan Gray, (date of birth September 8, 1970), convicted on May 28, 1993, of Possession of Marijuana with Intent to Deliver (PTAC), was sentenced to eight years of probation and ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 3-2. Following the Board's recommendation, Mr. Gray was granted a pardon on December 20, 2010, based on a lack of other criminal justice system contacts, the non-violent nature of the offense, and the length of time since the crime.

Wayne Brunette, (date of birth September 6, 1951), convicted on July 19, 1989, of Welfare Fraud, was sentenced to four years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5-1. Following the Board's recommendation, Mr. Brunette was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, the non-violent nature of the offense, the length of time since the crime, and the recommendation of the district attorney.

Dennis Green, (date of birth June 15, 1981), convicted on February 2, 2000, of Possession with Intent to Deliver THC, was sentenced to three years of probation and ordered to pay a

Following the Board's recommendation, Mr. Green was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, valid job concerns, and his extensive personal growth and development.

Charlie Ward, (date of birth December 22, 1973), convicted on February 15, 1995, of Possession with Intent to Deliver a Controlled Substance— Cocaine (PTAC), was sentenced to two years in prison and ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Ward was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of prior or subsequent criminal justice system contacts, the non-violent nature of the crime, the length of time since the crime, and his extensive personal growth and development.

Following the Board's recommendation, Ms. Garry was granted a pardon on December 20, 2010, based on her positive adjustment, a lack of other criminal justice system contacts, and the non-violent nature of the offense.

pardon by a vote of 5–0. Following the Board's recommendation, Mr. Bieniek was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, the length of time since the offense, and his extensive personal growth and development.

Roy Bader, (date of birth April 19, 1977), convicted on May 23, 1977, of Possession with Intent to Deliver Marijuana, was sentenced to one year of probation and ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Bader was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of prior or subsequent criminal justice system contacts, the non-violent nature of the offense, the length of time since the crime, valid job concerns, extensive personal growth and development, achievements in his community, a low risk of reoffending, and the recommendation of the judge.

Sherry Crumb, (date of birth October 27, 1965), convicted on October 15, 1952, of Failure to Report Receipt of Income, was sentenced to two years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Ms Crumb was granted a pardon on December 20, 2010, based on her positive adjustment, the non-violent nature of the offense, and the length of time since the crime.

William Peavey, (date of birth January 27, 1958), convicted on August 5, 1976, of Operate Vehicle Without Owner's Consent, was sentenced to two years of probation and ordered to pay a fine and restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Peavey was granted a pardon on December 20, 2010, based on his positive adjustment, the non-violent nature of the offense, and the length of time since the crime.

Duane Zinda, (date of birth August 8, 1966), convicted on October 11, 1994, of Arson of a Building with Intent to Defraud, was sentenced to two years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Tracy Smith, (date of birth May 20, 1972), convicted on February 5, 1992, of Theft, was sentenced to three years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Smith was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, the non-violent nature of the crime, the length of time since the offense, his extensive personal growth and development, and a low risk of reoffending.

Michael Durian, (date of birth June 8, 1972), convicted on August 28, 1991, of Burglary (PTAC), was sentenced to three years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Durian was granted a pardon on December 20, 2010, based on his positive adjustment, the length of time since the offense, and his extensive personal growth and development.

Annie Glass, (date of birth April 20, 1966), convicted on April 7, 1992, of False Representation to Obtain Public Assistance, was sentenced to eight years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Ms. Glass was granted a pardon on December 20, 2010, based on her positive adjustment, the non-violent nature of the crime, and her extensive personal growth and development.

David Bednarski, (date of birth February 21, 1976), convicted on May 9, 1977, of PTAC Theft, was sentenced to thirty days in jail. The Governor's Pardon Advisory Board

recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Bednarski was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, valid job concerns, and his extensive personal growth and development.

Joseph Falkner, (date of birth October 21, 1979) convicted on June 3, 1999, of Possession with Intent to Deliver THC, was sentenced to two years of probation and ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Falkner was granted a pardon on December 20, 2010, based on his positive adjustment, lack of other criminal justice system contacts, the non-violent nature of the crime, and his extensive personal growth and development.

Scott Kippert, (date of birth July 26, 1959) convicted on December 17, 1984, of Two Counts of Delivery of a Controlled Substance THC, was sentenced to three years of probation on each count and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Kippert was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, the non-violent nature of the offense, the length of time since the crime, his extensive personal growth and development, and the recommendation of the judge.

Thomas Eades, (date of birth August 4, 1961) convicted on September 10, 1980, of Possession with Intent to Deliver/Manufacture a Controlled Substance, was sentenced to one year of probation and ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Eades was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of prior or subsequent criminal justice system contacts, the non-violent nature of the offense, the length of time since the crime, valid job concerns, substantial need, extensive personal growth and development, achievements in his community, a low risk of reoffending, and the recommendation of the district attorney.

Ke'Andra Hagans, (date of birth September 5, 1980) convicted on September 14, 2001, of Forgery–Uttering (PTAC) and was sentenced to three years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Ms. Hagans was granted a pardon on December 20, 2010, based on her positive adjustment, a lack of other criminal justice system contacts, the non-violent nature of the offense, her substantial need, and her extensive personal growth and development.

Stephanie Segall, (date of birth April 17, 1969) convicted on October 24, 1994, of Welfare Fraud, was sentenced to four years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Ms. Segall was granted a pardon on December 20, 2010, based on her positive adjustment, a lack of other criminal justice system contacts, the non-violent nature of the offense, the length of time since the crime, and her extensive personal growth and development.

Ronald Wolf, (date of birth June 30, 1974) convicted on November 2, 1995, of PTAC Burglary, was sentenced to two

years of probation and ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Wolf was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, the length of time since the offense, and his extensive personal growth and development.

Jeffrey Severson, (date of birth April 14, 1956) convicted on August 31, 1981, of Intent to Deliver a Controlled Substance (Marijuana) was sentenced to three years of probation. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Severson was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of prior or subsequent criminal justice system contacts, the non-violent nature of the offense, the length of time since the crime, his extensive personal growth and development, and the recommendation of the district attorney.

Jacob Bohm, (date of birth May 9, 1977) convicted on December 12, 2000, of Manufacture/Delivery of THC, was sentenced to three years of probation and ordered to pay a fine and restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Bohm was granted a pardon on December 20, 2010, based on his positive adjustment, lack of other criminal justice contacts, the non-violent nature of the crime, his substantial need, his extensive personal growth and development, and the recommendation of the judge.

Tammi Zibolsky, (date of birth December 20, 1982) convicted on April 30, 2002, of Possession with Intent to Deliver THC, was sentenced to fifteen months of probation and ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Ms. Zibolsky was granted a pardon on December 20, 2010, based on her positive adjustment, a lack of prior or subsequent criminal justice system contacts, the non-violent nature of the offense, valid job concerns, extensive personal growth and development, a low risk of reoffending, and the recommendation of the judge.

Scott Peterson, (date of birth February 9, 1972) convicted on November 2, 1993, of PTAC Burglary, was sentenced to five years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Peterson was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, the non-violent nature of the offense, the length of time since the crime, his extensive personal growth and development, and a low risk of reoffending.

Robert Parnau, (date of birth January 21, 1966) convicted on May 5, 1987, of Delivery of a Controlled Substance—Cocaine, was sentenced to eighteen months of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Parnau was granted a pardon on December 20, 2010, based on his positive adjustment, the length of time since the offense, no past record, his extensive personal growth and development, and a low risk of reoffending.

Charlie Gordon III (date of birth September 5, 1971) convicted on February 11, 1998, of Possession with Intent to Deliver Cocaine, was sentenced to thirty–six months of probation and ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Gordon was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of prior or subsequent criminal justice system contacts, the non-violent nature of the offense, the length of time since the crime, valid job concerns, and his extensive personal growth and development.

Sean Oliver, (date of birth March 8, 1966) convicted on October 19, 1987, of three counts of Party to Criminal Damage to Property, was sentenced to eight years of probation on each count, to run concurrent and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Mr. Oliver was granted a pardon on December 20, 2010, based on his positive adjustment, a lack of other criminal justice system contacts, the length of time since the offense, valid job concerns, and achievements in his community.

Margaret Madecky, (date of birth June 9, 1964) convicted on August 29, 1991, of Theft by Virtue of Employment, was sentenced to two years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Ms. Madecky was granted a pardon on December 20, 2010, based on her positive adjustment, a lack of prior or subsequent criminal justice system contacts, the non-violent nature of the offense, the length of time since the crime, her extensive personal growth and development, and a low risk of reoffending.

Janice Kidd, (date of birth July 4, 1962) convicted on November 19, 1990, of Forgery (PTAC), was sentenced to three years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Ms. Kidd was granted a pardon on December 20, 2010, based on her positive adjustment, a lack of prior or subsequent criminal justice system contacts, the non-violent nature of the offense, the length of time since the crime, her extensive personal growth and development, and a low risk of reoffending.

Lorris Bender, (date of birth July 10, 1961) convicted on February 6, 1992, of Failure to Report Receipt of Income and Food Stamp Fraud, was sentenced to six years of probation and ordered to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5–0. Following the Board's recommendation, Ms. Bender was granted a pardon on December 20, 2010, based on her lack of prior or subsequent criminal justice system contacts, the non-violent nature of the offense, the length of time since the crime, her extensive personal growth and development, and a low risk of reoffending.

Steven Frane, (date of birth November 9, 1965) convicted on February 8, 1991, of Theft, was sentenced to one hundred days in jail, fifty–five months of probation, and ordered to pay restitution; and convicted of Transferring Encumbered Property, was sentenced to three years of probation and ordered

to pay restitution. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 5-0. Following the Board's recommendation, Mr. Frane was granted a pardon on December 20, 2010, based on his positive adjustment, the non-violent nature of the offense, the length of time since the crime, his extensive personal growth and development, and the recommendation of the judge.

Jerome DeBell, (date of birth July 11, 1949) convicted on September 1, 1987, of two counts of Reckless Use of a Weapon, was sentenced to two years of probation and ordered to pay a fine. The Governor's Pardon Advisory Board recommended granting a pardon by a vote of 3-2. Following the Board's recommendation, Mr. DeBell was granted a pardon on December 22, 2010, based on his positive adjustment, a lack of prior or subsequent criminal justice system contacts, the length of time since the crime, achievements in his community, and a low risk of reoffending.

Josh Walling, (date of birth April 14, 1965) convicted on July 14, 1992, of Possession of a Controlled Substance with Intent to Deliver, was sentenced to thirty months of probation and ordered to pay a fine. The Governor's Pardon Advisory Board was split 3-3 on its recommendation to grant a pardon. Mr. Walling was granted a pardon on December 22, 2010, based on the length of time since the offense and the support of the judge.

Caroline Holden, (date of birth December 16, 1977) convicted on December 15, 1998, of Possession of Heroin, was ordered to pay a fine. The Governor's Pardon Advisory Board

recommended to grant a pardon by a vote of 2-3. Ms. Holden was granted a pardon on December 27, 2010, based on her extensive personal growth and development, positive adjustment, a lack of previous and subsequent criminal justice system contacts, valid job concerns and substantial need, the length of time since the offense, and a low risk of reoffending.

Benjamin Fahrenholz, (date of birth July 6, 1971) convicted on August 18, 1993, of Uttering and sentenced to eight years of probation and ordered to pay restitution; and convicted of PTACT Theft and sentenced to four years of intensive sanctions, one year of confinement. The Governor's Pardon Advisory Board was split 3-3 on its recommendation to grant a pardon. Mr. Fahrenholz was granted a pardon on December 27, 2010, based on his extensive personal growth and development, positive adjustment, a lack of previous or subsequent criminal justice system contacts, no objection from the judge, the length of time since the offense, and a low risk of reoffending.

Mark Zindars, (date of birth November 4, 1980) convicted on September 23, 1999 of Possession with Intent Psilocin, was sentenced to six months in jail and six months license suspended. Mr. Zindars was granted a pardon on December 29, 2010, based on his extensive personal growth and development, positive adjustment, no objection from the judge, valid job concerns, and substantial need.
