
Moved by Representative Pasch, seconded by Representative Kleefisch that **Assembly Bill 47** be recommended for passage.

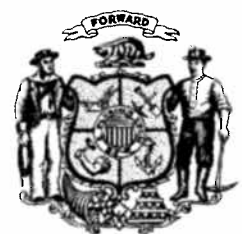

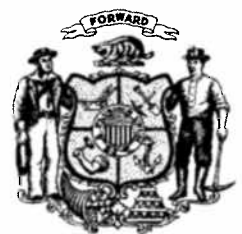

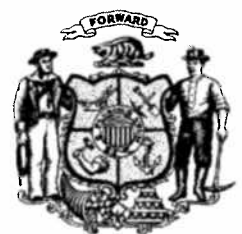
