I believe very strongly that Wisconsin should follow Federal standards and common sense in conducting background checks for a person who wishes to purchase a firearm. The state checks the background of the person using State records, but does not check the existing Federal database. The result - people who have Federal records, such as those who have involuntarily hospitalized in a mental institution via court order or an out-of-state firearms purchaser with a Federal record can easily pass a WI background check. This defies common sense. Legal gun purchases are accomplished within our laws. Why would we allow someone who was adjudicated as a threat to themselves or others to purchase firearms?

I am a friend of Scott Gelzer and Pat Wazbynski, whose son Brandon had bi-polar disorder and took his own life with a handgun purchased after having been in treatment for his disease. Thank you for your work on this bill. Let's see that it gets passed.

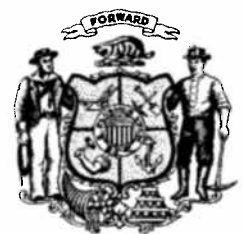

Dear Wisconsin Legislator,

It has been brought to our attention that a group has been passing along a considerable amount of misinformation regarding legislation introduced by Rep. Scott Gunderson (AB 70) and Sen. Alberta Darling (SB 44). These two bills will in no way "disarm veterans" as this group claims.

The essence of both bills is to require any court that orders an involuntary commitment, the appointment of a guardian, or protective placement under certain provisions of Wisconsin law also to "determine if, under 18 USC 922(g)(4), the individual is prohibited from possessing a firearm." This prohibition relates to a person "who has been adjudicated as a mental defective or who has been committed to a mental institution." 18 U.S.C. 922(g)(4). (This is the federal standard, no new standard is created.)

If the court makes such a finding, it shall order the person not to possess a firearm, order the seizure of any firearms in the person's possession, and inform the person of the requirements and penalties of WI ST 941.29, which deals in part with the possession of a firearm by a prohibited person. The court clerk would have to notify the state Department of Justice (DOJ) of the order of prohibition and provide only such identifying information about the individual as is necessary to permit an accurate firearms restriction record search under WI ST 175.35(2g)(c). The DOJ would then have to promulgate rules to convey the information in a timely manner to NICS.

These bills also contain provisions that would allow an individual who is the subject of a firearm prohibition order entered according to the above provisions to petition the court in the county where the person resides to "cancel the order." The court must grant the petition if it "determines that the circumstances of the [contested order] and the person's record and reputation indicate that the person is not likely to act in a manner dangerous to public safety and that the granting of the order would not be contrary to public interest." If the court enters such a cancellation order, the court clerk must provide relevant identifying information about the person to the DOJ, and the DOJ, in turn, must convey the information to NICS. The bills would also allow the court to designate a person to store any firearms of a person who is subject to a prohibition order, instead of ordering the seizure of the firearms by the state.

AB 70 and SB 44 would additionally require the state background check to include a NICS check to determine if the individual had a mental health related prohibition order entered under any of the above provisions. Any person who possessed a firearm in violation of such an order would be subject to Class G felony penalties under WI ST 941.29(2). These penalties would not apply if the order had been cancelled.

The federal legislation that was passed in 2007 did not create a new class of prohibited persons and neither does AB 70 or SB 44. The NRA does not, and will not, support the creation of new classes of prohibited persons. These bills would only require reporting of available records on people who are prohibited from possessing firearms under existing law.

The federal law specifies that mental health adjudications may not be reported if they've been expunged, or if the person has received relief from the adjudication under the procedures required by the bill. In those cases, the mental adjudication or commitment "shall be deemed not to have occurred," and therefore would not prohibit the person from possessing firearms. SB 44 and AB 70 likewise include provisions that would require the state to notify NICS of cancelled mental health prohibition orders.

Last, but not least, the federal law also provides veterans and others their first opportunity in more than 15 years to seek "relief from disabilities" through either state or federal programs. Prior to the federal law, no matter how successfully a person responded to treatment, there was no way for a person "adjudicated" incompetent or involuntarily committed to an institution to seek restoration of the right to possess a firearm. AB 70 and SB 44 similarly would create a mechanism for those who have been prohibited because of mental health adjudications to seek relief.

Under the federal standards that apply to these bills, a diagnosis alone is never enough; the person must be "adjudicated as a mental defective," which is a legal term that implies a fair hearing process. With respect to federal adjudications, the Veterans' Administration has regulations that provide veterans with an opportunity for a hearing on those decisions, and an opportunity for multiple appeals—just as a civilian does in state court. Any Veterans Administration records that don't meet this standard could not be reported to NICS, and any deficient records that have already been provided would have to be removed. AB 70 and SB 44 would require Wisconsin courts to apply the same standards federal agencies apply in determining which orders are reportable. Again, cancelled orders would also have to be reported.

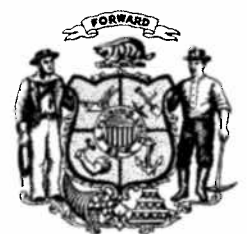
In summary, the procedural safeguards included in these bills should only improve matters for those subject to mental health adjudications or commitments, whether veteran or civilian.

I would like to hold an executive session on the bill on October 15th, but I want to make sure that the bill will be scheduled in the Assembly once it passes the Criminal Justice Committee. I believe AB 70 is good public policy and is nonpartisan in its purpose; it had a good reception at the public hearing, with no one testifying or registering against it. I hope that Assembly Bill 70 will not get bottled up in our house and I would like your assurances that it will be calendared, possibly before November 5th. Thank you.

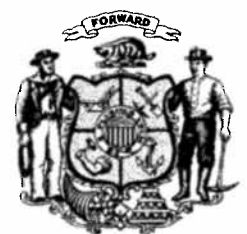

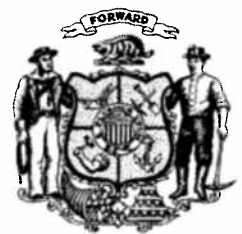

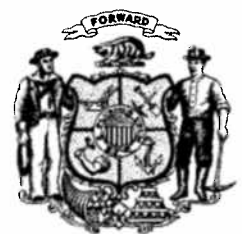
